PROCLAMATION, А

GEORGE R.

THEREAS Our Parliament which We fummoned to meet at Weftminster upon Tuefday the Thirty-first Day of August last, stands prorogued to Tuelday the Fifth Day of October next ; We, with the Advice of Our Privy Council, do, for divers weighty Reafons, hereby publish and declare, That the faid Parliament shall be further prorogued on the faid Fifth Day of October next to Tuesday the Sixteenth Day of November next: And We have given Order to Our Chancellor of that Part of Our United Kingdom called Great Britain to prepare a Writ Patent, under Our Great Seal, for pro. roguing the fame accordingly. And We do further hereby, with the Advice aforefaid, declare Our Royal Will and Pleafure, That the faid Parliament shall, on the faid Sixteenth Day of November next, be held and fit for the Difpatch of divers urgent and important Affairs. And the Lords Spiritual and Temporal, and the Knights, Citizens, and Burgeffes, and the Commiffioners for Shires and Burghs of the House of Commons, are hereby required and commanded to give their Attendance accordingly at Weftminster on the faid Sixteenth Day of November next.

The KING's Most Excellent Majesty in Council. 'HEREAS Information hath been received, that a malignant Fever is now raging in the

and at Baltimore, in Maryland, within the United States of America ; His Majefty, deeming the faid Fever to be probably infectious, doth, by and with the Advice of His Privy Council, deem it expedient to declare, and by this His Order doth declare, that the faid Fever is probably infectious, within the Meaning of the Act paffed in the Thirty-ninth and Fortieth Years of His Majefty's Reign, intituled " An Act for crecting a Laza e. on Chetney-Hill, " in the County of Kent; and for reducing into " one Act the Laws relating to Quarantine, and " for making further Provision therein :" And His Majefty doth hereby order, 'That all Ships, Veffels, Perfons, Goods, Wares, and Merchardife, now arrived, or which may hcreafter arrive in any of the Ports of this Kingdom, or the Ifles of Guernfey, Jerfey, Alderney, Sark, or Man, from any of the Ports of Pennfylvania or of Maryland, and shall have cleared out from any of the faid Ports of Pennfylvania or Maryland, subsequent to the First Day of July last, (not having any Perfon or Perfons on board the fame, actually ill of the faid Fever,) do perform a Quarantine of Fourteen Days at the feveral Places appointed, and according to the Rules prescribed by His Majesty's Order in Council of the Twenty-ninth of July One thousand eight hundred, for Performance of Quarantine by all Ships and Vessels coming from or through the Mediterranean, or from the Weft Barbary on the Atlantic Ocean, and arriving with clean Bills of Health; but in cafe any of the Crew or Paffengers on board any fuch Ship or Veffel, which shall have cleared out from any of the Ports of Pennfylvania or Maryland fubfequent to the faid First Day of July, and shall have arrived, and may hereafter arrive in any of the Ports of this Kingdom, or the Islands of Guernfey, Jerfey, Alderney, Sark, or Man, from any of the faid Ports of Pennfylvania, or of Maryland, shall have died of the faid Feyer during the Courfe of the Voyage, the Clothes, and all perfonal Effects which are City of Philadelphia, in the State of Pennfylvania, [fusceptible of Infection, worn by, or belonging to

fuch Perfou, shall be forthwith burned or funk in [ deep Water: And if fuch Clothes, and Effects, fhall not be to burned, or deftroyed, the faid Ship, or Veffel, with the whole of her Cargo, shall not be permitted to perform Quarantine at any Port or Place, except at Standsate Creek; and shall be compelled to depart from any other Port or Place at which the fame has arrived, or fhall arrive, as aforefaid; and shall repair to Standgate Creek, and there perform Quarantine, and not elfewhere: and His Majefty is further pleafed to order, with the Advice aforefaid, and it is hereby ordered, That if it shall appear, upon the Arrival of any Ship or Veffel, from any of the faid Ports of Pennfylvania, or of Maryland, as aforefaid, that any of the Crew or Paffengers belonging to the fame are actually ill of the faid Fever, then fuch Ship, or Veffel, and the Perfons, Goods, Wares, and Merchandize, on board • the fame shall not be permitted to perform Quarantine at any Port or Place, except Standgate Creek, and shall be compelled to depart from any other Port or Place, and to proceed immediately to Standgate Creek, in order to perform Quarantine, and shall there perform Quarantine, and not elfewhere : And the Right Honorable the Lords Commiffioners of His Majefty's Treafury, the Commiffioners for executing the Offices f Lord High Admiral of Great Britain, the Lord Warden of the Cinque Ports, the Master General, and the Reft of the Principal Officers of the Ordnance, His Majefty's Secretary at War, and the Governors or Commanders in Chief for the Time being of the faid Ifles of Guernfey, Jerfey, Alderney, Sark, and Man, are to give the neceffary Directions herein, as to them may refpec-W.
