A PROCLAMATION, GEORGE R.

W HEREAS Our Parliament which We fummoned to meet at Weftminfter upon Tuefday the Thirty firft Day of August last, stands prorogued to Tuesday the Fifth Day of October next; We, with the Advice of Our Privy Council, do, for divers weighty Reasons, hereby publish and declare, That the faid Parliament shall be further prorogued on the faid Fifth Day of October next to Tuesday the Sixteenth Day of November next: And We have given Order to Our Chancellor of that Part of Our United Kingdom called Great Britain to prepare a Writ Patent, under Our Great Seal, for proroguing the fame accordingly. And We do further hereby, with the Advice aforefaid; declare Our Royal Will and Pleasure, That the faid Parliament shall, on the faid Sixteenth Day of November next, be held and fit for the Dispatch of divers urgent and important Affairs. And the Lords Spiritual and Temporal, and the Knights, Citizens, and Burgeffes, and the Commiss, are hereby required and commanded to give their Attendance accordingly at Westminfter on the faid Sixteenth Day of November next.

A T the Court at Windfor, the 18th of September 1802,

PRESENT,

The KING's Moft Excellent Majefty in Council. WHEREAS Information hith been received, that a malignant Fever is now raging in the City of Philadelphia, in the State of Pennfylvania, and at Baltimore, in Maryland, within the United States of America; His Majefty, deeming the faid Fever to be probably infectious, doth, by and with the Advice of His Privy Council, deem it expedient to declare, and by this His Order doth declare, that

the faid Fever is probably infectious, within the Meaning of the Act passed in the Thirty-ninth and Fortieth Years of His Majesty's Reign, intituled " An Act for erecting a Lazaret on Chetney-Hill, " in the County of Kent; and for reducing into " one Act the Laws relating to Quarantine, and " one Act the Laws relating to Quarantine, and " for making further Provision therein:" And His Majefty doth hereby order, That all Ships, Veffels, Perfons, Goods, Wares, and Merchandife, now ar-rived, or which may hereafter arrive in any of the Ports of this Kingdom, or the Iiles of Guernfey, Larford Advance Sock or the Iiles of Guernfey, Jerley, Alderney, Sark, or Man, from any of the Ports of Pennfylvania or of Maryland, and shall have cleared out from any of the said Ports of Pennfylvania or Maryland, subsequent to the First Day of July last, (not having any Person or Persons on board the same, actually ill of the said Fever,) do perform a Quarantine of Fourteen Days at the feveral Places appointed, and according to the Rules prefcribed by His Majefty's Order in Council of the Twenty-ninth of July One thouland eight hun-dred, for Performance of Quarantine by all Ships and Veifels coming from or through the Mediter-ranean, or from the Weft Barbary on the Atlantic Ocean, and arriving with clean Bills of Health; but in cafe any of the Crew or Paffengers on board any which the Mediter and any fuch Ship or Veffel, which shall have cleared out. from any of the Ports of Pennsylvania or Maryland subsequent to the faid First Day of July, and shill have arrived, and may hereafter arrive in any of the Ports of this Kingdom, or the Islands of Guernfey, Jerley, Alderney, S.irk, or Man. from any of the laid Ports of Pennfylvania, or of Maryland, shall have died of the faid Fever during the Courfe of the Voyage, the Clothes, and all perional Effects which are fulceptible of Infection, worn by, or belonging to fuch Perfon, shall be forthwith burned or funk in deep Water: And if fuch Clothes, and Effects, shall not be to burned, or destroyed, the faid Ship, or Veffel, with the whole of her Cargo, fhall not be permitted to perform Quarantine at any Port or Place, except at Standgate Creek; and fhall be compelled to depart from any other Port or Place at which the lame has arrived, or shall arrive, as aforefaid; and shall repair to Standgate Creek, and there perform Quarantine, and not elsewhere: and His

appear, upon the Arrival of any Ship or Veffel, | from any of the faid Ports of Pennfylvania, or of Maryland, as aforefaid, that any of the Crew or Paffengers belonging to the fame are actually ilf of the faid Fever, then fuch Ship, or Veffel, and the Perfons, Goods, Wares, and Merchandize, on board the fame thall not be permitted to perform Quarantine at any Port or Place, except Standgate Creek, and fhall be compelled to depart from any other Port or Place, and to proceed immediately to Standgate Creek, in order to perform Quarantine, and shall there perform Quarantine, and not elfewhere : And the Right Honorable the Lords Commiffioners of His Majefty's Treafury, the Commiffioners for executing the Office of Lord High Admiral of Great Britain, the Lord Warden of the Cinque Ports, the Mafter General, and the Reft of the Principal Officers of the Ordnance, His Majefly's Secretary at War, and the Governors or Commanders in Chief for the Time being of the faid 1sles of Guernfey, Jerfey, Alderney, Sark, and Man, are to give the neceffary Directions herein', as to them may respectively appertain. Whitehall, September 25, 1802. Thereas it has been humbly reprefented to the King, that many daring and alarming Outrages have been lately committed by Perfons unlawfully affembling, armed and diguifed, and that on or about the following Times, viz.

April 22d laft, A large Hay Rick ; and a few Day's afterwards, a Dog Kennel and Oat Rick be-longing to Mr. Warren, of Warminiter, Wilts, were wilfully and malicioufly fet on Fire.

May 20, The Cart of Mr. Bayley, of Califon-Mills, near Devizes, returning from Warminster, was stopped on the Downs, (by Five Men, Four of whom had their Faces difguided, and a Sixth Man holding their Coats at a Diftance,) 'and the Driver compelled to leave the Cart whill the Men cut and otherwise injured the Cloths therein.

June 23, A Gun was fired in the Night into the Window of a Houfe occupied by a Workman of Meffirs. Bleek and Strode, at Warminster: About the fame Time a Rick of Hay belonging to Mr. Dunn, of Trowbridge, was wilfully and maliciously fet on Fire.

June 26, A large Rick of Hay belonging to Meffrs. T. and M. Tugwell, of Bradford, was alfo wilfully and malicioufly fet on Fire; and a threatening Letter was, about the fame Time, put under the Door of the Workshops of, and addressed to the faid Messrs. T. and M. Tugwell.

June 29, In the Night a Gun was fired into the Chamber of the Dwelling-House of Mr. Henry Wanley, of Warminster, in the County of Wilts.

July 6, In the Night a Gun was fired into the Houfe of John Jones, and another immediately af-terwards into the Houfe of ——— Baker, both Workmen to Mr. H. Wanfey ; and the fame Night a Gun was fired into the Houfe of Mr. Stancomb, Manufacturer, at Trowbridge.

July 13, In the Night, a Barn, Stable, &c. the Property of Mr. George Warren, Manufacturer, at Warminster, was wilfully and maliciously fet Fire to, and wholly confumed ;---and an anonymous Letter was fent to another Manufacturer at Warminster about this Time, threatening, by Almighty God, to have his Life within a Month.

July 14, In the Night, the Factory of Meffrs. Jones, Hart, Jones, and Co. at Staverton, near Bradford, was attacked by an Armed Body of Men, who fired many Rounds of Bullets, Slugs, &c. which demolifhed the Windows, and did other Damage.

July 16, This Night Clifford Mill and Premifes, near Beckington, Somerlet, the Property of Mr. Newton, were wilfully and malicioufly fet on Fire, and wholly deftroyed.

July 19, A large Hay Rick, at Bradford, the Property of Mr. Tanner, Manufacturer, was wil-fully and maliciously fet on Fire, and deftroyed.

July 22, The Mills at Littleton, in the Parish of Steeple Ashton, Wilts, belonging to Mr. Nailb, of Trowbridge, were attacked by an Armed Body of Men, (many of whom had their Faces blacken'd,) and who wilfully and malicioufly fet Fire to, and wholly deftroyed the fame, with the Machinery, and Stock in Trade therein, to a very confiderable Amount, after which they went away threatening Destruction to other Mills.

July 24, This Night Two Ricks of Hay, the Property of Mr. Newman, Manufacturer, of Mclkfham, was wilfully and malicioufly fet on Fire.

July 28, The Factory at Staverton, belonging to Meffirs. Jones and Co. was again attacked by an Armed Body of Men, who fired from Three different Parts at the Centinel on Duty.

July 29, In the Night, a Dwelling-Houfe, fituate at Bearfield, near Bradford, the Property of John Jones, Efq; was wilfully and maliciously fet on Fire and destroyed.

August 3, An extensive Building, situate in Trowbridge, belonging to Mess. Naith and Goldfinch, (in which was a confiderable Quantity of Machinery, Wool, &c. belonging to Mr. Naifh,) was wilfully and malicioufly fet on Fire and wholly deftroyed.

August 31, Two Cottages, a Stable, and Out-Houles, situate at the Common, in the Parish of Warminster, in the County of Wilts, belonging to Mr. George Warren, was wilfully and maliciously fet on Fire, and wholly destroyed.

September 9, Between Nine and Ten o'Clock in the Evening, a Gun was fired into the Window of a Sitting-Room in the Houfe of Mr. John Bleek, of Warminster.

His Majefly, for the better apprehending and bringing to Juffice the Perfons concerned in the Felonies abovementioned, is hereby pleased to promise His most gracious Pardon to any One of them, (except the Person or Perfons who adjually fet any of the feveral Premifes and Matters aforefaid, on Fire, or who adjually wrote the faid Letters,) who shall difeover his or their Accomplice or Accomplices in any or either of the above Felonics, fo that he, fle, or they may be apprehended and convided thereof.
