Cologne, Octob. 11.

**T**He Bishop of *Strasburg* has taken his leave of all the Persons of Quality here, and intends to part from hence on Monday next for *Strasburg*, and from thence to continue his Journey to *Paris*; some are of opinion, that this Journey will have some notable Consequences, with relation to the City of *Strasburg*; but others again disagree with them in this Matter.

*Lintz*, Octob. 12. Count *Caprara*, who Commands the Imperial Forces in *Hungary*, has sent an Express hither, to give the Emperor an Account of the posture of Affairs there; that his Troops for want of Pay, begin to be very disorderly: that the Malcontents are practising to debauch them from their Duty; and that they seem to promise themselves an assistance from the Turks. To morrow the Sentence against the Count of *Zinzendorf*, late President of the Emperors Revenues, will be pronounced: The Emperors Dowager intends to part hence on the 16th for *Vienna*, and with her goes the Queen of *Poland*; but their Imperial Majesties purpose to stay here this Winter.

*Berlin*, Octob. 14. The 8th Instant arrived here *Benjamin Paule*, Brother to him that Commands his Electoral Highnesses Ships, to give him an Account, that the Spanish Ship taken in the Road of *Ostend*, was past the *Sound*, and that they were carrying her to the *Pillar*; upon which the Elector gave strict Orders, that nothing in the said Ship should be touched or embzelled, till it be known what Resolution the King of *Spain* will take concerning the giving his Electoral Highness satisfaction in the Matter of the Subsidies due to him. In the mean time the Spaniards make great Complaints, and the Elector has written to the King of *Spain* to justify his Proceeding, and the reasonableness of it. The Prince of *Orange* is expected at *Posdam* the 19th or 20th Instant, whither the Elector is going to receive him, and in the mean time has sent several Persons of Quality to meet his Highness upon his entering upon his Dominions, to Conduct his Highness to *Posdam*.

*Amsterdam*, Octob. 15. The Prince of *Orange* is going to *Berlin*, from whence we have an Account, that the Elector of *Brandenburg* has accepted the Mediation of this State, for the composing the difference between the Crown of *Spain* and his Electoral Highness; who we understand, has likewise written to the King of *Spain*, That he was sorry he had been necessitated for the obtaining himself satisfaction in the Matter of Subsidies that remain due to him, to take a way he would not have done, could he have thought of any other to attain the same, but that his intention was not in the least to break the Peace which is between them; and to manifest his Resolution to continue a sincere Friendship and good Correspondence with His Majesty;

he offers to restore the said Ship and all that was taken in her, provided he have a reasonable satisfaction given him in his pretension. We have an Account from *Ostend*, of the arrival of the Prince of *Parma*.

*Amsterdam*, Octob. 18. Upon the Representations that have been made by the Minister of this State at *Berlin*, concerning the Ships fitted out by the Elector of *Brandenburg*, with a Design to employ them on the Coast of *Guinea* and *Angola*, his Electoral Highness has answered, that he never had any thoughts to incommode or disturb the subjects of this State, where they Trade on these Coasts exclusively to all others; but that the Design of those Frigates was only to seek their Fortune, where the Trade was open, and therefore feared, that if by Tempest, or any other accident they should be forced to put into any Port belonging to the *West-India* Company, that they might be favourably received. A *Hamburger*, who was a Slave at *Argiers*, having made his escape from thence in a Dutch Ship, the thing is before the States to consider what is fit to be done to prevent all occasions of difference with that Government.

*Antague*, Octob. 15. The Prince of *Orange* has writ to the States-General, to acquaint them that he has thought fit to make a Step as far as *Berlin*, to give the Elector of *Brandenburg* a visit, and that during his short stay there, he would employ his best endeavours to keep his Electoral Highness firm to the Common Interests of *Europe*; The States do well approve of his Highnesses Journey, and have resolved accordingly to write to him; but we are told, that the French Ambassador is not at all pleased with it. The Spanish Minister here has desired of the States, not to pay the Elector of *Brandenburg*, the Arrears of Subsidies that remain due to him from this State, till satisfaction be given by his Electoral Highness, for the Ship taken in *Ostend* Road; but the States thinking it better to have that Matter determined amicably, have offered their Mediation for the doing it, and have resolved to pay the Elector all the Arrears due to him, till the year 1676, which amount to about 300000 Livres; and its said, the Duke of *Zell* will likewise receive a considerable Sum upon the same Account. This day the Deputies of the respective Admiralties have had a Conference with the States, about the Equipping some Ships to serve for a Conyoy to the Prince of *Parma*, but news being come of his arrival at *Ostend*, the thing is laid by.

*Hague*, Octob. 18. This morning a Report was about Town, that the Elector Palatine was taken ill in his way home, in the Duke of *Neuburgs* Territories, but his Electoral Highnesses Minister here having no news of it, its hoped our next Letters from those parts will assure us of the contrary. The Prince and Princess of *Orange* are not expected here till the middle of the next Month.

*Cleves*, Octob. 12. On Thursday last arrived here  
the

the Elector Palatine from *Holland*, having upon his return from *England*, landed at *Rotterdam*, from whence he took his Journey directly hither; his Electoral Highness made no stay here, but parted again after Dinner, on his way to *Eologne*.

*Brussels*, Octob. 13. The Duke de *Villa Hermosa* having received Advice from *Ostend*; that the Prince of *Parma* arrived there the 11th Instant, and that he intended to be at *Ostend* as this day, his Excellency is gone thither to meet him there, and to Resign the Government into his hands; which done, his Excellency will return hither, to take care of his private Affairs, and in few days after will begin his Journey for *Spain*.

*Paris* Octob. 19. The 14th Instant dyed the Duke of *Fantadour*, in the 84th year of his age, he was the Kings Lieutenant-General in *Languedoc*. There are Letters which give an Account, that a French man of War Commanded by the Chevalier de *Lery*, having met two Frigats belonging to the Crown of *Portugal*, about two Leagues from the *Rock of Lisbon*, he required them to Salute him, which they refusing, the Chevalier de *Lery* gave them a Broadside, which they returned; that the Dispute lasted long between them, which was ended by the Portuguese Saluting the French, as was at first demanded, after which, the Chevalier de *Lery* continued his course, being bound to *Villa Franca*, to take on board an Ambassador which the Duke of *Savoy* is sending to *Portugal*, and to carry him thither. From *Schlestadt* they write, that the States of *Alsace* which had been summoned by the Sovereign Council Established at *Brisac*, to do Hommage to the King, had Declared, That they were ready to yield Obedience to His Majesties Commands, and that the Arms of *France* had been already put up in most places of that Country.

*Deal*, Octob. 11. There are at present above 200 Sail of Merchant Ships in the *Downs*, expecting a fair wind.

*Whitehall*, Octob. 13. His Majesty being informed, That notwithstanding His late Proclamation of the 4th of this Instant *October*, Commanding all *Papists*, or reputed *Papists*, to Depart from the *Cities of London and Westminster*, and from within Ten miles of the same, divers *Papists*, and persons reputed *Papists*, do resort to and remain in the *Cities of London and Westminster*, and within Ten miles distance from the same; His Majesty for the more effectual Discovery and Apprehension of such *Papists*, was this day Graciously pleased to Declare, That if the Churchwardens, and Overseers of the Poor of any Parish, within the *City of London*, or the Liberties thereof, or within Ten miles of the said *City*, shall discover any *Papists* remaining or abiding, contrary to Law, within their respective Limits, to *Philip Burton*, Gent. Solicitor, appointed to prosecute herein, they shall have and receive for the benefit of the Poor of the Parish, where such *Papists* shall be found, the Moiety of the hundredth pound Penalty due by Law to His Majesty, and recovered from such *Papists*, upon their being Indicted or Convicted thereof.

The Matters charged upon *Simpson Tongue*, who stands Committed to *Newgate* by Order of the Board, of the 24th of the last Month, for endeavouring by false Accusations, and Subornation of Perjury, to Defame the Kings Evidence, and all the Prosecutions of the Popish Plot, having been this day further Examined before His Majesty in Coun-

cil; His Majesty was pleased to Order, that Mr. Attorney-General do Prosecute the said *Tongue*; as likewise Capt. *Ely*, who appears to have been concerned in the aforesaid Practices, in the *Kings Bench* the next Term.
