#### Whitehall, February 12, 1803.

As feveral Artificers and Manufacturers, Subjects of Is feweral Artificers and Manufacturers, Subjects of Great Britain, have, from Time to Time, gone into Foreign Countries to exercife their feweral Callings, contrary to the Laws of thefe Kingdoms, the follow. ing Abstracts of Ads of Parliament of Their late Majestics King George the First and Second, and of His prefent Majefly, for preventing fuch Practices, are publified, for the Information of all Perfons who may be ignorant of the Penalties they may incur-by Difobedience to them : And it will be observed, that fuch Penalties likewife extend to those who are any ways concerned or infirumental in the Sending or Enticing Artificers or Manufacturers out of thefe Kingdoms, or in the Exportation of the Tools and Instruments used by them, as well as to the Artificers or Manufacturers themfelves.

Statute 5 George I. Chap. 27.

F any Perfon thall contract with, entice, or folicit, 1 any Artificer in Wool, Iron, Steel, Brafs, or other Metal, Clock-maker, Watch-maker, or any other Artificer of Great Britain, to go into Foreign Countries out of the King's Dominions, and fhail be convicted thereof, upon Indictment or Information in any of the Courts at Weftminfter, or at the Affizes or Quarter Schons, he shall be fined any Sum not exceeding ONE HUNDRED POUNDS for the first Offence, and shall be imprisoned Three Months, and till the Fine be paid. And if any Perfon having been once convicted shall offend again, he shall be fined at the Diferentian of the Court, and imprisoned Twelve Months, and till the Fine be paid.

If any of the King's Subjects, being fuch Artificers, fhall go into any Country out of His Majefty's Dominions, to exercise or teach the faid Trades to Foreigners; and if any of the King's Subjects in any such Foreign Country, exercising any of the faid Trades, shall not return into this Realm within Six Months after Warning given by the Ambaffador, Minister, or Conful of Great Britain, in the Country where fuch Artificers shall be, or by any Person authorifed by such Ambaffador, &c. or by one of the Sccretaries of State, and from henceforth inhabit within this Realm; such Persons shall be incapable of taking any Legacy, or of being an Executor or Administrator, or of taking any Lands, &c. within this Kingdom, by Defcent, Devife, or Purchafe, and shall forfeit all Lands, Goods, &c. within this Kingdom, to His Majesty's Use, and shall be deemed Alien, and out of His Majesty's Protection.

Juffice of Peace, that any Perfon is endeavour-ing to feduce any fuch Artificer, or that any fuch Artilicer hath contracted or is preparing to go out of His Majesty's Dominions, for the Purposes afore-faid, such Jultice may fend his Warrant to bring the Person complained of before him, or before fome other Justice; and if it shall appear by the Oath of One Witnefs, or by Confession, that he was guilty of any of the faid Offences, fuch Justice may bind him to appear at the next Affizes or Quarter Seffions: And if fuch Perfon shall refuse to give Security, the Justice may commit him to Gaol till the next Affizes or Quarter Schlons, and until he shall be delivered by due Course of Law. And if any such Artificer shall be convicted, upon Indictment, of any fuch Promife, Contract, or Preparation to go beyond the Seas, for the Purpole aforefaid, he shall give fuch Security to the King not to depart out of His Majefty's Dominions, as fuch Court fhall think reasonable, and shall be imprisoned till Security given.

If any of the above Offences shall be committed in Scotland, the fame shall be profecuted in the Court of Justiciary or the Circuits there.

Statute 23 George II. Chap. 13.

IF any Perfon shall contract with, or endeavour to feduce any Artificer in Wool, Mohair, Cotton, or Silk, or in Iron, Steel, Brass, or other Metal, or any Clock-maker, Watch-maker, or any other Artificer in any other of the Manufactures of Great Britain or Ireland, to go out of this Kingdom or Ireland into any Foreign Country not within the Dominions of the Crown of Great Britain, and shall be convicted, upon Indictment or Information, in the Kings Bench at Weitminster, or by Indictment at the Affizes or General Gaol Delivery for the County, &cc. wherein fuch Offence fhall be committed in England, or by Indictment in the Court of Jufticiary or any of the Circuit Courts in Scotland, or by Indictment or Information in the King's Bench at Dublin, if fuch Offence be committed in Ireland; the Perfon fo convicted fhall, for every Artificer contracted with or feduced, forreit FIVE HUNDRED POUNDS, and fhall fuffer Impriforment in the Common Gaol of the County or Stewartry wherein fuch Offender fhall be convicted for Twelve Calendar Months, and until Forfeiture be paid: And in cafe of a fubfequent Offence of the fame Kind, the Perfous fo again offending fhall forfeit, for every Perfon contracted with or feduced, ONE THOUSAND POUNDS, and fhall fuffer Impriforment in the Common Gaol of the County or Stewartry wherein fuch Offender fhall be convicted, for Two Years, and until fuck Forfeiture be paid.

If any Perfon in Great Britain or Ireland fhall put on board any Ship or Boat, not bound directly to fome Port in Great Britain or Ireland, or to fome other of the Dominions of the Crown of Great Britain, any fuch Tools or Utenfils as are commonly ufed in, or proper for the Preparing, Working up, or Finishing of the Woollen or Silk Manufactures, or any Part of fuch Tools, he shall, for every Offence, forfeit all fuch Tools, or Parts thereof, put on board, and TWO HUNDRED POUNDS, to be recovered by Action of Debt, &c. in any Court of Record at Westminster, or in the Court of Selfion in Scotland, or at any of the Four Courts in Dublin respectively, wherein no Ession, &c. shall be allowed.

It shall be lawful for any Officer of the Customs in Great Britain, or for any Officer of the Revenue in Ireland, to feize and fecure, in fome of His Majesty's Warehouses, all fuch Tools or Utensils prohibited to be exported, as such Officer shall find on board any Vessel not bound directly to fome Port in Great Britain or Ireland, or to fome other of the Dominions of the Crown of Great Britain; and all Tools fo feized shall, after Condemnation, be publicly fold to the best Bidder; and one Moiety of the Produce shall be to the Use of His Majesty, and the other Moiety to the Officer who shall feize and fecure the fame.

If the Captain of any Veffel in Great Britain or Ireland knowingly permit any of the faid Tools, prohibited to be exported, to be put on board his Veffel, he fhall, for every fuch Offence, forfeit ONE HUNDRED POUNDS, to be recovered as the Penalties inflicted upon Perfons exporting the Tools; and, if the Veffel belongs to His Majeity, the Captain fhall not only forfeit ONE HUNDRED POUNDS, but fhall alfo forfeit his Employment, and be incapable of any Employment under His Majefty. If any Officer of the Cuftoms in Great Britain

If any Officer of the Cuftoms in Great Britain or of the Revenue in Ireland, take, or knowingly fuffer to be taken, any Entry outward, or fign any Cocket or Sufferance for the Shipping or Exporting of any of the faid Tools, or knowingly fuffer the fame to be done, he fhall forfeit ONE HUNDRED POUNDS, to be recovered as aforefaid, and alfo forfeit his Office, and be incapable of any Office under His Majefty.

One Moiety of the Forfeitures shall be applied to the Ufe of His Majefty, and the other Moiety to the Ufe of the Perfon who shall fue for the fame.

Statutes 14, 21, 25, and 26 of His prefent Majefly. BY thefe Statutes the like Penalties and Forfeitures as above-mentioned are extended to Perfons packing or putting on board any Veffel, not bound directly for fome Port in Great Britain or Ireland, any Machine, Engine, Tool, Prefs, Paper, Uteniil, or Implement whatfover, ufed in or proper for the working or finishing of the Cotton, Steel, or Iron Manufactures of this Kingdom, or any Part or Parts of fuch Machines or Implements, or any Models or Plans thereof ; and all Captains of Ships and other Perfons receiving or being in Poffeffion of any fuch Articles, with an Intent to export the fame to Foreign Parts, and all Cultom-house Officers fuffering an Entry to be made thereof, are refpectively liable to the like Penalties as are above-mentioned, in the cafe of Tools and Utenfils ufed in the Woollen and Silk Manufactures.

American Claim-Office, London, Jan. 24, 1803. By the Board of Commiffioners appointed under the Seventh Article of the Treaty of Amity, Commerce, and Navigation, concluded at London on the 4th Day of November 1794, between His Britannic Majefty and the United States of America.

IT Hereas by the Third Article of a Convention, concluded at London on the 8th of January 1802, relative to the Sixth and Seventh Articles of the Treaty of Amity, Commerce, and Navization, between the Plenipotentiaries of His Britannic Majefly and the United States of America, it is, amongst other Things, agreed and concluded, "That all Sums of Money awarded to " be paid to British or American Claimants, according " to the Provisions of the faid Seventh Article, shall be "made payable in Three equal Instalments, the first " whereof to be paid at the Expiration of One Year, the Second at the Expiration of Two Years, and the " Third and Laft at the Expiration of Three Years, next
