For encouraging Seamen and Landmen to enter themfelves on board His Majefy's Ships of War.

Α

GEORGE R. HEREAS it is Our Royal Intention to give all due Encouragements it is in the second give all due Encouragement to all fuch Seamen and Landmen who fhall voluntarily enter themfelves in Our Service; We have thought fit, by and with the Advice of Our Privy Council, to publish this Our Royal Proclamation : And We do hereby promife and declare, That all fich Able Seamen not above the Age of Fifty, nor under the Age of Twenty Years, fit for Our Service, who fhall, on or before the Thirtjeth Day of April next, volumtarily enter themfelves to ferve in Our Royal Navy, either with the Captains or Lieutenants of Our Ships, or Officers employed in Tenders or at Rendezvous on Shore for raining Men for the Service of Our Navy, fhall receive, as Our Royal Bounty, the Sum of Three Pounds each Man; and all fuch Ordinary Seamen fit for Our Service, who shall so enter themselves as aforefaid, shall receive the Sum of Two Pounds each Man; and all fuch Able-

bodied Landmen, not above the Age of Thirtyfive, nor under the Age of Twenty Years, who hall fo enter themfelves as aforefaid, fhall receive the Sum of Twenty Shillings each Man, as Our Royal Bounty, fuch respective Sums to be paid them by the respective Clerks of the Checque refiding at the Ports or Places where the Ships into which they shall be entered, shall be, immediately after the Third Muster of such Seamen and Landmen: And We do declare, That the Qualifications of the Scamen and Landmen fo entering themfelves as aforefaid, shall be certified by the Captain, Mafter, and Boatfwain of the Ship or Veffel where they fhall enter. And for preventing any Abufes by any Perfons leaving the Veffels to which they fhall belong, and entering themfelves on board any other Our Ships or Veffels, in order to obtain the faid Bounty Money; We do hereby declare and command, That fuch Seamen and Landmen be-longing to any of Our Ships or Veffels as shall abfent themfelves from any of the faid Ships or Veffels to which they shall belong, and shall enter them-felves on board any other of Our said Ships or Vessels, in order to obtain the faid Bounty, shall not only lose the Wages due to them in the Ships or Veffels they shall leave, but also be feverely panifhed according to their Demerits.

### PROCLAMATION, A

For recalling and prohibiting Seamen from ferving Foreign Princes and States ; and for granting Re-wards for difcovering fuch Seamen as fhall conceal them felves.

GEORGE R. WHEREAS We are informed, That great Numbers of Mariners and Seafaring Men, Our natural-born Subjects, are in the Service of divers Foreign Princes and States, to the Prejudice of Our Kingdom; We have thought it necellary, by and with the Advice of Our Privy Council, to publish this Our Royal Proclamation; and do hereby strictly charge and command all Masters of Ships, Pilots, Mariners, Seamen, Shipwrights, and other Seafaring Men whatfoever and wherefoever (being Our natural-born Subjects), who are in the Pay or Service of any Foreign Prince or State, or do ferve in any Foreign Ship or Vellel, that forthwith they, and every of them, do (according to their known and bounden Duty and Allegiance) withdraw themfelves, depart from, and quit fuch Foreign Services, and return home to their Native Countries: And further, We do hereby firicity prohibit and forbid all Masters of Ships, Pilots, Mariners, Seamen, Shipwrights, and other Sea-faring Men whatfoever (being Cur natural-born Subjects), from entering, and do charge and command them, and every of them, from henceforth to forbear to enter themfelves into the Pay or Service of any Foreign Prince or State, or to ferve le,

any Foreign Ship or Veffel whatfoever, without . Our Special Licence first had and obtained in that Behalf ; to all which We expect due Obedience and exact Conformity; And We do hereby publish and declare, That the Offenders to the contrary shall not only incur Our just Displeasure, but be pro-ceeded against for their Contempt according to the utmost Severities of the Law: And We do hereby declare, That if any fuch Masters of Ships, Pilots, Mariners, Seamen, Shipwrights, or other Seafaring Men, (being Our Subjects,) shall be taken in any Foreign Service by the Turks, Algerines, or any others, they shall not be reclaimed by Us as Subsjects of the United Kingdom of Great Britain and Ireland: And We do hereby further promife and declare, That a Reward of Twenty Shillings for every Able and Ordinary Seaman fit to ferve on board Our Ships, shall be paid any Person who shall discover any Seaman or Seamen who may conceal him or themselves, fo that such Seaman or Seamen shall be taken for Our faid Service by any of Our Sea Officers employed for railing Men, on or before the Thirtieth Day of April next; the faid Rewards to be paid for any Seaman or Seamen fo diffeovered and taken in and about London, by the Principal Officers and Commiffioners of Our Navy; and at the Out-Ports by the Naval Officers, (where there are any), and (where there are no Naval Of-ficers), by the Collectors of Our Cultoms, immediately upon a Certificate being produced to the Taid Principal Officers and Commiffioners of Our Navy, Naval Officers, or Collectors respectively, by the Perfon who may make Difcovery of any Seaman or Seamen as aforefaid, certifying his Name, and the Name or Names, and Number of Seamen procured in confequence of his Difcovery; the faid Certificate to be given by fuch Officer as may take fuch Seaman or Seamen for Our Service.
