THEREAS the Time limited by His Majefty's Order in Council of the Sixth Day of April last, for prohibiting the Exportation out of this Kingdom, or carrying Coastwife, Gunpowder or Salt Petre, or any Sort of Arms or Ammunition, will expire upon the Sixth Day of June next: And whereas it is judged expedient for His Majesty's Service, and the Safety of this Kingdom, that the faid Prohibition should be continued for fome Time longer, His Majesty doth therefore, by and with the Advice of His Privy Council, hereby order, require, prohibit, and command, that no Person or Persons whatsoever, (except the Master-General of the Ordnance for His Majesty's Service,) do at any Time, during the Space of Six Months, to commence from the faid Sixth Day of June next, presume to transport into any Parts out of this Kingdom, or carry Coastwife, any Gunpowder or Salt Petre, or any Sort of Arms or Ammunition, or ship or lade any Gunpowder or Salt Petre, or any Sort of Arms or Ammunition, on board any Ship or Vessel in order to transporting the same into any Parts beyond the Seas, or carrying the same Coastwise, without Leave or Permission in that Behalf first obtained from His Majesty or His Privy Council, upon Pain of incurring and fuffering the respective Forseitures and Penalties inflicted by an Act passed in the Twenty-ninth

" Exportation of Salt Petre, and to enforce the " Law for empowering His Majesty to prohibit " the Exportation of Gunpowder, or any Sort of " Arms or Ammunition; and also to empower " His Majelty to restrain the carrying Coastwise of " Salt Petre, Gunpowder, or any Sort of Arms or " Ammunition:"-And the Right Honorable the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, the Lord Warden of the Cinque Ports, the Master-General of the Ordnance, and His Majesty's Secretary at War, are to give the necessary Directions herein, as to them may respectively appertain. #### By the KING. PROCLAMATION.

For increasing the Militia.

GEORGE R.

THEREAS it is expedient that the Number of Our Militia Forces should be increased without Delay: And whereas the Occasion thereof hath been communicated to Parliament: We have thought fit, by and with the Advice of Our Privy Council, to publish this Our Royal Proclamation; and We do hereby, in pursuance of the Powers which are vested in Us by an Act passed in the Forty-second Year of Our Reign, intituled "An " Act for amending the Laws relating to the Mi-"litia in England, and for augmenting the Mi-"litia," and of another Act passed in the same Year, intituled "An Act to raise and establish a " Militia Force in Scotland," order and direct that, in Addition to the Number of Men already required to be raifed under the faid Acts by the feveral Counties, Ridings, Stewartries, Cities, and Places therein mentioned, there shall forthwith be raised and enrolled in the faid feveral Counties, Ridings, Stewartries, Citics, and Places therein mentioned, respectively, such a Number of Men as may amount to, but not exceed the Proportion of One Half of the whole Number of Men required to be railed by Year of His late Majesty's Reign, intituled "An the said Acts in each County, Riding, Stewartry, Act to empower His Majesty to prohibit the City, and Place respectively: And We do hereby

further order and direct Our Lieutenants and Deputy Lieutenants respectively, of the said several Counties, Ridings, Stewartries, Cities, and Places, immediately to affemble and forthwith proceed to apportion the Number of Men hereby required to be raised in their respective Counties, Ridings, Stewartries, Cities, and Places among the several Huadreds, Rapes, Lathes, Wapentakes, or other Divisions, and also among the several Parishes, Tythings, or Places therein respectively, and thereafter to proceed to raise and enrol such Men on or before the Sixteenth Day of July next columns.

Given at Our Court at St James's, the Twentyfixth Day of May, in the Year of our Lord One thousand eight hundred and three, in the Forty-third Year of Our Reign.

The KING's Most Excellent Majetty in Council. THEREAS, in purfuance of the Powers veiled W in His Majesty, by an Act passed in the present Session of Parliament, intituled "An Act to continue, until the First Day of January " One thousand eight hundred and four, several " Laws relating to the prohibiting the Exportation and permitting the Importation of Corn, and for allowing the Importation of other Ar-" ticles of Provision without Payment of Duty; to the Relief of Captors of Prizes, with respect " to the bringing and landing certain Prize Goods 44 in this Kingdom; and to the regulating the " Trade and Commerce to and from the life of " Malta;" His Majefly was pleafed, by His Order in Council, bearing Date the Thirty first of December last, to order, and it was thereby ordered, That the Probibition laid, by Order of His Majelly in Council, bearing Date the Twelfth Day of Decomber One thousand eight hundred and one. upon the Exportation from any Port or Place in Great Britain of any Wheat, Rye, Barley, Beer or Bigg, Peale, Beans, Oats, or any Meal or Flom, or Bread, Bilcuit, or Malt made thereof, or of any Indian Corn or Maize, or Meal or Flour made thereof; and also the Liberty, granted by the fa d Order in Council, bearing Date the Twelfth Day of December One thousand eight hundred and one, to import and take out of Warehouse Foreign Corn and other Articles as aforefaid, and likewife to import fundry other Articles of Provision Duty free, should be further continued until the Thirty fast Day of March last, save and except the Importation, Duty free, of the Articles of Rice and Malt; and fave and except, as it was declared by the faid Order, that nothing therein contained was intended to extend, or fhould be confirmed to extend, to affect or apply to any Exportation of Seed Corn from Great Britain to Ireland, or any Importation of Malt from Ireland to Great Britain, in the Manner authorized by an Act palled in the present Session of Parliament, intituled "An Act for continuing, until the First Day of July One . thousand eight hundred and three, an Act made 6 in the Forty-feeond Year of the Reign of His !

"present Majesty, intituled An A& for regulating, until the Fifteenth Day of February One thoufand eight hundred and three, the Prices at which
Grain, Meal, and Flour may be exported from
Grear Britain to Ireland, and from Ireland to
Great Britain; and for permitting, from and
after the passing thereof, until the faid First Day
of July One thousand eight hundred and three,
the Exportation of Seed Corn from Great Britain to Ireland, and the Importation of Malt
into Great Britain from Ireland?"

And whereas His Majefly's faid Order in Council of the Thirty-first Day of December last, has been further continued until the Thirty-first Day of this instant May;

And whereas it is judged expedient that the faid Prohibition to export, and the faid Permilian to import, should be continued for some Time longer, His Majelly, therefore, by and with the Ad c. of His Privy Council, and in purfuance of the Powers given by the First of the above-recited Acts, passed in the present Session of Parliament, bath thought in to order, and it is hereby ordered, That the faid Order in Council, bearing Date the Thirty-first of December last, and all the Exceptions, Provisoes. Rules Regulations, and Reftrictions, specified and enforced by the faid Order, respecting such Exportation and Importation, and taking out of Warehouse, shall be, and continue in Force until the Thirtieth Day of June next inclusive, in the same Manner as the fame are now in Force by the faid Order, bearing Date the Thirty-first Day of December last. And the Right Honorable the Lords Commissioners of His Majesty's Treasury are to give the necessary Directions herein accordingly. W. Fawkener.
