A PROCLAMÁTION. GEORGE R.

THEREAS by an Act, passed in the Fortythird Year of Our Reign, intituled " An « AA to repeal an AA paffed in the last Seffion of " Parliament for establishing Regulations respecting " Aliens arriving in this Kingdom, or refident " therein ; and for establishing, until Three Months " after the Ratification of a Definitive Treaty of " Peace, Regulations refpecting Aliens arriving in " this Kingdom, or refiding therein, in certain " Cafes ;" We are authorized by Our Royal Proclamation, from Time to Time, to require and command every Alien who now is in, or who fhall hereafter come into, Great Britain, except as therein excepted, to register himfelf or herfelf, and thereupon to obtain Our Royal Licence to refide within this Kingdom, as therein-mentioned : Now We, being defirous of carrying into Execution the Purpoles of the faid A&, do, by this Our Proclamation, by and with the Advice of Our Privy Council, require and command every Alien who shall be in this Kingdom on the Day of the Date of this Our Proclamation, except as hereinafter excepted, to register himself or herfelf, in the Manner hereinafter-mentioned ; that is to fay,

- All Aliens refiding in the City of London fhall, within Ten Days from the Publication of this Our Proclamation in the London Gazette, fo register themfelves with the Lord Mayor of the faid City:
- All Aliens refiding in the City and Liberties of Weilminfter, or elfewhere within the Bills of Mortality (except the City of London), or refiding within Ten Miles of the City of London, fhall, within Ten Days from the Publication of this Our Proclamation in the London Gazette, fo register themfelves with the Magistrates at One of the undermentioned Public

- Offices, in the Diftrict of which Office fuch Alien fhall then refide; that is to fay, the Police Office Queen-Square, Weftminfter; Great Marlbro'-Street; Hatton-Garden; Lambeth-Street, Whitechapel; Worfhip-Street, Shoreditch; High-Street, Shadwell; and Union-Hall, Southwark:
- All Aliens refiding out of the Districts aforefaid, and within any Cities or Corporate Towns, or within the Jurifdiction of the Magistrates of fuch Cities or Corporate Towns refpectively, shall, within Fourteen Days from the Publication of this Our Proclamation in the London Gazette, fo register themselves with the Mayor or other Chief Magistrate of fuch Cities or Corporate Towns respectively:
- And all Aliens refiding in other Places in Great Britain fhall, within Eighteen Days from the Publication of this Our Proclamation in the London Gazette, fo register themfelves with fome Magistrate of the County or Place where fuch Aliens respectively shall refide.

And We do further require and command all Aliens who shall come into Great Britain, after the Publication of this Our Proclamation in the London Gazette, to register themselves in the Manner hereinafter-mentioned with the Lord Mayor, Mayors, or other Magistrates as aforefaid, within Two Days after every fuch Alien shall have arrived within any fuch City, Town, Diffrict, or other Place to which he shall be allowed to proceed, by Passport granted for that Purpose, except Aliens who are required by Our Proclamation of the Twelfth August last to land at no other Port than the Ports of Yarmouth, Harwich, Dover, and Southampton, and at Gravefend, whom We hereby require and command to register themselves in Manaer hereinafter-mentioned, at the Alien Office in Crown-Street, Weltminster.

tion of this Our Proclamation in the London Gazette, fo register themselves with the Magistrates at One of the undermentioned Public as aforefaid, to deliver, or cause to be delivered, to the Perfon or Perfons with whom such Alien is hereby required to register himfelf or herfelf as aforefaid, a full and true Decleration or Account in Writing of his or her Name, Age, Place of Birth, Rank, Occupation, Profession, the Place of Refidence when last in his or her own Country, together with the laft and principal Place of Refidence before his or her Arrival in this Kingdom, the Name or Names of fome Person or Persons in this Country to whom known, the Reafon or Purpofe for which he or fhe came to this Kingdom, the Time when, and the Piace at which, fuch Alien laft arrived in Great Britain, and where his or her actual Refidence has been fince fuch laft Arrival, and is at the Time of giving in fuch Declaration, which faid Declaration or Account shall be figned by fuch

And We do hereby authorize and appoint the faid Lord Mayor, Mayors, and other Magiltrates as aforefaid respectively, to receive fach Accounts as aforefaid, and do require and command them respectively to cause the original Account to be transmitted within Two Days to Our Principal Secretary of State for the Home Department, for the Putpofe of fuch Alien obtaining Our Royal Licence to refide within Great Britain from the faid Secretary, whom We do hereby authorize and appoint to grant fuch Licences, or from fuch other Perfon or Perfons who now are, cr who shall from 'Time to Time be authorized and appointed by Us to grant fuch Licences.

Alien with his or her Name or Mark.

And We do further authorize and require the faid Lord Mayor, Mayors, and other Magistrates as aforefaid, to whom any fuch Accounts shall be delivered as aforefaid, to grant under his Hand and Seal to the Alien delivering fuch Account, a provisional Licence to refide within Great Britain, under fuch Reftrictions as shall appear fit, during the Time that shall be therein allowed to fuch Alien for obtaining Our Royal Licence as aforefaid.

And We do further declare, That this Our Proclamation shall not extend to require any Alien to obtain fuch Licence as aforefaid, who shall, before the Publication of this Our Proclamation in the London Gazette, have obtained Our Royal Licence to relide in any Part of this Kingdom.

And We do further direct, That every Alien as aforefaid, upon every Change of Refidence, as well to any Place in the fame City, Town, District, or Place, as in any other City, Town, Diffrict, or Place, fhall give Four Days previous Notice thereof to the Perfon or Perfons with whom he or fhe has been fo registered, and shall again register himfelf or herfelf in Manner before-mentioned according to fuch new Refidence, declaring the Refidence from whence he or fhe fo removed.

And We do further declare, That no Foreign Ambailador, or other public Minister duly autho-

rized, nor the domeltic Servants of any fuch Foreign Ambaffador, or public Minister registered according to the Directions of the Laws in force for that Purpose, and being actually attendant upon fuch Ambaffador or Minister; nor any Alien not above the Age of Fourteen Years, shall be deemed within the Meaning and Intent of this Proclamation.

And We do further declare, That all fuch Licences, and provisional Licences, as aforefaid shall be given without Fee or Reward, and shall be fubject to no Duty or Charge whatfoever.

And We do further declare and make known, That every Alien who shall be found at large in Great Britain after the Time by this Our Proclamation limited for registering and thereupon obtaining Licences as aforefaid, fuch Aliens not having obtained fuch Licence refpectively, and not being exempted as aforefaid, will be liable on Conviction to fuffer Imprifonment for any Time not exceeding Six Months, according to the Provisions of the faid A&.

St. James's, October 20, 1803.

THE following Addresses having been presented to the King; which Addresses His Majesty was pleased to receive very graciously:

Most Gracious Sovereign,

WE, your Majefty's loyal and dutiful Subjects, the Noblemen, Heritors, Freeholders, Juitices of the Peace, Committioners of Supply, Clergy, and Gentlemen of the County of Banff, alfembled, imprefied with a Senfe of the prefent important Crifis, prefume to approach the Throne with our unanimous Affurance of Attachment to your Majelty's Perfon and Government.

The Contelt in which the Nation is involved we confider as jult as it is neceffary, and now humbly beg Leave to come forward with an Offer of our Lives and Properties for the Safety of our Majefty's Perfon, and the Honor and Independence of the Crown.

We behold with Horror the Cruelties and Injuffice exercifed by the Military Defpot of France

But we view with Admiration the Zeal and Determination manifelted by all the Subjects of your Majefty's Dominions, as a System with the Affiltance of Almighty God, the most certain to overwhelm the Devices, and check the Plans of an Usurper who afpires to universal Rule through the Subversion of our Civil and Religious Privileges, who hopes to complete his Views of Aggrandizement by the Annihilation of that glorious Conftitution, which is the Envy of furrounding Nations. Whilft we reprobate the ambitious Deligns of

our Enemy, we truft that, with the Affiftance of Almighty God, the wife Counfels of your Majefty's Government, and the vigorous Exertions of your Navy and Army, these Designs will be frustrated, and the Bleffings of Peace rettored. And pray that your Majesty may long reign over your free and happy People.

As feveral Artificers and Manufacturers, Subjects of Great Britain, have, from Time to Time, gonz into Foreign Countries to exercise their feveral Callings, containy to the Laws of these Kingdoms, the follow-ing Auftracts of Acts of Parliament of Their latz Majeflies King George the First and Second, and of His Account Majefly for presenting orth Parlian His prefent Majely, for preventing fuch Prastices, are published, for the Information of all Perfons who may be ignorant of the Penalties they may incur by Difobedience to them: And it will be observed, that fuch Penalties likewife extend to those who are any ways concerned or inflrumental in the Sending or Enticing Artificers or Manufacturers out of these Kingdoms, or in the Exportation of the Tools and Inftruments used by them, as well as to the Artificers or Manufacturers themfelves.

Statute 5 George I. Chap. 27.

F any Perlon shall contract with, entice, or folicit, 1 any Artificer in Wool, Iron, Steel, Brafs, or other Metal, Clock-maker, Watch-maker, or any other Artificer of Great Britain, to go into Foreign Countries out of the King's Dominions, and shall be convicted thereof, upon Indictment or Informa-tion in any of the Courts at Westminster, or at the Affizes or Quarter Seffions, he fhall be fined any Sum not exceeding ONE HUNDRED POUNDS for the first Offence, and shall be imprisoned Three Months, and till the Fine be paid. And if any Per-fon having been once convicted shall offend again, he shall be fined at the Difcretion of the Court, and imprifoned Twelve Months, and till the Fine be paid.

If any of the King's Subjects, being fuch Artificers, shall go into any Country out of His Majefty's Dominions, to exercise or teach the faid Trades to Foreigners; and if any of the King's Subjects in any such Foreign Country, exercifing any of the faid Trades, shall not return into this Realm within Six Month: after Warning given by the Ambaffador, Minifler, or Conful of Great Britain, in the Country where fuch Artificers shall be, or by any Perfon authorifed by fuch Ambaffador, &c. or by one of the Secretaries of State, and from henceforth inhabit within this Realm; fuch Perfons hall be incapable of taking any Legacy, or of being an Executor or Administrator, or of taking any Lands, &c. within this Kingdom, by Defcent, Devife, or Parchafe, and shall forfeit all Lands, Goods, &c. within this Kingdom, to His Majesty's Ufe, and shall be deemed Alien, and out of His

Upon Complaint made, upon Oath, before any Milice of Peace, that any Perfon is endeavouring to feduce any fuch Artificer, or that any fuch Artificer hath contracted or is preparing to go out of His Majefty's Dominious, for the Purpofes afore-aid, such Juffice may fend his Warrant to bring the Perfon complained of before him, or before for e other Justice; and if it shall appear by the Oath of One Witnefs, or by Confession, that he was guilty of any of the faid Offences, fuch Justice may bind him to appear at the next Affizes or Quarter Seltions: And if fuch Perfon shall refuse to give Security, the Juffice may commit him to Gaol till the next Affizes or Quarter Seffions, and until he shall he delivered by die Courfe of Law. And if any fuch Artificer shall be convided, upon Indictment, of any fuch Promise, Contract, or Preparation to go beyond the Seas, for the Purpole aforefaid, he shall give fuch Security to the King not to depart out of His Majelly's Dominions, as such Court shall think reafonable, and flull be imprifoned till Security given.

If any of the above Offences shall be committed in Scotland, the fime shall be profecuted in the Court of Jufficiary or the Circuits there.

Statute 23 George II. Chap. 13.

IF any Perfon shall contract with, or endeavour to seduce any Artificer in Wool, Mohair, Cotton, or Silk, or in Iron, Steel, Brafs, or other Metal, or any Clock-maker, 'Watch-maker, or any other Artificer in any other of the Manufac-tures of Great Britain or Ireland, to go out of this Kingdom or Ireland into any Foreign Country not within the Dominions of the Crown of Great Britain, and shall be convicted, upon Indictment or Information, in the Kings Bench at Weftminfler, or by Indictment at the Affizes or General Gaol Delivery for the County, &c. wherein fuch Offence fhall be committed in England, or by Indictment in the Court of Jufficiary or any of the Circuit Courts in Scotland, or by Indictment or Information in the King's Bench at Dublin, if fuch Offence be committed in Ire-land; the Perfon fo convicted shall, for every Artilicer contracted with or feduced, forfeit FIVE HUNDRED POUNDS, and fhall fuffer Impri-fonment in the Common Gaol of the County or Stewartry whereia fich Offender shall be convicted for Twelve Calendar Months, and until Forfeiture be paid: And in cale of a subfequent Offence of che fame Kind, the Perfons fo again offending thall forfeit, for every Perion contracted with or feduced, ONE THOUSAND POUNDS, and thall fuffer Imprilonment in the Common Gaol of the County or Sawartry wherein fuch Offender Ihall be convicted, for Two Years, and until fuch Forfeiture be paid.

If any Perfon in Great Britain or Ireland shall put on board any Ship of Boar, not bound directly to fome Port in Great Ibliain or Ireland, or to fome other of the Dominipue of the Crown of Great Britain, any fuch Tools or Utenfils as are commonly ufed in, or proper for the Preparing, Working up, or Finifhing of the Woullen or Silk Manufactures, or any Part of fuch Tools, he shall, for every Offence, forfeit all fuch Tools, or Parts thereof, put on board, and TWO HUNDRED POUNDS, to

of Record at Weltminster, or in the Court of Selfion in Scotland, or at any of the Four Courts in Dublin respectively, wherein no Essoin, &c. shall be allowed.

It shall be lawful for any Officer of the Customs in Great Britain, or for any Officer of the Revenue in Ireland, to feize and fecure, in fome of His Majefty's Warehoufes, all fuch Tools or Utenfils prohibited to be exported, as fuch Officer shall find on board any Vessel not bound directly to some Port in Great Britain or Ireland, or to fome other of the Dominions of the Crown of Great Britain; and all Tools to feized shall, after Condemnation, be publicly fold to the beft Bidder; and one Moiety of the Produce shall be to the Use of His Majesty, and the other Moiety to the Officer who shall seize and fecure the fame.

If the Captain of any Veffel in Great Britain or Ireland knowingly permit any of the faid Tools, prohibited to be exported, to be put on board his Veffel, he fhall, for every fuch Offence, forfeit ONE HUNDRED POUNDS, to be recovered as the Penalties inflicted upon Perfons exporting the Tools; and, if the Veffel belongs to His Majefty, the Captain shall not only forfeit ONE HUNDRED POUNDS, but shall also forfeit his Employment, and be incapable of any Employment under His Majesty.

If any Officer of the Customs in Great Britain or of the Revenue in Ireland, take, or knowingly fuffer to be taken, any Entry outward, or fign any Cocket or Sufferance for the Shipping or Exporting of any of the faid Tools, or knowingly fuffer the fame to be done, he shall forfeit ONE HUNDRED POUNDS, to be recovered as aforefaid, and alfo forfeit his Office, and be incapable of any Office under His Majelty.

One Moiety of the Forfeitures shall be applied to the Use of His Majesty, and the other Moiety to the Use of the Person who shall sue for the fame.

Statutes 14, 21, 25, and 26 of His prefent Majefly.
