THEREAS His Majesty was pleased by His Order in Council, bearing Date the Eleventh Day of May One thousand eight hundred and three, and by subsequent Orders continuing the said

T the Court at the Queen's Palace, the 27th prohibit, and command that no Person or Persons of June 1804, whatsoever should at any Time, during the Space of Six Months from the Date of the faid Order, prefume to transport into any Parts out of this King-dom, any Pig-Iron, Bat-Iron, Hemp, Pitch, Tar, Rosin, Turpentine, Anchors, Cables, Cordage, Masts, Yards, Bowsprits, Oars, Oakum, Oker, Sheet-Copper, or other Naval Stores, or ship or lade any of the Articles before-mentioned, on board any Ship or Veffel, in order to transporting the fame to any Parts Leyond the Seas, without Leave or Permission being first had and obtained from His Majesty or His Privy Council: (except for the Purposes and to the Places mentioned in the faid Order:) And whereas it hath been represented on Behalf of the principal Importers and Venders of Bar-Iron in the City of London, that great Loss and Inconvenience will result to the Trade by the Exportation of Bar-Iron continuing to be pro-hibited to Countries in Amity with His Majesty, without special Orders being obtained for that Purpose; His Majesty taking the same into Considera-tion, is pleased, by and with the Advice of His Privy Council, to order, (as it is hereby ordered,) that, from and after the Date hereof, the Exportation of Bar-Iron and Pig-Iron shall, notwithstanding the faid Orders, be permitted and allowed from any of the Ports of this Kingdom to any Country in or out of Europe, in Amity with His Majesty, in British built Ships, owned by His Majesty's Subjects, and navigated according to Law; provided the Merchant Exporter of any such Bar Iron and Pig-Iron do first make Oath of the true Destination of the same to the Places for which such Bar-Iron and Pig-Iron shall be entered Outwards before the Entry of the same shall be made, and do give full and sufficient Security by Bond to the Satisfaction of the Commissioners of His Majelly's Customs to carry the faid Bar-Iron and Pig-Iron to the Places for which they are so entered Outwards, and for the Purposes specified, and none other, and to produce within Twelve Months from the Date of the Bond, from the British Consul or Vice-Consul resident at the Part for which fuch Bar-Iron and Pig-Iron shall be cleared out, or in case there shall be no Consul there refident, or he shall be absent from the same, then from Two British Merchants, resident there, a Cerformer Order from Time to Time, to order, require, I tificate or Certificates that such Bar-Iron and PigIron has been duly delivered at the Ports for which the same was cleared out, and the Bonds or Securities shall not be cancelled or delivered up but on Production of such Certificate or Certificates; and the Right Honorable the Lords Commissioners of His Majesty's Treasury are to give the necessary Directions herein accordingly. TRANSLATION of an Imperial Ukafe, issued by the Emperor of Russia at St. Petersburgh the 7th of May 1804, relative to the Admission of Foreigners into His Imperial Majesty's Dominions.

ist. O enter our Frontiers, all Persons, except in the under-mentioned Cases, are to be provided with Passports from Our Ministers or other Agents refiding in Foreign Countries -Particular Instructions will be fent to Our Ministers and Confuls as to the Manner in which fuch Pafiports are to I Morning until Three in the Afternoon, viz.

be granted, fo as to cause the least Inconvenience to

Trade or general Intercourse.

2d. Persons coming from Cities or Places where We have neither Missions nor Consuls, must produce Passports at the Frontiers from the Governors or Chief Officers there. Passports from Inferior Officers, from Country Justices or Commissioners, or from the Magistrates, will not be acknowledged. The Governors of Our Frontier Provinces will receive Instructions in what Manner they are to communicate with the Governors of Provinces belonging to another Power relative to this Point, and Directions will be given at the Barriers where Pastports are to be acknowledged.

3d. Ruffian Subjects, Traders, and other Persons usually reliding in Russia, having Passports to go Abroad for a limited Term, will be permitted to

return with the fame Paffport.

4th. Persons owing Allegiance to Two Powers (Sujets mixtes) must, from Our Side, he provided with a Passport for a Year from the Regency of that Government in which their Property lies, with which, during that Term, they may pass out and in without Interruption.

5th. All Persons must produce their Passports at the Frontiers; and, if conformable to these Regulations, they will be allowed to pass without Moleliation, except fuch as may be particularly ordered to

be itopped.

6th. These Regulations are to extend to all Sea Ports, in so far as regards Passengers arriving there. Ship-Malters, and Persons serving on board of Ships, are to be admitted upon the former existing Regulations

7th. All these Regulations shall be enforced for the nearer Parts of Europe within Two Months; and for the more distant, namely, Italy, Spain, and Portugal, within Four Months, reckoning from the Date of this Ordinance (Ukafe), which shall be published in the Newspapers of both Our Capitals.

8th. The daily Communications of Persons refiding on the Frontiers will remain on the former

Footing oth. The Intercourse with various Asiatic Nations on the Frontiers of the Cuban, on the Lines of the Caucasus and Orenburg, and also with the Turkish Subjects in general, is to remain on the former Footing.

10th. Paffports will be granted to Persons going

out of the Country as formerly.
