[7HEREAS the Time limited by His Majefty's Order in Council of the Fourth Day of Ja-"V Order in Council of the Fourth Day of Ja-auary laft, prohibiting the transporting into any Parts out of this Kingdom any Pig-Iron, Bar-Iron, Hemp, Pitch, Tar, Rofin, Turpentine, Anchors, Cables, Cordage, Mafts, Yards, Bowsprits, Oars, Oakum, Oker, Sheet-Copper, or other Naval Stores, will expire upon the Eleventh Day of July next: And whereas it is judged expedient for His Majefty's Service, and the Safety of this Kingdom, that the faid Probibition should be con-tinued for fome Time longer. His Majefty doth timued for fome Time longer, His Majefty doth therefore, with the Advice of His Privy Council, hereby order, require, prohibit, and command, that no Perfon or Perfons whofoever do at any Time, for the Space of Six Months from the faid Eleventh Day of July next, prefume to transport into any Parts out of this Kingdom any Pig-Iron, Bar-Iron, Hemp, Pitch, Tar, Rofin, Turpentine, Anchors, Cables, Cordage, Mafts, Yards, Bowsfprits, Qars, Oakum, Oker, Sheet, Conper or other Nami Qars, Oakum, Oker, Sheet-Copper, or other Naval Stores, or do fhip or lade any Pig-Iron, Bar-Iron, Hemp, Pitch, Tar, Rofin, Turpentine, Anchors, Cables, Cordage, Mafts, Yards, Bowfprits, Oars, Okum, Oker, Sheet-Copper, or other Naval Stores, or Ship or lade any of the Articles above-mentioned on board any Ship or Verful in order to mentioned on board any Ship or Veffel, in order to transporting the fame to any Parts beyond the Seas, without Leave or Permission first ibeing had and obtained from His Majesty or His Privy Council, upon Pain of incurring the Forfeitures inflicted by an Act paffed in the Thirty-third Year of His Majefty's Reign, intituled " An AC to enable His Majeity " to reftrain the Exportation of Naval Stores, and " more effectually to prevent the Exportation of "Salt-Petre, Arms, and Ammunition, when pro-"hibited by Proclamation or Order in Council:" But it is neverthelefs His Majefty's Pleafure, that nothing herein contained shall extend, or be conftrued to extend, to any of His Majelty's Ships of War, or any other Ships or Veffels or Boats in the Service of His Majefty, or employed or freighted by I

T the Court at the Queen's Palace, the 27th of June 1804, His Majesty's Board of Ordnance, or by the Com-millioners of His Majesty's Navy; nor to prevent any Ship or Vessel from taking or having on board such Quantities of Naval Stores as may be necelfary for the Ule of fuch Ship or Vessel during the Courle of her intended Voyage, or by Licence from the Lord High Admiral of Great Britain, or the Commiffioners of the Admiralty for the Time being; nor to the Exportation of the faid feveral Articles to Ireland, or to His Majefty's Yards or Garrifons, or to His Majefty's Colonies or Planta-tions in America or the Weft Indies, or to Newfoundland, or to His Majefty's Forts and Settle-ments on the Coaft of Africa, or to the Island of St. Helena, or to the British Settlements or Factories in the East Indies: Provided, that upon the Exportation of any of the faid Articles for the Purpoles of Trade to Ireland, or to His Majefly's Yards and Carrifons, or to His Majefly's Colonies and Plantations in America or the Welt Indies, or to the Island of Newfoundland, or to His Majefty's Forts and Settlements on the Coaft of Africa, or to the Island of St. Helena, or to the British Settlements or Factories in the East Indies, the Exporters of fuch Articles do first make Oath of the true Destination of the same to the Places for which they shall be entered outwards, before the Entry of the fame shall be made, and do give! full and fufficient Security, by Bond, to the Satisfaction of the Commiffioners of His Majefty's Cuftoms, to carry the faid Articles to the Places for which they are fo entered Outwards, and for the Purpofes fpecified, and none other; and iuch Bond shall not be cancelled or delivered up until Proof be made to the Satisfaction of the faid Commiffioners, by the Production, within a Time to be fixed by the faid Commissioners, and specified in the Bond, of a Certificate or Certificates, in fuch Form and Manner as shall be directed by the faid Commistioners, thewing that the faid Articles have been all duly landed at the Places for which they were en-tered Outwards: And the Right Honorable the Lords Commillioners of His Majefty's Treasury, the Commiffioners for executing the Office of Lord High Admiral of Great Britain, and the Lord Warden of the Cinque Ports, are to give the ne-cellary Directions herein as to them may refpec-tively appertain. WHEREAS the Colony of Surinam, in South America, has been furrendered to His Majefty's'Arms, and the Territory and Forts of the fame are delivered up to His Majefty, and the faid Colony is now in His Majefty's Poffeffion; His Majefty is thereupon pleased to order and de-clare, and it is hereby ordered and declared, That all His loving Subjects may lawfully trade to and from the faid Colony of Surinam, fubject, neverthelefs, to the fame Duties, Rules, Regulations, Conditions, Reftrictions, Penalties, and Forfeitures, to which the Trade to and from His Majefty's Colonies, Plantations, and Illands in the West Indies, is or shall be subject by Law: And His Majesty is further pleased to order and declare, and it is hereby ordered and declared, that all Commodities, being of the Growth, Produce, or Manufacture of the faid Colony of Surinam, being in His Majefty's Poffeffion, shall be permitted to be imported into any of the Ports of this Kingdom in British Ships, owned by His Majelty's Subjects, and navigated according to Law, fubject to the fame Duties, Rules, Regulations, Reltrictions, Conditions, Penalties, and Forfeitures, as Articles of the like Sort are fubject to, coming from His Majefty's Colonies, Plantations, or Islands in the Weit Indies : And the Right Honorable the Lords Commiffioners of His Majesty's Treasury, and the Lords Commis-fioners of the Admiralty, are to give the necessary Directions herein as to them may respectively ap-W. THEREAS His Majefty was pleafed by His Order in Council, bearing Date the Eleventh Day of May One thousand eight hundred and three, and by fublequent Orders continuing the faid former Order from Time to Time, to order, require, prohibit, and command that no Perfon or Perfons whatfoever should at any Time, during the Space of Six Months from the Date of the faid Order, pre-fume to transport-into any Parts out of this Kingdom, any Pig-Iron, Bar-Iron, Hemp, Pitch, Tar, Rosin, Turpentine, Anchors, Cables, Cordage, Masts, Yards, Bowsprits, Oars, Oakum, Oker, Sheet-Copper, or other Naval Stores, or ship or lade any of the Articles before-mentioned, on board any Ship or Veffel, in order to transporting the fame to any Parts beyond the Seas, without Leave or Permifition being first had and obtained from His Majesty or His Privy Council : (except for the Purposes and to the Places mentioned in the faid Order :) And whereas it hath been reprefented on Behalf of the principal Importers and Venders of Bar-Iron in the City of London, that great Lois and Inconvenience will refult to the Trade by the Exportation of Bar-Iron continuing to be prohibited to Countries in Amity with His Majefty,

T the Court at the Queen's Palace, the 27th | without fpecial Orders being obtained for that Purpose; His Majefty taking the same into Consideration, is pleased, by and with the Advice of His Privy Council, to order, (as it is hereby ordered,) that, from and after the Date hereof, the Exportation of Bar-Iron and Pig-Iron shall, notwithstanding the faid Orders, be permitted and allowed from any of the Ports of this Kingdom to any Country in or out of Europe, in Amity with His Majefty, in British built Ships, owned by His Majefty's Subjects, and navigated according to Law; provided the Merchant Exporter of any fuch Bar-Iron and Pig-Iron do first make Oath of the true Defination of the fame to the Places for which fuch Bar-Iron and Pig-Iron shall be entered Outwards before the Entry of the fame shall be made, and do give full and fufficient Security by Bond to the Satisfaction of the Commiffioners of His Majefty's Cuftoms to carry the faid Bar-Iron and Pig-Iron to the Places for which they are fo entered Outwards, and for the Purpofes fpecified, and none other, and to produce within Twelve Months from the Date of the Bond, from the British Conful or Vice-Conful refident at the Part for which fuch Bar-Iron and Pig-Iron shall be cleared out, or in cafe there shall be no Conful there refident, or he shall be absent from the fame, then from Two British Merchants, refident there, a Certificate or Certificates that fuch Bar-Iron and Pig-Iron has been duly delivered at the Ports for which the lame was cleared out, and the Bonds or Securities (hall not be cancelled or delivered up but on Production of fuch Certificate or Certificates; and the Right Honorable the Lords Commissioners of His Majefty's Treasury are to give the neceffary Directions herein accordingly.
