By the KING. PROCLAMATION. GEORGE R.

HEREAS alarming Accounts have been re-ceived that the Infections Difease (which, with a Malignancy equalling if not exceeding that of the Plague, has occasioned a dreadful Mortality in feveral Parts of Spain, and in Our Town and Garrison of Gibraltar) has spread and extended itself to Parts of the Coast of the Mediterranean; And whereas, from the Season of the Year in which it has continued its Ravages in those Places where it has already appeared, there is no good Ground of Considence or Hope that the comparative Coldness and the Temperature of this Climate can afford any Obstacle to its Introduction and Progress in Our

And whereas we feel it to be incumbent upon Us to employ such Means as, under the Protection and Favour of Divine Providence, may be best calculated to guard Our loving Subjects against the Visitation of so dreadful a Calamity, We have thought sit, by and with the Advice of Our Privy Council, to issue this Our Royal Proclamation, and We do herein, by and with the Advice of Our faid Council, most Arictly enjoin and command all Our loving Subjects, and more especially those residing at any of the Sea-Port Towns, or in any other Places on the Coasts of this Kingdom, whether they may themselves be liable to Quarantine or otherwise, as they tender the Preservation of their own Lives, and the Safety and Welfare of all the Inhabitants of this Kingdom, most scrupulously to observe all the Laws of Quarantine which now are or may hereafter be in Force, and all Orders made by Us, with the Advice of Our Privy Council, or by Our Privy Council, under the Authority thereof; and particularly most carefully to avoid any Communication with any Ship or Vessel, or with any Person or Persons coming therein, from or through the Mediterranean, or from the West Barbary, on the Atlantic Ocean, or from Cadiz, or other Parts of Spain without the Streights, lying to the Southward of Cape St. Vincent, or from any Place to which, by Our Royal Proclamation, by and with the Advice of Our Privy Council, or by Our Orders in Council, the Laws of Quarantine are, or may hereafter, be extended; or with any Boat or Person

therein, coming from or having been on board any fuch Ship, until fuch Ship, Vessel, or Boat, with the Grews and Persons on board, and the Goods, Wares, and Merchandizes imported therein, shall have performed their Quarantine, in such Places and Manner as are or shall hereafter be directed in that Behalf, and until they respectively shall have been duly discharged therefrom: And We do, surther strictly exhort, enjoin, and command all Magistrates and Persons in Authority, and all others Our loving Subjects, without Loss of Time, to give Informa-tion to Us, through Our Principal Secretary of State for the Home Department, or to Our Privy Council, of any Persons that they may know or believe to have offended against any of the said Laws or Orders; and We do hereby warn all Persons whom it may concern, that We have given the strictest Orders for enforcing, with the utmost Rigour, the most punctual Observance of the Laws of Quarantine, and all the Orders, Rules, and Regulations relating thereto, it being Our few Determine tions relating thereto, it being Our firm Determina-tion, upon ferious Confideration of the great Extent of Milery and Calamity which a fingle Instance of improvidently neglecting any of these Regulations may bring upon Our loving Subjects, to cause the several Penalties which the Law has provided, or may provide, to be inflicted upon all those who may

be guilty of any Offence against the same:
And whereas it is also necessary to take the utmost Precaution to prevent the spreading of Insection, in case the said malignant Disease, or any other of a contagious Nature, (which God, in His Mercy, avert!) should unhappily manifest itself in any Part of Our United Kingdom, notwithstanding the Pre-cautions taken to guard against the Introduction thereof, We have thought sit, by and with the Ad-vice of Our said Council, to take Measures for the Establishment of a Board of Health, to consist of Men able, learned, eminent, and experienced in the Study and Practice of Physic, together with Perfons most capable, from their Knowlege of the Ports of Our Kingdoms, to afford Assistance in the forming of Regulations respectively applicable to the local Circumstances of the said Ports; such Board to be authorized and directed to prepare and digest the best Rules and Regulations for the speedy and effectual Adoption of the most approved Methods of guarding against the Introduction and spreading

of Infection, and for purifying any Ship or House, or any Place in which any contagious Diforder may have manifested itself, and to communicate the same to all Magistrates, Medical Persons, and others of Our loving Subjects, who may be desirous, and may apply to be made acquainted therewith; and We most strictly enjoin and command all Magistrates and Persons in Authority, all Medical Persons, and others Our loving Subjects, especially those within the Maritime Counties, to give immediate Notice to Us, through Our Principal Secretary of State for the Home Department, or Our Privy Council, in case any Person or Persons should be attacked with any Fever, attended with new and uncommon Symptoms, such as to afford Ground for Apprehension that such Fever is of the same Nature as the Disorder prevailing in feveral Parts of Spain, and in Gibraltar, in order that the most immediate and effectual Measures may be taken, as well for affording due and necessary Assistance and Relief to those as-slicted with the same, as for preventing the Conta-gion from spreading amongst Our loving Subjects.

HEREAS by Our Royal Proclamation, bearing Date the Seventh of March One thousand eight hundred and three, We were pleased, amongst other Things, to promise and declare that a Reward. of Twenty Shillings for every Able and Ordinary Seaman, fit to serve on board Our Ships, should be paid to any Person who should discover any Seaman or Seamen who might conceal him or themselves, so that fuch Seaman or Seamen should be taken for Our Service by any of Our Officers employed for railing Men, on or before the Thirteenth Day of April then .next: And whereas the Time limited for the Payment of the faid Reward has been, by several Or-ders in Council, prolonged to the Thirty-sitt Day of December next, inclusive: And whereas We have, by and with the Advice of Our Privy Council, thought it expedient and necessary for the public Service that the faid Reward should be increased, We do hereby promise and declare, by and with the Advice of Our faid Council, that a Reward of Three Pounds for every Able Seaman, and Fifty Shillings for every Ordinary Seamen, fit to ferve on board Our Ships, shall be paid to any Person who fhall discover any such Seaman or Seamen respectively, who may conceal him or themselves, so that fuch Seaman or Seamen shall be taken for Our faid Service by any of Our Sea-Officers employed for raifing Men, on or before the faid Thirty first Day of December next, inclusive; the faid Rewards to be paid for any such Seaman or Seamen respectively, so discovered and taken in and about London, by the Principal Officers and Commissioners of Our Navy,

diately upon a Certificate being produced to the faid Principal Officers and Commissioners of Our Navy, Naval Officers, or Collectors respectively, by the Person who may make Discovery of any Seaman or Seamen as aforesaid, certifying his Name, and the Name or Names, and Number and Quality of Seamen procured in Consequence of his Discovery; the said Certificate to be given by such Officer as may take fuch Seaman or Seamen for Our Service.

A PROCLAMATION,

For granting the Distribution of Prizes during the present Hostilities.

GEORGE R.

HEREAS by Our Order in Council, dated VV the Seventeenth Day of August One thou-fand eight hundred and three, We have ordered that General Reprisals be granted against the Ships, Goods, and Subjects of the Countries styling themselves the Italian and Ligurian Republics; And whereas by Our Order in Council, of the Eleventh Day of this instant January, We have ordered that General Reprisals be granted against the Ships, Goods, and Subjects of the King of Spain, so that as well Our Fleets and Ships, as also all other Ships and Vessels that shall be commissionated by Letters of Marque or General Reprifals, or otherwise, by Our Commissioners for executing Our Office of Lord High Admiral of Great Britain, shall and may lawfully feize all Ships, Veffels, and Goods belonging to the Countries styling themselves the Italian and Ligurian Republics, or the King of Spain, or any Persons being Subjects of the Countries styling themselves the Italian and Ligurian Republics, or the King of Spain, or inhabiting within any of the Territories of the Countries styling themselves the Italian and Ligurian Republics, or the King of Spain, and bring the same to Judgment in any of Our Courts of Admiralty within Our Dominions, duly authorised and required to take Cognizance thereof; We, being desirous to give due Encouragement to all Our faithful Subjects who shall lawfully feize the same, and having declared in Council Our Intentions concerning the Distribution of all Mauner of Captures, Seizures, Prizes, and Reprifals of all Ships and Goods during these Hostilities, do now make known to all Our loving Subjects, and all others whom it may concern, by this Our Proclamation, by and with the Advice and Confent of Our Privy Council, that Our Will and Pleasure is, that the neat Produce of all Prizes taken, the Right whereof is inherent in Us and Our Crown, be given to the Takers, (fave and except the Produce of such Prizes as are or shall be taken by Ships or Vessels belonging to, or hired by, or in the Service of, Our Commissioners of Customs or Excise, the Disposition and at the Out-Ports, by the Naval Officers (where there are no Naval Officers) by the Collectors of Our Customs, immediately the Customs of Our Customs of Our

toms and Duties as the same are now or would have been liable to if the fame were or might have been imported as Merchandize; and that the same may be so given in the Proportion and Manner hereinaster : fet forth; that is to fay,

That all Prizes taken by Ships and Veffels having Commissions of Letters of Marque and Reprisals (fave and except such Prizes as are or shall be taken by the Ships or Vessels belonging to, or hired by, or in the Service of, Our Commissioners aforesaid), may be fold and disposed of by the Merchants, Owners, Fitters, and others, to whom fuch Letters of Marque and Reprilals are granted, for their own Use and Benefit, after final Adjudication, and not before:

And We do hereby further order and direct, that the Neat Produce of all Prizes which are or Thall be taken by any of Our Ships or Veffels of War, (fave and except when they shall be acting on any conjunct Expedition with Our Army, in which Case We reserve to Ourselves the Division and Distribution of all Prize and Booty taken; and also save and except as hereinaster-mentioned,) shall be for the entire Benesit and Encouragement of Our Flag-Officers, Captains, Commanders, and other Commissioned Officers in Our Pay, and of the Seamen, Marines, and Soldiers on board Our faid Ships and Veffels at the Time of the Capture; and that such Prizes may be lawfully sold and disposed of by them and their Agents after the same shall have been to Us finally adjudged lawful Prize, and not otherwife.

The Distribution shall be made as follows :-Whole of the Neat Produce being first divided into

Eight equal Parts,

The Captain or Captains of any of Our faid Ships or Veffels of War, who shall be actually on board at the Taking of any Prize, shall have Three Eighth Parts; but in case any such Prize shall be taken by any of Our Ships or Vessels of War, under the Command of a Flag or Flags, the Flag Officer or Officers being actually on board, or directing and affifting in the Capture, shall have One of the Three Eighth Parts; the said One Eighth Part to be paid to fuch Flag or Flag Officers in such Proportions, and subject to such Regulations, as are hereinafter-mentioned:

The Captains of Marines and Land Forces, Sea Licutenants, and Master, on board, shall have One ·Eighth Part, to be equally divided amongst them; but that every Physician appointed, or hereafter to be appointed, to a Fleet or Squadron of Our · Ships of War, shall, in the Distribution of Prizes which shall hereafter be taken by the Ships in which he shall serve, or in which such Ship's *Company shall be entitled to share, be classed with the Sea Lieutenants with respect to the said One Eighth Part, and be allowed to share equally with them, provided such Physician be actually on board at the Time of Taking such Prizes. The Lieutenants and Quarter-Masters of Marines, and Lieutenants, Enligns, and Quarter Masters of Land Forces; Secretaries of Admirals or of Com-modores, with Captains under them, Second Masters of Line of Battle Ships, Boatswains, Gunners, Purfers, Carpenters, Master's-Mates, Chirur-

One Eighth Part, to be equally divided amongst The Midshipmen, Captains' Clerks, Master Sailmakers, Carpenters' Mates, Boatswains'-Mates, Gunners' Mates, Masters at Arms, Corporals, Yeomen of the Sheets, Coxswains, Quarter-Masters, Quarter-Masters'-Mates, Chirurgeons'-Mates, Yeomen of the Powder Room, Serjeants of Marines and Land Forces, on board, shall have One Eighth Part, to be equally divided amongst them: The Trumpeters, Quarter-Gunners, Car-penters'-Crew, Stewards, Cook, Armourers, Stewards'-Mates, Cook's-Mates, tounsmiths, Coopers, Swabbers, Ordinary Trumpeters, Barbers, Able Seamen, Ordinary Seamen, and Marines and other Soldiers, and all other Persons doing Duty, and affilting on board, shall have Two Eighth Parts, to be equally divided amongst them:-And We do hereby further order, that, in the Case of Cutters, Schooners, Brigs, and other Armed Vessels, commanded by Lieutenants, the Share of such Lieutenants shall be Three Eighth Parts of the Prize, unless such Lieutenants shall be under the Command of a Flag Officer or Officers, in which Case the Flag-Officer or Officers shall have One of the said Three Eighths, to be divided amongst such Flag-Officer or Officers in the same Manner herein-directed in the Case of Captains ferving under Flag-Officers. Secondly, We direct that the Share of the Sub-Lieutenant, Secondly. Master, and Pilot, shall be One Eighth; the said Eighth, if there be all Three such Persons on board, to be divided into Four Parts, Two Parts to be taken by the Sub-Lieutenant, One Part by the Master, and One Part by the Pilot; if there be only Two such Persons on board, then the Eighth to be divided into Three Parts, of which Two Thirds shall go to the Person Second in Command, and One Third to the other Person, if there be only a Sub-Lieutenant, or a Master, and no Pilot, then the Sub-Lieutenant or Master to take the whole Eighth: -That the Share of the Chirurgeon, or Chirurgeon's-Mate, (where there is no Chirurgeon,) Midshipmen, Clerk, and Steward, shall be One Eighth: That the Share of the Boatswain's, Gunner's, and Carpenter's-Mates, Yeoman of the Sheets, Sailmaker, Quarter-Master, and Quarter-Master's-Mate, shall be One Eighth; and the Share of the Seamen, Marines, and other Persons on board, assisting in the Capture, shall be Two Eighth Parts.

But it is Our Intention, nevertheless, That the above Distribution shall only extend to such Captures as shall be made by any Cutter, Schooner, Brig, or Armed Vessel, without any of Our Ships or Vessels of War being present, or within Sight of and adding to the Encouragement of the Captors, and Terror of the Enemy; but in case any of Our Ships or Vessels of War shall be present, or in Sight, that then the Officers, Pilots, Petty Officers, and Men, on board fuch Cutters, Schooners, Brigs, or Armed Vessels, shall share in the same Proportions as is allowed to Persons of the like Rank and Denomination on board of Our Ships and Vessels of War; the Sub-Lieutenant and Master to be confidered as Warrant Officers; and such Cutters, Schooners, Brigs, or Armed Vessels shall not, in respect to such Captures, convey any Interest or Share geons, Pilots, and Chaplains, on board, shall have I in the Flag Eighth to the Flag Officer or Officers

under whose Orders such Cutters, Schooners, Brigs, and Armed Vessels may happen to be; and We surther order, that the Directions herein given with respect to the Shares of the Sub-Lieurenants, Masters, and Pilots on board Vessels commanded by Lieutenants, be applied to Captures made from

France and the Batavian Republic:

And whereas it is judged expedient, during the prefent Hostilities, to hire into Our Service Armed Vessels, to be employed as Cruizers against the Enemy, which Vessels are the Property of, and their Masters and Crews are paid by, the Merchants of whom they are hired, although several of them are commanded by Our Commissioned Officers, in Our Pay, it is Our further Will and Pleasure, that the Neat Produce of all Prizes taken by such Hired Armed Vessels (except as hereinaster-mentioned) shall be for the Benefit of Our Commissioned Officers in Our Pay, and of the Masters and Crews on board the said Hired Armed Vessels at the Time of the Capture; and that such Prizes may be lawfully sold and disposed of by them and their Agents, after the same shall have been to Us snally adjudged lawful Prize, and not otherwise; the Distribution whereof shall be as follows:

The Whole of the Neat Produce being divided into Eight equal Parts, Our Officer commanding any Hired Armed Vessel, who shall be actually on board at the Taking of any Prize, shall have Three Eighths; but in case such Hired Armed Vessel shall be under the Command of a Flag or Flags, the Flag-Officer or Officers being actually on board, or directing or affifting in the Capture, shall have One of the said Three Eighth Parts; the faid One Eighth Part to be paid to fuch Flag or Flag-Officers, in fuch Proportions, and subject to such Regulations, as are hereinaster mentioned: In case there be acting on board such Hired Armed Veffels, besides Our Officer commanding the fame, One or more of Our Commissioned Sea Lieutenants in Our Pay, such Lieutenant or Lieutenants shall take Oue Eighth. One Eighth shall belong to the Master and Mate, of which the Master shall take Two Thirds, and the Mate One Third; but in case there shall be acting on board fuch Hired Armed Veffel One or more Midshipmen, or other Person in Our Pay, of those who are classed with Midshipmen in the former Part of this Our Proclamation, in that Case the Master shall take One Half of the Eighth, and the other Half shall be equally divided between the Mate, Midshipmen, and such other Persons in Our Pay. Three Eighths shall belong to and be divided among the other Officers, and the rest of the Crew. And in the Case of Prizes taken by any Hired Armed Vessel, not commanded by any of Our Commissioned Officers, One Eighth shall belong to the Flag-Officers, to be divided as aforefaid, in case such Hired Armed and the Command of a Flag. Two Eighths shall belong to the Master and Mate, of which the Master shall take Two Thirds, and the Mate One Third. Three Eighths shall belong to and be divided among the other Officers and the rest of the Command of the Command of the Command of the Command of the Surplus, are in directed, the Crew, in Manner aforesaid. The Surplus, the Distribution of which is not herein directed, shall remain at Our Disposal; and if not disposed of within a Year after final Adjudication, the fame shall belong and be paid to Greenwich Hospital. And in the Case of Prizes taken jointly by any of Our Ships of War, and any Hired Armed Vessel, Our Commissioned Officer or Officers on board such Hired Armed Vessel shall share with Our Commissioned Officer or Officers of the same Rank on board our Ship or Ships of War, being joint Captors; the Master of such Hired Armed Vessel shall share with the Warrant Officers; the Mate of fuch Hired Armed Vessel with the Petty Officers; and the Seamen of Such Hired Armed Vessel with the Seamen on board Our faid Ship or Ships of War; fave and except that, in case such Hired Armed Vessel shall be commanded by One of Our Commissioned Officers, having the Rank of Master and Commander, and there shall be none of Our Lieutenants on board, or in case such Hired Armed Vessel shall be commanded by the Master, in both those Cases, the Master of such Hired Armed Vessel shall share with the Lieutenants of Our Ships of War, and the Mate with the Warrant Officers. And in case any Difficulty should arise in respect to the faid Distribution, not herein sufficiently provided for, the same shall be referred to Our Lords Commissioners of the Admiralty, whose Direction thereupon shall be final, and have the same Force and Effect as if herein inserted.

Provided that if any Officer, being on board any of Our Ships of War at the Time of Taking any Prize, shall have more Commissions or Offices than one, such Officer shall be entitled only to the Share or Shares of the Prizes which, according to the abovementioned Distribution, shall belong to the superior Commission or Office:—Provided also, that in all Prizes taken by any of Our Squadrons, Ships, or Vessels, while acting in Conjunction with any Squadron, Ship, or Vessels, while acting in Conjunction with any Squadron, Ship, or Vessels be at Our surther Disposal, equal to that Share which the Flag, and other Officers and Crews of such Squadron, Ships, or Vessels would have been entitled to if they had be.

longed to Us.

And We do hereby strictly enjoin all Commanders of Our Ships and Veffels of War, taking any Prize, to transmit as soon as may be, or cause to be transmitted, to the Commissioners of Our Navy, a true List of the Names of all the Officers, Seamen, Marines, Soldiers, and others, who were actually on board Our Ships or Vessels of War under their Command at the Time of the Capture; which Lift shall contain the Quality of the Service of each Person on board, together with the Description of the Men, taken from the Description-Books of the capturing Ship or Ships, and their feveral Ratings, and be fubscribed by the Captain or Commanding Officer, and Three or more of the Chief Officers on board. And We do hereby require and direct the Commissioners of Our Navy, or any Three or more of them, to examine, or cause to be examined, such Lists by the Muster-Books of such Ships and Vessels of War, and Lists annexed thereto, to see that such Lists do agree with the said Master-Books and annexed Lists as to the Names, Qualities, or Ratings of the Officers, Seamen, Marines, Soldiers, and others, belonging to such Ships and Vessels of War; and, upon Request, forthwith to grant a Certificate of the



Truth of any List transmitted to them to the Agents nominated and appointed by the Captors to take Care and difpose of such Prize; and also, upon Application to them the said Commissioners, they, shall give, or cause to be given, to the said Agents all such Lists from the Muster-Books of any such Ships of War and annexed Lists, as the said Agents shall find requisite for their Direction in paying the Produce of such Prizes, and otherwise shall be aiding and affifting to the faid Agents in all Iuch Mat-ters as shall be necessary. We do hereby further will and direct, that the following Regulations shall be observed concerning the One Eighth Part hereinbefore-mentioned to be granted to the Flag or Flag-Officers who shall actually be on board at the Taking of any Prize, or shall be directing or assisting therein: First, That a Captain of a Ship shall be deemed to be under the Command of a Flag when he shall actually have received some Order directly from, or be acting in Execution of some Order issued by, a Flag-Officer, and shall be deemed to continue under the Command of fuch Flag fo long as the Flag-Officer, by whom the Order was iffued, or any other Flag Officer acting upon the same Station, shall continue upon such Station; or until such Captain shall have received some Order directly from, or be acting in Execution of some Order issued by, some other Flag-Officer, or the Lords Commissioners of the Admiralty. Secondly, That a Flag-Officer Commander in Chief, when there is but One Flag-Officer upon Service, shall have to his own Use the said One Eighth Part of the Prizes taken by Ships and Vessels under his Command. Thirdly, That a Flag-Officer fent to command on any Station shall have no Right to any Share of Prizes taken by Ships or Vessels employed there before he arrives within the Limits of fuch Station, and actually takes upon him the Command, by communicating Orders to the Flag Officer previously in Command, fave only that he shall be entitled to a Share of Prizes taken by those particular Ships to which he shall actually have given some Order, and taken under his Command, within the Limits of such Station. Fourthly, That a Commander in Chief, or other Flag-Officer, appointed or belonging to any Station, and passing through or into any other Station, shall not be entitled to share in any Prize out of the Limits of the Station to which he is appointed or belongs, by any Ship or Vessel under the Command of a Flag-Officer of any other Station, or under Admiralty Orders, unless such Commander in Chief or Flag-Officer is expressly authorised by the Lords Commissioners of the Admiralty to take upon him the Command on that Station in which the Prize is taken, and shall actually have taken upon him such Command, in Manner af refaid. Fifthly, That when an inferior Flag-Officer is fent to reinforce a superior Flag-Officer on any Station, the Superior Flag Officer shall have no Right to any Share of Prizes taken by the inferior Flag-Officer before the inferior Flag-Officer shall arrive within the Limits of the Station; and, moreover, shall actually receive some Order directly from him, or be acting in Execution of some Or-der issued by him. Sixthly, That a chief Flag-Officer quitting a Station, either to return Home, or to allume another Command, or otherwife, except upon some particular urgent Service, with the Intention of returning to the Station as foon as fuch Service is performed, shall have no Share of Prizes

taken by the Ships or Vessels lest behind, after he shall have passed the Limits of the Station, or after he shall have surrendered the Command to another Flag-Officer appointed by the Admiralty to be Commander in Chief upon such Station. Seventhly, That an inferior Flag-Officer quitting a Station, except when detached by Orders from his Commander in Chief, out of the Limits thereof, upon a special Service, with Orders to return to such Station as foon as fuch Service is performed, shall have no Share in Prizes taken by the Ships and Vessels a remaining on the Station, after he shall have passed the Limits thereof; and in like Manner the Flag-Officers remaining on the Station shall have no Share of the Prizes taken by such inferior Flag-Officer, or by the Ships and Vessels under his immediate Command, after he shall have quitted the Limits of his Station, except when detached as aforesaid. Eighthly, That when Vessels, under the Command of a Flag, which belong to separate Stations, shall happen to be Joint Captors, the Captain of each Ship shall pay One Third of the Share to which he is, entitled to the Flag-Officers of the Station to which he belongs. But the Captains of Vessels under Admiralty Orders, being Joint Captors with other Vessels, under a Flag, shall retain the Whole of their Share. Ninthly, That if a Flag-Officer is sent to command in the Out-Ports of this Kingdom, he shall have no Share of the Prizes taken by Ships or Vessels which have failed, or shall fail from that Port by Order from the Admiralty.
