PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS by an Act, passed in the present Session of Parliament, intituled "An Act for continuing several Laws relating to the permitting the Warehousing of Spirits in Ireland for "Exportation, for charging a Duty on the same when taken out for Home Consumption, and for " regulating the Exportation to Great Britain of Spirits not warehoused, until the Twenty-ninth Day of September, One thousand eight hundred and five; to the prohibiting the Exportation from, and permitting the Importation to, Great Britain, of Corn, and for allowing the Importa-"tion of other Articles of Provision, without Payment of Duty; and to the prohibiting the Exother Provisions; and to the permitting the Importation into Ireland of Corn, Fish, and Provi-" fions without Payment of Duty, until the Twenty-"fifth Day of March One thousand eight hundred and fix;" it is, among other Things, enacted, That an Act, made in the Thirty-ninth Year of His present Majesty, intituled An Act for enabling His Majesty to prohibit the Exportation and permit the Importation of Corn, and for allowing the Importation of other Articles of Provision without Payment of Duty, to continue in Force until Six Weeks after the Commencement of the next Seffion of Parliament; which was continued by an A& of the Thirty-ninth and Fortieth Years of His present Majesty, and amended and further continued by feveral subsequent Acts, until the Twenty-fifth Day of March, One thousand eight hundred and five, shall be, and the same is thereby, further continued until the Twenty-fifth Day of March, One thoufand eight hundred and fix, His Majesty, in virtue of the Powers vested in Him by the said Acts, is pleased, with the Advice of His Privy Council, to allow, and doth hereby allow, for and during the Space of Six Months, to commence from the Date of this His Majesty's Order in Council, the Importation into any Port or Place of Great Britain of any Beans called Kidney or French Beans, Tares, Lentiles, Calavancies, and all other Sorts of Pulse; and also of Bulls, Cows, Oxen, Calves, Sheep, Lambs, and Swine; and of Beef, Pork, Mutton, Veal, and Lamb (except salted Beef and Pork); and of Bacon, Hams, Tongues, Butter, Cheese, Potatoes, Sago, Sago-Powder, Tapioca, Vermicelli, Millet-Seed, Poultry, Fowls, Eggs, Game, and Sour Crout, in any British Ship or Vessel, or in any other Ship or Vessel, belonging to Persons of any Kingdom or State in Amity with His Majesty, and navigated in any Manner whatever, without Payment of any Duty whatsoever; provided that a due Entry shall be made of all such Articles as aforesaid, that shall be so imported, with the proper Officers of the Customs at the Port where the same shall be imported, under the Penalties and Forseitures mentioned and referred to in the said above-recited Act, passed in the Thirty-ninth Year of His present Majesty:—And the Right Honorable the Lords Commissioners of His Majesty Treasury are to give the necessary Directions herein accordingly.

As several Artificers and Manusaturers, Subjects of Great Britain, have, from Time to Time, gone into Foreign Countries to exercise their several Callings, contrary to the Laws of these Kingdoms, the following Abstracts of Acts of Parliament of Their late Majessies King George the First and Second, and of His present Majessy, for preventing such Practices, are published, for the Information of all Persons who may be ignorant of the Penalties they may incur by Disobedience to them: And it will be observed, that such Penalties likewise extend to those who are any ways concerned or instrumental in the Sending or Enticing Artificers or Manufacturers out of these Kingdoms, or in the Exportation of the Tools and Instruments used by them, as well as to the Artificers or Manufacturers themselves.

Statute 5 George I. Chap. 27.

IF any Person shall contract with, entice, or solicit, any Artificer in Wool, Iron, Steel, Brass, or other Metal, Clock-maker, Watch-maker, or any other Artificer of Great Britain, to go into Foreign Countries out of the King's Dominions, and shall he convicted thereof, upon Indictment or Informa-tion in any of the Courts at Westminster, or at the Affizes or Quarter Sessions, he shall be fined any Sum not exceeding ONE HUNDRED POUNDS for the first Offence, and shall be imprisoned Three Months, and till the Fine be paid. And if any Perfon having been once convicted shall offend again, he shall be fined at the Discretion of the Court, and imprisoned Twelve Months, and till the Fine be paid.
If any of the King's Subjects, being such Arti-

It any of the King's Subjects, being lice Artificers, shall go into any Country out of His Majesty's Dominions, to exercise or teach the said Trades to Foreigners; and if any of the King's Subjects in any such Foreign Country, exercising any of the said Trades, shall not return into this Realm within Six Months after Warning given by the Ambassador. Minister, or Consul of Great Britannia. the Ambassador, Minister, or Consul of Great Britain, in the Country where such Artificers shall be, or by any Person authorised by such Ambassador, &c. or by one of the Secretaries of State, and from 'henceforth inhabit within this Realm; such Persons shall be incapable of taking any Legacy, or of being an Executor or Administrator, or of taking any Lands, &c. within this Kingdom, by Descent, Devise, or Purchase, and shall forfeit all Lands, Goods, &c. within this Kingdom, to His Majesty's Use, and shall be deemed Alien, and out of His Majesty's Protection.

Upon Complaint made, upon Oath, before any Justice of Peace, that any Person is endeavouring to seduce any such Artificer, or that any such Artificer hath contracted or is preparing to go out of His Majesty's Dominions, for the Purposes aforefaid, such Justice may send his Warrant to bring the Person complained of before him, or before some other Justice; and if it shall appear by the Oath of One Witness, or by Confession, that he was guilty of any of the faid Offences, such Justice may bind him to appear at the next Affizes or Quarter Seffions: And if such Person shall refuse to give Security, the Justice may commit him to Gaol till the next Affizes or Quarter Schlions, and until he shall be delivered by due Course of Law. And if any fuch Artificer shall be convicted, upon Indictment, of any fuch Promise, Contract, or Preparation to go

beyond the Seas, for the Purpole aforelaid, he shall give fuch Security to the King not to depart out of His Majesty's Dominions, as such Court shall think reasonable, and shall be imprisoned till Security

If any of the above Offences shall be committed in Scotland, the same shall be prosecuted in the Court of Justiciary or the Circuits there.

Statute 23 George II. Chap. 13. IF any Person shall contract with, or endeavour to feduce any Artificer in Wool, Mohair, Cotton, or Silk, or in Iron, Steel, Brass, or other Metal, or any Clock-maker, Watch-maker, or any other Artificer in any other of the Manufactures of Great Britain or Ireland, to go out of this Kingdom or Ireland into any Foreign Country not within the Dominions of the Crown of Great Britain, and shall be convicted, upon Indictment or Information, in the Kings Bench at Westminster, or by Indictment at the Assizes or General Gaol Delivery for the County, &c. wherein such Offence shall be committed in Eng. land, or by Indictment in the Court of Justiciary or any of the Circuit Courts in Scotland, or by Indictment or Information in the King's Bench at Dublin, if fuch Offence be committed in Ireland; the Person so convicted shall, for every Artificer contracted with or seduced, forseit FIVE HUNDRED POUNDS, and shall suffer Impriforment in the Common Gaol of the County or Stewartry wherein fuch Offender shall be convicted for Twelve Calendar Months, and until Forfeiture be paid: And in case of a subsequent Offence of the fame Kind, the Persons so again offending shall forseit, for every Person contracted with or seduced, ONE THOUSAND POUNDS, and shall suffer Imprisonment in the Common Gaol of the County or Stewartry wherein fuch Offender shall be convicted, for Two Years, and until such Forfeiture be paid.

If any Person in Great Britain or Ireland shall put on board any Ship or Boat, not bound directly to some Port in Great Britain or Ireland, or to some other of the Dominions of the Crown of Great Britain, any such Tools or Utenfils as are commonly uied in, or proper for the Preparing, Working up, or Finishing of the Woollen or Silk Manufactures, or any Part of such Tools, he shall, for every Offence, forfeit all such Tools, or Parts thereof, put on board, and TWO HUNDRED POUNDS, to be recovered by Action of Debt, &c. in any Court of Record at Westminster, or in the Court of Sefsion in Scotland, or at any of the Four Courts in Dublin respectively, wherein no Essoin, &c. shall be,

It shall be lawful for any Officer of the Customs in Great Britain, or for any Officer of the Revenue in Ireland, to seize and secure, in some of His Majesty's Warehouses, all such Tools or Utensils prohibited to be exported, as fuch Officer shall find on board any Vessel not bound directly to some Port in Great Britain or Ireland, or to some other of the Dominions of the Crown of Great Britain; and all Tools fo seized shall, after Condemnation, be publicly fold to the best Bidder; and one Moiety of the Produce shall be to the Use of His Majesty, and the other Moiety to the Officer who shall seize and fecure the fame.

If the Captain of any Vessel in Great Britain or Ireland knowingly permit any of the said Tools, prohibited to be exported, to be put on board his Vessel, he shall, for every such Ossence, forseit ONE HUNDRED POUNDS, to be recovered as the Penalties insticted upon Persons exporting the Tools; and, if the Vessel belongs to His Majesty, the Captain shall not only forseit ONE HUNDRED POUNDS, but shall also forseit his Employment, and be incapable of any Employment under His Majesty.

If any Officer of the Customs in Great Britain or of the Revenue in Ireland, take, or knowingly suffer to be taken, any Entry outward, or fign any Cocket or Sufferance for the Shipping or Exporting of any of the said Tools, or knowingly suffer the same to be done, he shall forfeit ONE HUNDRED POUNDS, to be recovered as aforesaid, and also forfeit his Office, and be incapable of any Office

under His Majesty.

One Moiety of the Forfeitures shall be applied to the Use of His Majesty, and the other Moiety to the Use of the Person who shall sue for the

BY these Statutes the like Penalties and Forfeitures as above-mentioned are extended to Persons packing or putting on board any Vessel, not bound directly for some Port in Great Britain or Ireland, any Machine, Engine, Tool, Press, Paper, Utensil, or Implement whatsover, used in or proper for the working or finishing of the Cotton, Steel, or Iron Manusactures of this Kingdom, or any Part or Parts of such Machines or Implements, or any Models or Plans thereof; and all Captains of Ships and other Persons receiving or being in Possession of any such Articles, with an Intent to export the same to Foreign Parts, and all Custom-house Officers suffering an Entry to be made thereof, are respectively liable to the like Penalties as are above-mentioned, in the case of Tools and Utensils used in the Woollen and Silk Manusactures.

third Year of His present Majesty's Reign, intituled "An Act for permitting certain Goods "imported into Great Britain, to be secured in "Warehouses without Payment of Duty:" It is enacted, 'That it should be lawful for the Importer or Importers, Proprietor or Proprietors, Confignee or Configuees of any of the Goods, Wares, or Merchandizes enumerated or described in the Table thereunto annexed, marked (B), and which shall be legally imported and brought into the Port of London, to lodge and secure the same under the Joint Locks of the Crown and the London Dock Company, in any Warehouse or Warehouses erected or to be erected, situate within the Premises belonging to the London Dock Company, without Payment at the Time of the first Entry of such Goods, Wares, and Merchandize, of the Duties of Customs or Excise due on the Importation thereof, subject nevertheless to the Rules, Regulations, and Restrictions therein contained; provided

that no fuch Goods, Wares, or Merchandize should be so lodged, or secured, unless and until such Warehouses or other Works belonging, or to belong thereto, should be so far compleated that, in the Judgment of the Lord High Treasurer, or the Commissioners of His Majesty's Treasury for the Time being, or any Three or more of them, the same shall be sit and proper, in every Respect, for the Reception of such Goods, Wares, and Merchandize, and wherein the same might respectively be safely and securely deposited, and remain under the Regulations and Directions in the faid Act contained; and the faid Lord High Trea-furer, or Commissioners of His Majesty's Treasury foo the Time being, or any Three or more of them, were thereby authorized and empowered, by Writing under his or their Hand, or Hands, to certify and make known his or their Approbation of fuch Warehouses, which Certificate should be published Three Times, at least, in the London Gazette, and in Two or more public Morning Newspapers usually circulated in London. And whereas the Table marked (B), above referred to, is in the Words following win Table (B). lowing; viz. Table (B)
