A PROCLAMATION. GEORGE R.

7 HEREAS Our Parliament flands prorogued W to Thursday the Twenty-eighth Day of this instant November, We, with the Advice of Our Privy Council, do hereby publish and declare, That the faid Parliament shall be further prorogued on the faid Twenty-eighth Day of this inftant November to Tuesday the Seventh Day of January next : And We have given Order to Our Chancellor of that Part of Our United Kingdom called Great Britain, to prepare a Commiffion for proroguing the fame accordingly : And We do further hereby, with the Advice aforefaid, declare Our Royal Will and Pleafure, that the faid Parliament shall, on the faid Sewenth Day of January next, be held, and fit for the Difpatch of diverfe urgent and important Affairs : And the Lords Spiritual and Temporal, and the Knights, Citizens, and Burgeffes, and the Commiffioners for Shires and Burghs of the Houfe of Commons, are hereby required and commanded to give their Attendance accordingly at Westminster on the faid Seventh Day of January next.

PROCLAMATION. A

GEORGE R.

W HEREAS by Our Royal Proclamation, bear-ing Date the Sixteenth of May, One thou-fand eight hundred and three, We were pleafed to promise and declare, among other Things, That all Able-bodied Landmen, not above the Age of Thirty-five, nor under the Age of Twenty Years, fit for Our Service, who should, on or before the Thirtieth Day of June then next, voluntarily enter themfelves to ferve in Our Royal Navy, should receive the Sum of Thirty Shillings each Man as Our Royal Bounty:

faid Bounty has been by feveral Orders in Council prolonged to the Thirty-first Day of December next inclusive: And whereas it has been represented to Us that much Advantage would arife to Our Service if the faid Bounty were extended to fuch young Able-bodied Landmen as may hereafter enter themselves to ferve on board Our Flect, upon Proof being exhibited of their being not less than Eighteen Years of Age, instead of Twenty Years; We do hereby promife and declare, by and with the Advice of Our Privy Council, that all Able-bodied Land-men so entering themselves to serve in Our Royal Navy, on or before the faid Thirty-first Day of De. Navy, on or before the laid Thirty-hirlt Day of De-cember next, inclusive, shall be entitled to receive Our faid Bounty of Thirty Shillings each Man, upon Proof being exhibited that fuch Able-bodied Landmen are not above the Age of Thirty-five, nor under the Age of Eighteen Years: And whereas, by Our Royal Proclamation, bearing Date the Sixth of February last, We were pleafed to promise and declare, that, instead of the Reward theretofore paid for the Difference of every Able and Ordinary San for the Difcovery of every Able and Ordinary Sea-man fit to ferve on board Our Ships, and who might conceal him or themfelves, a Reward of Three Pounds for every Able Seaman, and Fifty Shillings for every Ordinary Seaman, fit to ferve on board Our Ships, should be paid in Manner directed by Our faid Proclamation to any Perlou who fhould difcover fuch Seaman or Seamen refpectively, who might conceal him or themfclves, fo that fuch Seaman or Seamen should be taken for Our Service by any of Our Sea Officers employed for railing Men on or before the Thirty first Day of December next : And whereas it hath been reprefented to Us that Advantage would arile to Our Service if fome Eucouragement were also given to luch Perfon or Perfons as may be disposed to procure Men for the Service of Our Fleet, We do hereby further promise and declare, by and with the Advice of Our Privy Council, that a Reward of Four Guineas for every Able Seaman, Three Guineas for every Ordinary Seaman, and Two Guineas and a Half for every Landman, shall be paid to any Person or Persons. who may, on or before the Thirty-first Day of December next, inclusive, procure the voluntary Service of, and convey, such Able Seaman, Ordinary Sea-man, or Landman, fit for Our Naval Service, on And whereas the Time limited for Payment of the board any of Our Ships or Veffels, or to any of Our Sea-Officers employed in raifing Men; together with an Allowance, at the Rate of One Penny per Mile, for each Aole Seaman, Ordinary Seaman, and Landman, for every Mile fuch Man may respectively travel to the nearest of Our Ships of War, or nearest Place of Refidence of any of Our Sea-Officers employed in raifing Men (provided fuch Man shall be found fit for Our Service, and there shall not be Reafon to suppose that he is an Apprentice); the faid Rewards and Travelling Allowance to be paid for any fuch Able Seaman or Seamen, Ordinary Seaman or Landman refpectively, fo procured and taken in and about London, by the Principal Offi-cers and Commiffioners of Qur Navy; and at the Out Ports, by the Naval Officers (where there are any), and (where there are no Naval Officers) by the Collector of Our Cuitoms, immediately upon a Certificate being produced to the faid Principal Of-ticers and Commiffioners of Our Navy, Naval Officers, or Collectors of Our Cultoms respectively, by the Perfon who may procure the voluntary Service of any Able Seaman, Ordinary Seaman, or Land-man as aforelaid, certifying his Name, and the Name or Names, and Numbers and Quality, of Seamen and Landmen fo procured; the faid Certificate to be given by fuch Officer as may take Charge of fuch Seaman or Landman for Our Service.

HEREAS the Time limited by His Ma-jefty's Order in Council of the Thirtieth Day of May laft, for prohibiting the Exportation out of this Kingdom, or carrying Coaftwile, Gunpowder or Salt-Petre, or any Sort of Arms or Ammunition, will expire upon the Sixth Day of December next: And whereas it is judged expedient for His Majefty's Service, and the Safety of this Kingdom, that the faid Prohibition fhould be continued for fome Time longer, His Majcíty doth therefore, by and with the Advice of His Privy Council, hereby order, require, prohibit, and command, that no Perion or Perfons whatfoever, (except the Mafter General of the Ordnance for His Majefty's Service,) do at any Time, during the Space of Six Months, to commence from the faid Sixth Day of December next, prefume to transport into any Parts out of this Kingdom, or carry Coastwife, any Gunpowder or Salt+Petre, or any Sort of Arms or Aminunition, or ship or lade any Gunpowder or Salt-Petre, or any Sort of Arms or Ammunition, on board any Ship or Veffel in order to transporting the same into any Parts beyond the .Seas, or carrying the fame Coaftwife, without Leave or Permission in that Behalf first obtained from His Majefty or His Privy Council, upon Pain of incurring and fuffering the refpective Forfeitures and Penalties inflicted by an Act passed in the Twenty-ninth Year of His late Majefty's Reign, intituled "An I Thirtieth Day of this inftant November, the Impor-

VHEREAS by an AA, passed in the laft Session of Parliament, intituled "An AA " for continuing feveral Laws relating to the permitting the Warehoufing of Spirits in Ireland for Exportation, for charging a Duty on the fame when taken out for Home Confumption, and for " "regulating the Exportation to Great Britain of "Spirits not warehoused, until the Twenty-ninth " Day of September, One thousand eight hundred and five; to the prohibiting the Exportation from, and permitting the Importation to, Great Britain, of Corn, and for allowing the Importa-" tion of other Articles of Provision, without Pay-" ment of Duty; and to the prohibiting the Ex-portation from Ireland of Corn or Potatoes, or other Provisions; and to the permitting the Im-portation into Ireland of Corn, Fifh, and Provi-" ٤< tions without Payment of Duty, until the Twenty-" fifth Day of March One thousand eight hundred " and fix;" it is, among other Things, enacted, That an Act, made in the Thirty ninth Year of His prefent Majefly, intituled An Act for enabling His Majefly to prohibit the Exportation and permit the Importation of Corn, and for allowing the Importation of other Articles of Provision without Payment of Duty, to continue in Force until Six Weeks after the Commencement of the next Selfion of Parliament; which was continued by an Act of the Thirty ninth and Fortieth Years of His prefent Majefly, and amended and further continued by feveral fubfequent Acts, until the Twenty-fifth Day of Match, One thoufand eight hundred and five, shall be, and the fame is thereby, further continued until the Twenty-fifth Day of March, One thou-fand eight hundred and fix, His Majesty was pleased, by His Order in Council of the Thirtieth Day of May last, to permit, for the Space of Six Months from the Date of the faid Order, the Importation of fundry Articles of Provisions therein specified, Duty free: And whereas it is judged expedient that the faid Permiffion fhould be continued for fome Time longer; His Majesty is thereupon pleafed, by and with the Advice of His Privy Council, to allow, and doth hereby allow, for and during the Space of Three Months, to commence from the

tation into any Port or Place of Great Britain of any Beans called Kidney or French Beans, Fares, Lentiles, Calavancies, and all other Sorts of Pulle; and alfo of Bulls, Cows, Oxen, Calves, Sheep, Lambs, and Swine; and of Beef, Pork, Mutton, Veal, and Lamb (except falted Beef and Pork); and of Bacon, Hams, Tongues, Butter, Cheefe, Po-tatoes, Sago, Sago-Powder, Tapioca, Vermicelli, Millet-Seed, Poultry, Fowls, Eggs, Game, and Sour Crout, in any British Ship or Vessel, or in any other Ship or Veffel, belonging to Perfons of any Kingdom or State in Amity with His Majefty, and navigated in any Manner whatever, without Payment of any Duty whatfoever; provided that a due Eutry shall be made of all such Articles as aforefaid, that shall be so imported, with the proper Officers of the Cuftoms at the Port where the fame shall be imported, under the Penalties and Forfeitures mentioned and referred to in the faid above-recited Act, paffed in the Thirty-ninth Year of His prefent Majetty :- And the Right Honorable the Lords Com-missioners of His Majetty Treasury are to give the neceffary Directions herein accordingly.



Most Gracious Sovereign,

WE, your Majefty's loyal Subjects, the Lord Provoft, Magistrates, and Council of the City of Edinburgh, defire to approach your Throne with our most cordial Congratulations upon the late glo-rious Victory obtained by your Majesty's Arms over the combined Fleets of France and Spain.



While we behold the combined Navies of France and Spain reduced, by repeated Defeats, to an inconfiderable Force, and their Ships and Sailors dragged in Triumph to our Shores, we participate in those lively Sensations of Joy with which the unrivalled Succels of those gallant Warriors, who fought and conquered in Defence of your Majesty's Throne, of our happy Constitution, and of the Liberties of Europe, have inspired a grateful People. PROCLAMATION for pardoning Deferters from His Majefty's Regular Forces.
