His Majefly's Sloop Port Mahon, Sept. 30, 1805, Trinidad de Cuba N. E. by N. diftant Taventy-fix Leagues. SIR,

HIS Majefty's Sloop Port Makon, under my Command, this Morning croffed upon a Schooner, laying to; but, on our near Approach, made Sail from us. I have the Honor of informing you she was captured after a Chace of Two Hours, and proves His Catholic Majefty's Packet El Galgo, commanded by Lieutenant Ignacio Guofquez, with Thirty Men ; pierced for Fourteen Guns, but only Four Brals Swivels mounted. She is a very fine Veffel, Coppered and Copper-fastened, well found, and fails fait; left Cadiz on the 9th of August, haddelivered Dispatches at Camana, and was bound, with others, to Trinidad de Cuba and Vera Cruz, which were thrown overboard.

SIR, IN confequence of Information I received while on my Station at Honduras, that a Schooner Guarda Colla had taken feveral Veffels trading to that Settlement, and if not captured, was likely to do much more Mifchief; I was determined to detach Mr. James Smith, Second Lieutenant of the Ship I command, with a Party of Men, to fee what could be effected, and I take the Honor to refer you to a Perulal of his Letter to me for an Account of his Succels, which, for Execution and Bravery has been acknowledged to bid fair for Protection and Countenance.

.La Caridad Perfecta is a very fine new Veffel, and in my Opinion, every way fit for His Majefty's Ser-I remain, Sir, &c. vice.

SIR, Mariannie Schooner, Balize, Sept. 4, 1805. BEG Leave to acquaint you, that, in purfuance I of your Orders, I proceeded with the Schooner you placed under my Command to the Southward; and, while cruizing on that Station, and off the Island of Bonacca, received Information from the Caribbean Fishermen, that a Guarda Costa was at Anchor under the Batteries of Truxillo, and that The had lately captured and carried into that Port the Schooner Admiral Duckworth, of Jamaica, with another Veffel, Name unknown, from Honduras; I therefore maturely confidered the incalculable Injury fuch a Veffel might caufe to the Settlement, and conceiving it a Duty incumbent on myfelf to prevent, if poffible, further Depredations, fummoned the People aft, and, on my flating the Cafe to them, they very readily volunteered to make an Attempt to cut her out. Accordingly, on the Evening of the 13th Ultimo, I flood over, under Cover of the Night, for the Harbour of Truxillo, and got well into the Bay without being difcovered, when I manned Two fmall Boats, with Six Men in each, under Charge of Mr. Walker, Boatfwain, in the one, and Mr. Bowler, Midshipman, in the other, with Directions to pull in close along Shore, and examine if our Information was correct, ftanding in, at the fame Time, with the Schooner to cover the Boats, if Occasion required. Shortly after we got in Sight of the Veffel we were in Purfuit of; which was immediately boarded with great Bravery by the Boat's Crew under Charge of Mr. Bowler, (the other, from pulling heavy, not being able to get up,) and, after some Refistance from the People on Deck, they very gallantly got Poffession of her, the Captain and others jumping overboard ;--the Noile this Contest occasioned alarmed the Forts, which opened on us a very heavy Fire. The Cables were then cut, and Sail made, the Forts keeping a continual Fire on us till out of Gun-fhot, which was returned from both Veffels. She proves to be La Caridad Perfecta, Schooner rigged, Copper-bottomed, and pierced for Sixteen Guns, but mounted only with Twelve, and had on board but Fifteen Men, the Remainder of her Complement being on Shore at the Time.

I am happy to add, that in performing this Service no Perfon has been hurt.

His Majefly's Sloop Wolf, at Sea,

SIR, UAuber 20, 1805. HAVE to acquaint you, that Yefterday Evening in confequence of Information I received from the Shore, I gave chafe to Two Sail in the Offing, and foon came up with a Ship, which proved to be an American, captured a few Minutes before by a Spanish Privateer then standing in Shore : I dropt I opening, by Barrowclough, confirmed by James

a Boat to take Poffeffion of her, and flood after the Privateer, but it falling calm shortly after, I difpatched Two Boats in chafe ; they came up with, and boarded her at the very Moment the ftruck on a Reef near the Shore, and about Ten Miles to Leeward of Falmouth; every Effort proved ineffectual to get her off and the went to Pieces foon after. She proved to be La Piecieusa, a new Cutter, out Six Days from St. Jago Cuba, commanded by Galana Garfa, carrying Three fmall Guns and Twenty-three Men, Five of whom made their Efcape in a Canoe previous to her being boarded, had made no other Captures.

RECEIPT DUTY.

His Majefly's Attorney-General verfus William Bell.

Sittings in the Exchequer, after Michaelmas Term, 1805, before the Lord Chief Baron and a fpecial Jury.

R. PLUMER, the Counfel for the Crown, MI stated to the Court and Jury, that this was an Information filed in the Name of His Majefty's At-torney-General, by Order of the Commiffioners of Stamps, against the Defendant William Bell, a Butcher, at Manchester, for having, in the Month of October, 1804, received from a Person of the Name of Barrowclough, a Sheriff's Officer, alfor refiding at Manchefter, the Sum of 111. 158. 6d. the Amount of a Bill delivered for Meat fold to him, and refusing, at the Time the Money was paid, to fign a Receipt for the fame on a proper Stamp, and to pay the Duty thereon, as directed by the Statute of the 43d of the prefent King, Cap. 126 ; which Act, in the 2d Section, directs, that the Stamp Duty on all Receipts shall be paid by the Perfon receiving the Money. And the 5th Section also enacts, that it shall be lawful for any Perion, or any Agent of any Perion, from whom any Sum of Money shall be due or payable, and who shall have paid such Sum of Money, to provide a Piece of Paper, duly flamped according to the Amount of the Sum fo paid, or fome higher Rate of Duty in the faid Act contained, and to demand and require of the Perlon entitled to fuch Sum of Money a Receipt for the fame, and also the Amount of the Duty thereon ; and then it provides, if any Per-fon, to whom any Sum of Money shall have been paid, shall refuse to give fuch Receipt upon Demand thereof, or pay the Amount of the Duty thereof, every fuch Perion shall forfeit and pay for every fuch Offence the Sum of Ten Pounds .- He then obferved that this Act cafts the Obligation upon the Perfon who receives the Money to give a flamped Receipt to the Person paying it, or the Person pay-ing the Money may tender a Receipt Stamp, and may demand of the Perfon to fign it after he has received the Money; and he has a Right alfo to de-mand the Payment of the Amount of the Duty; and if the Perlon receiving the Money does not fign the Receipt, and pay the Duty, he incurs the Penalty.

The Cale was proved agreeable to Mr. Plumer's

Butler, who proved that the Defendant was paid ' 111. 155. 6d. for his Bill, and then alked to fign a Receipt, which was produced by Barrowclough, and to pay the Sum of 4d. which was the Price of the Stamp. The Defendant refufed, and faid he fhould aff: Advice of his Friends, and would fign it imme-diately after. Upon being frequently applied to afterwards, he perfevered in his Refufal to tign the Receipt, or pay the 4d.

Mr. Dauncey made a few Observations on Behalf of the Defendant.

When the Lord Chief Baron addreffed the Jury as follows:

I think this is an extremely proper Profecution. I take the Object of it to be to give Publicity to the Law. I entirely agree with what has fallen from the Counfel for the Crown, that the Receipt mult be given immediately upon the Payment of the Money, at the Peril of the Party who refuses it.

By your Verdict I hope, therefore, it will be understood, that the Law must be put in Execution ; and that a Perfon withholds a Receipt at the Time of receiving the Money at his Peril. It is impoffible that to a Butcher (a Man in confiderable Trade I flould fuppole, by having a Bill of 111. 158. 6d. paid by a Cuftomer not of very high Rank), the 2d. fhould be an Object to him. I take it to be an Experiment on the Part of this Man, and perhaps many others, to try whether the Law can be evaded or not. It is not likely he fhould fquabble merely about 4d.; nor is it likely he could have any Doubt about the Terms of the Receipt. It was ex. tremely proper that it should be published to the World, that a Man must give a Receipt upon receiving out Money, and must do it immediately. That I take to be the true Interpretation of the Law in this Cafe. Gentlemen, you can have no Doubt in finding a Verdict for the Crown.

The Jury immediately gave a Verdict for the King. Penalty L 10 Stamp Office, January 13, 1806.
