on Behalf of any Person or Persons being Subjects, or reliding within the Dominions of the King of Prussia, or in the Ports or Places aforesaid, for the Freight of Merchandize laden on board any Ship which is detained under the faid Embargo, or which shall hereafter be brought into any of the Ports of His Majesty's Dominions, but that such Freight-Money shall be forthwith paid into the Registry of the High Court of Admiralty, there to remain until His Majesty's Pleasure shall be further known, or until other Provision shall be made by Law: And whereas it has been represented to His Majesty, that the Goods on board several of the Prof-tian Vessels so detained, or to be detained by the Embargo, are the Property of His Majesty's Subjects, or the Property of Persons not being Subjects of Pruffia.: It is further ordered, that all Goods on board any Vessels detained under the said Emhargo, which were laden in, or coming configned to Ports of the United Kingdom, shall be delivered to the Disposal of the Owners or their Agents, upon Affidavit being made and produced in the High Court of Admiralty, that the faid Goods were not, at the Time of Shipment, nor are now, the Property of Subjects of Prussia, and upon paying the Freight due upon such Goods into the Registry of the faid Court, and upon giving sufficient Bail to abide Adjudication in case any Proceedings should be commenced against the said Goods within Two Months from the Date of fuch Delivery :- And the Right Honorable the Lords Commissioners of His Majesty's Treasury, the Lords Commissioners of the Admiralty, and Lord Warden of the Cinque Ports, and the Judge of the High Court of Admiralty, are to give the necessary Directions herein as to them may respectively appertain.

## PRESENT,

The KING's Most Excellent Majesty in Council. HEREAS by an AA, passed in the present Session of Parliament, intituled " An Act for reviving and continuing feveral Laws of Customs relating to the establishing Courts of Judicature in the Island of Newfoundland; and to the prohibiting the Exportation from, and permitting the Importation to, Great Britain, of Corn, and for allowing the Importation of other Articles of Provision, without Payment of Duty, until the Twenty-sifth Day of March One thousand eight hundred and nine; and for continuing several Laws relating to the granting a Bounty upon certain Species of British and Irish Linens exported from Great Britain, and taking off the Duties on Importation into Great Britain of Foreign Raw Linen Yarns made of Flax, to the granting a Bounty upon the Importation into Great Britain of Hemp, and rough and undressed Flax from His Majesty's Colonies in America, and to the Encouragement of the Greenland Whale Fisheries; and for reviving and continuing feveral Laws relating to the regulating the Prices at which Corn and Grain may be exported from Great Britain to Ireland, and from Ireland to Great Britain; and to the Admission to entry in

Great Britain of Oil and Blubber of Newfoundland taken by His Majesty's Subjects carrying on the Fishery from and residing in the said Island; and for continuing an Act of the Twenty third Year of His present Majesty for the more effectual Encouragement of the Manufactures of Flax and Cotton in Great Britain; and for reviving and continuing feveral Laws relating to the permitting the Importation into Great Britain of Hides and other Articles in Foreign Ships; and to the prohibiting the Exportation from Ireland of Corn or Potators, or other Provisions; and to the permitting the Importation into Ireland of Corn, Fish, and Provifions without Payment of Duty, until the Twentyfifth Day of March One thousand eight hundred and eight; and for reviving and continuing an Act passed in the Parliament of Ireland in the Twenty-fifth Year of His present Majesty, for the Encouragement of the Flaxen and Hempen Manufactures of Ireland, until the Twenty-fifth Day of March One thousand eight hundred and twenty-seven: and for amending and further continuing an A& made in the Seventh Year of His present Majesty for the free Importation into Great Britain of Cochineal and Indigo until the Twenty-fifth Day of March One thousand eight hundred and nine:" It is, amongst other Things, enacted, That an Act, made in the Thirty-ninth Year of His present Majesty, intituled "An Act for enabling His Majesty to prohibit the Exportation and permit the Importation of Corn, and for allowing the Importation of other Articles of Provision without Payment of Duty, to continue in Force until Six Weeks after the Commencement of the next Session of Parliament; which was continued by an Act of the Thirty ninth and Fortieth Years of His present Majesty, and amended and further continued by several subsequent Acts, until the Twenty-fifth Day of March, One thousand eight hundred and fix, shall be, and the same is hereby revived, and further continued until the Twenty-fifth Day of March, One thousand eight hundred and nine, His Majefty in virtue of the Powers vested in Him by the faid Acts, is pleased, by and with the Advice of His Privy Council, to allow, and doth hereby allow for and during the Space of Six Months, to commence from the Date of this Order, the Im-portation into any Port or Place of Great Britain of any Beans called Kidney or French Beans, Tares, Lentiles, Calavancies, and all other Sorts of Pulse; and also of Bulls, Cows, Oxen, Calves, Sheep, Lambs, and Swine; and of Beef, Pork, Mutton, Veal, and Lamb (except falted Beef and Pork); and of Bacon, Hams, Tongues, Butter, Cheefe, Potatoes, Sago, Sago-Powder, Tapioca, Vermicelli, Millet-Seed, Poultry, Fowls, Eggs, Game, and Sour Crout, in any British Ship or Vessel, or in any other Ship or Vessel, belonging to Persons of any Kingdom or State in Amity with His Majesty, and navigated in any Manner whatever, without Payment of any Duty whatsoever; provided that due Entry shall be made of all such Articles as aforesaid, that shall be so imported, with the proper Officers of the Customs at the Port where the same shall be imported, under the Penalties and Forfeitures mentioned and referred to in the faid above-recited Act, passed in the Thirty-ninth Year of His present Majelly :-And the Right Honorable the Lords Com-
