AT the Court at the Queen's Palace, the 14th of May 1806,

PRESENT,

The KING's Most Excellent Majesty in Council. HIS Majesty liaving taken into Consideration the present State of Hamburgh and Oldenburgh, and the Circumstances under which several Vessels belonging to Bremen and Papenburgh, have arrived in the Ports of the United Kingdom, is pleased, by and with the Advice of His Privy Council, to order, and it is hereby ordered, That the Embargo now fubfilting upon all Ships and Veffels belonging to Hamburgh and Oldenburgh, be taken off: And it is hereby further ordered, That the Embargo be also taken off those Vessels belonging to the Towns of Bremen and Papenburgh, which had cleared out for Ports of the United Kingdom previous to the Pruffian Notification, dated Twenty-eighth of March last, whereby British Ships were excluded from the Ports of the Prussian Dominions, and from certain other Ports in the North of Europe; and that the faid Ships and Vessels, with their Cargoes, not being Prussian, or Enemies' Property, be permitted to fail to any Port not blockaded: And the Right Honorable the Lords Commissioners of His Majefty's Treasury; the Lords Commissioners of the Admiralty, the Lord Warden of the Cinque Ports, and the Judge of the High Court of Admiralty, are to give the necessary Directions herein as may

The KING's Most Excellent Majesty in Gouncil.
WHEREAS during the Interval which has elapsed since His Majesty found himself compelled, by the hostile Measures of His Majesty the King of Prussia, to lay an Embargo on the Ships

and Goods belonging to His Subjects, and to Places under His Controul, such hostile Measures have not been discontinued: And whereas the Town of Papenburgh cannot but be confidered as dependent on, and under the absolute Controul of Prussia; His Majesty therefore is pleased, by and with the Advice of His Privy Council, to order, and it is hereby ordered, that General Reprifals be granted against the Ships, Goods, and Subjects of the King of Prussia, and of the Town of Papenburgh, (fave and except any Ships to which His. Majesty's Licence has been granted, or which have been directed to be released from the Embargo,) fo that as well. His Majesty's Fleets and Ships, as also all other Ships and Vessels that shall be commissionated by Letters of Marque or General Reprifals, or otherwise, by His Majesty's Com-. missioners for executing the Office of Lord High Admiral of Great Britain, shall and may lawfully feize all Ships, Vessels, and Goods belonging to the King of Prussia, or His Subjects, or others inhabiting within the Territories of the King of Prussia, or belonging to the Town of Papenburgh, (except as aforefaid,) and bring the fame to Judgment in any of the Courts of Admiralty within His Majesty's Dominions; and to that End, His Majesty's Advocate General, with the Advocate of the Admiralty, are forthwith to prepare the Draft of a Commission, and present the fame to His Majesty at this Board, authoriting the Commissioners for executing the Office of Lord High Admiral, or any Person or Persons by them empowered and appointed, to iffue forth and grant Letters of Marque and Reprifals to any of His Majelly's Subjects, or others, whom the faid Commissioners shall deem fitly qualified in that Behalf, for the apprehending, feizing, and taking the Ships, Veffels, and Goods belonging to Pruffia, and the Vasfals and Subjects of the King of Prussia, or any inhabiting within His Countries, Territories, or Dominions, or belonging to the Town of Pa-

penburgh (except as aforefaid); and that fuch Powers and Clauses be inserted in the said Commission as have been usual, and are according to former Precedents; and His Majelty's Advocate-General, with the Advocate of the Admiralty, are also forthwith to prepare the Drast of a Commission, . ned present the same to His Majesty at this Board, authoriting the faid Commillioners for executing the Office of Lord High Admiral, to will and require the High Court of Admiralty of Great Britain, and the Lieutenant and Judge of the faid Court, His Surrogate or Surrogates, as also the feveral Courts of Admiralty within His Majesty's Dominions, to take Cognizance of, and proceed upon all and all Manner of Captures, Seizures, Prizes, and Reprifals of all Ships and Goods that are, or shall be taken, and to hear and determine the fame, and according to the Court of Admiralty and the Laws of Nations to adjudge and condemn all fuch Ships, Vessels, and Goods as shall belong to Proffia, or the Vaffals and Subjects of the King of Prussia, or to any others inhabiting within any of His Countries, Territories, and Dominions, or as shall belong to the Town of Papenburgh, (except as aforefaid); and that fuch Powers and Clauses be inserted in the said Commission as have been usual, and are according to former Precedents; and they are likewife to prepare and lay before His Majesty at this Board, a Draft of fuch Instructions as may be proper to be sent to the Courts of Admiralty in His Majesty's Foreign Governments and Plantations for their Guidance herein; as also another Draft of Instructions for such Ships as shall be commissionated for the Purposes above-Spencer. mentioned.

Downing-Street, May 16, 1806

HE King has been pleased to cause it to be fignified by the Right Honorable Charles James Fox, His Majesty's Principal Secretary of State for Foreign Affairs, to the Ministers of Friendly and Neutral Powers reliding at this Court, that His Majelly, taking into Confideration the new and extraordinary Means reforted to by the Enemy for the Purpole of distressing the Commerce of His Subjects, Iras thought lit to direct, that the necessary Measures should be taken for the Blockade of the Coast, Rivers, and Ports from the River Elbe to the Port of Breit, both inclusive; and that the said Coast, Rivers, and Ports are, and must be considered as blockaded; But that His Majesty is pleased to declare, that fuch Blockade shall not extend to prevent Neutral Ships and Veffels laden with Goods, not being the

Property of His Majesty's Enemies, and not being contraband of War, from approaching the faid Coasts, and entering into, and failing from the faid Rivers and Ports, (fave and except the Coast, Rivers, and Ports from Oftend to the River Seine, already in a State of strict and rigorous Blockade, and which are to be confidered as fo continued:) Provided the faid Ships and Vellels to approaching and entering (except as aforefaid,) shall not have been laden at any Port belonging to, or in the Possession of any of His Majelty's Enemies, and that the faid Ships and Veffels fo failing from the faid Rivers and Ports, (except as aforefaid,) shall not be destined to any Port belonging to, or in the Possession of any of His Majesty's Enemies, nor have previously broken the Blockade; and that the laid Coast, Rivers, and Ports must be considered as being in a State of Blockade; -and that from this Time all the Measures authorized by the Law of Nations, and the respective Treaties between. His Majesty and the different friendly and Neutral Powers, will be adopted and executed with respect to all Vessels which may attempt to violate the faid Blockade.

By the KING. A PROCLAMATION, GEORGE R.

HEREAS by Our Royal Proclamation, bearing Date the Fourth Day of December One thousand seven hundred and ninety nine, in the Fortieth Year of Our Reign, We thought fit to ordain, declare, and command that certain Pieces of Copper Money therein described, should be current and lawful Money of Our Kingdom of Great Britain, and should pass and be received as current and lawful Money of Our faid Kingdom, in the Manner fet forth in Our faid Proclamation: And we did thereby declare Our Royal Intention to order a further Coinage of Copper from Time to Time as Occasion should require, and as should be found necessary for the Purposes of Circulation: And whereas We have fince thought fit to order a further Coinage of Penny Pieces, Halfpenny Pieces, and Fathings, in the following Proportions; that is to fay, One Hundred and Fifty Tons of Penny Pieces, Four Hundred and Twenty-feven and a Half Tons of Halfpenny Pieces, and Twenty-two, and a Halt Tons of Farthings: And whereas fuch Penny Pieces are coined in the Proportion of Twenty four to the Pound of Copper, Avoirdupoile: and fuch Halfpenny Pieces in the Proportion of Forty-eight to the Found of Copper, Avoirdupoile; and such Farthings in the Proportion of Ninety-fix to the Pound of Copper, Avoirdupoife; the instrinsic Value of such several Pieces, Workmanship and other necessary Charges included, corresponding as nearly as may be with the nominal Value of the fame respectively-every such Piece having on the Obverfe Our Effigies or Portraiture with Our Name or Title, and the Year of Our Lord; and on the Reverse, the Figure of Britannia, represented fitting on a Rock in the Sea, holding a Trident in her

Left Hand, and a Branch of Olive in her Right Hand; all which Penny Pieces, Halfpenny Pieces, and Farthings have been coined by Matthew Boulton, of Soho, near Birmingham, in the County of Warwick, Esquire: We have therefore, with the Advice of Our Privy Council, thought fit to issue this Our Royal Proclamation, and We do hereby ordain, declare, and command that all the faid Pieces of Copper Money last described, which have already been coined and iffued, and which shall hereafter be coined and iffued as aforefaid, shall be current and lawful Money of Our Kingdom of Great Britain, and shall pass and be received as current and lawful Money of Our faid Kingdom; that is to fay, such Penny Pieces as of the Value of One Penny; such Halfpenny Pieces as of the Value of One Halfpenny; and such Farthings as of the Value of One Farthing: Provided that no Person shall be obliged to take more of fuch Penny Pieces in any one Payment than shall be of the Value of One Shilling, after the Rate aforefaid; or to take more of fuch Halfpenny or Farthing Pieces in any one Payment than shall be of the Value of Sixpence, after the Rate aforefaid.

Capy of a Letter from Vice-Admiral Lord Collingwood, Commander in Chief of His Majesty's Ships and Vessels in the Mediterranean, to William Marsden, Efq; dated on board the Ocean, off Cadiz, the 30th of April 1806.

SIR, INCLOSE, for the Information of the Lords Commissioners of the Admiralty, a Letter from Captain Mundy, of His Majesty's Ship the Hydra, giving an Account of his having captured the Spanish National Schooner Argonauta, on the Morning of the 28th Instant, after a long Chace. COLLINGWOOD I am, &c.

His Majesty's Ship Hydra, at Sea? 28th April 1806.

My Lord, HAVE the Honor to inform you, His Catholic Majesty's Schooner Argonauta, commanded by Lieutenant Don Josef de Mendivil, and destined for Buenos Ayres, with Dispatches, was captured this Morning by His Majetty's Ship under my Command, (after a Chace of Two Hundred and Thirty Miles, in Lat. 34 Deg. 9 Min. N. and Long. 9 Deg. 29 Min. W.

She is a remarkable fine Veffel of her Kind, having originally carried Ten Six-Pounders and Two Eights, all of which, however, were taken out previous to her proceeding across the Atlantic, on the above Service; at the Time of Capture having only Four Sixes mounted on Stocks, and a Complement of Twenty Officers and Men. She is coppered, and well-found in every Sort of Store, and appears perfectly adapted for His Majelly's Service.

Copy of a Letter from Vice-Admiral Dacres, Commander in Chief of His Majefly's Ships and Vessels at Jamaica, to William Marsden, Esq; dated at Port Royal, March 27, 1806.

SIR, HAVE the Honor to inclose, for the Information of the Lords Commissioners of the Admiralty, the Copy of a Letter I have received from Captain Waller, of the Serpent, detailing the Capture of one of His Catholic Majesty's Guarda Costas by the Boats of that Sloop, in a very gallant Manner. J. R. DACRES.

I am, &c.

His Majesty's Sloop Serpent, Port Royal Har-R, bour, Jamaica, March 6, 1806. SIR. HAVE the Honor to inform you, that, on the 28th of November last, being off the Island of Bonecce, at Five P. M. Two Sail appeared in the N. E. Quarter. As they were far to Windward, and Night approaching, I judged, by commencing a Chace at that Time, there was but little Prospect of keeping Sight of them after Close of Day, I therefore continued with the Ship in the same Situation as when first feen till Dusk, and then bore up; made all Sail for Truxillo Bay, the Entrance of which we reached before Eleven o'Clock the same Night. I was induced to believe, by the Direction they were fleering, added to other Circumflances, this was their Defination. At Two in the Morning of the 29th, these Vessels were seen rounding At Two in the Mornthe East Point forming Truxillo Bay, but hauling so close to the Land that they were scarcely to be discerned. Experiencing a strong Current, at the same Time setting the Ship out, and the Wind also in that Direction, which they avoided in Shore, I found, under these great Disadvantages, there was no Probability of acting against them with Effect without the Boats, so they were instantly dispatched under the Orders of Mr. William Parfull, the Second Lieutenant, and Mr. Charles Trace, Master's-Mate, in the Launch, and the Cutter with Mr. Samuel Nisbett, Midshipman, and Mr. Thomas Scriven, the Purser, all of whom came forward in a very handsome Manner, offering their Services, as well as every Man employed on this Occasion. We had made them out before Night; one to be a Felucca, the other Felucca rigged forward, but having a Schooner-fail aft, which convinced me they were Enemy's Armed Vessels, I therefore directed the Boats to act together, and attempt the largest first. On approaching her they received a heavy Discharge from great Guns and small Arms, but their Exertions soon caused them to board and carry their Object; which proved to be a Schooner built Vessel and Guarda Colla, called the St. Christo Vil Pano, bearing the Colours and belonging to His Catholic Majesty, from the Havannah, mounting one long Traverling Eighteen-Pounder, Two Four Pounders, Four Brass Three-Pounders, small Arms, &c. and Forty Men, commanded by Don Juan Christorel Tierro, who, and Twenty-five others escaped by jumping overboard and swimming on Shore; Lieutenant Patfull, with the Launch alone loft no Time in pursuing the other, but am forry to fay, she eluded his Vigilance under cover of the Night, by lowering her Sails, then fweeping round the opposite Side of the Bay close to Lukes Keys; and at Daylight was nearly under the Fort Truxillo; a Spanish Fe-

Jucca Privateer mounting one Four-Pounder and I ternoon, they will put up to Sale at their Office, in So-Forty Men; she had accidentally joined the captured Veffel off Cape Antonio Five Days, before, I feel much Pleasure in saying this Service was performed without the Loss of a Man, and great Credit is due to Lieutenant Patfull, not only for his Judgment in laying the Boats on board, the gallant Manner he led them on, but for his active Exertion respecting the Pursuit; of the other Officers and Men employed under his Orders, highly merit my avarmelt Acknowledgments, all of whom 4 take the Liberty of recommending to your Notice.

HAVE the Honor to acquaint you, that this
Morning at Daylight, (Martinique bearing S. 81

Captain M'Kenzie, of the Carysfort, foon made himself known to me by Signal, and that the Chace was an Enemy; the Carysfort having been in Chace 30 Hours, and by the greatest Perseverance and Attention kept Sight of her the whole Night, the Enemy manceuvring in a malterly Style the At Half past Seven, finding the could whele Time. not crofs us, she furrendered, and proved to be the French National Brig La Lutine, Monfieur Crocquet Dechauteurs, Commander, from L'Orient, bound to Martinique, out Thirty-three Days, and had not made any Capture; she is a remarkably fine Vessel, quite new, mounts Eighteen Guns, Two of which were thrown overboard in the Chace, is well appointed in every Respect; sails uncommonly falt, and is, in my Opinion, well calculated for His Majesty's Service.
