Settlements or Factories in the East Indies, the Exporters of Such Articles do first make Oath of the true Destination of the same to the Places for which they shall be entered outwards, before the Entry of therfame shall be made, and do give full and fufficient Security, by Bond, to the Satisfaction of the Commissioners of His Majelly's Customs, to early the faid Articles to the Places for which they are fo entered outwards, and for the Purpofes specified, and none other; and such Bond shall not be cancelled or delivered up until Proof be made to the Satisfaction of the faid Commissioners, by the Production, within a Time to be fixed bythe faid Commissioners, and specified in the Bond, of a Certificate or Certificates, in such Form and Manner as shall be directed by the faid Commiffioners, fliewing that the faid Articles have been all duly landed at the Places for which they were entered outwards: And the Right Honorable the Lords Commillioners of His Majesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, and the Lord Warden of the Cinque Ports, are to give the necellary Directions herein as to them may respecfively appertain. WHEREAS by the Second Section of His Majetty's Order in Council of the Fifth Day of April One thousand eight hundred and five, certain Stations for the Performance of Quarantine by cer-tain Ships and Veffels in the faid Order specified, furnished with Clean Bills of Health, are assigned to afuch Ships and Vessels according to the Ports to which they are respectively bound; and Doubts have arisen at what Stations Quarantine ought to be performed by Ships and Veffels with Clean Bills of Health, captured or detained and brought into the Ports of Great Britain as Prize: His Majesty is thereupon pleafed, by and with the Advice of His Privy Council, to declare and order, that all fuch-Ships and Vessels shall, for the Purpole of per--forming Quarantine, be deemed, and taken to be bound to the Ports into which they have been, or shall be so brought, and shall, together with all Persons, Goods, Wares, and Merchandize, and other Atticles on board thereof, perform Quarantine accordingly: And the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, the Lord Warden of the Cinque Ports, the Master-General and the Rell of the Principal Officers of the Ordnance, His Majesty's Secretary at War, and the Governors and Commanders in Chief for the Time being of the Isles of Guernsey, Jersey, Alderney, Sark, and Man, are to give the necessary Directions , herein, as to them may respectively appertain.
