PROCLAMATION,

For dissolving this present Parliament, and declaring the Culling of another.

GEORGE R

HEREAS We think fit, by and with the: Advice of Our Privy Council, to disolve the present Parliament, which stands prorogued to Wednesday the Twenty-ninth Day of this instant: October, and which was to be further prorogued on: the faid Twenty-ninth Day of this instant October, to Thursday the Twenty-seventh Day of November -next: We do therefore publish this Our Royal Proclamation, and do hereby diffolve the faid Parliament accordingly; and the Lords Spiritual and Temporal, and the Knights, Chizzens, and Burgelles, and the Commissioners for Shires and Burghs of the House of Commons, are discharged from their Meeting and Attendance on the said Wednesday the Twentyninth Day of this instant October, and on the faid Thursday the Twenty-seventh Day of November next. And We being defirous and refolved, as foon as may be, to meet Our People, and to have their Advice in Parliament, do hereby make known to all Our loving Subjects Our Royal Will and Pleafure to call a new Parliament: And do hereby further declare, that, with the Advice of Our Privy :Council, We have this Day given Order that Our Chancellor of that Part of Our United Kingdom called Great Britain, and Our Chancellor of Ireland, do respectively forthwith issue out Writs, in due Form and according to Law, for calling a new Pardiament. And We do hereby also, by this Our's Royal Proclamation under Our Great Seal of Our United Kingdom, require Writs forthwish to be affued accordingly by Our said Chancellors respectively, for caufing the Lords Spiritual and Temporal, and Commons, who are to serve in Our said Parliament, to be duly returned to, and give their Attendance in, Our said Parliament; which Writs are to be returnable on Monday the Fifteenth Day of December next

A PROCLAMATION.

In order to the Eleding and Summaning the Sixteen Peers of Scotland.

GEORGE R.

WHEREAS We have, in Our Council, thought fit to declare Our Pleasure for summoning and holding a Parliament of Our United Kingdom of Great Britain and Ireland, on Monday the Fifteenth Day of December next enluing the Date hereof: In order therefore to the electing and fummoning the Sixteen Peers of Scotland, who are to fit in the House of Peers in the faid Parliament; We do, by the Advice of Our Privy Council, issue forth this Our Royal Proclamation, Briefly charging and-commanding all the Peers of Scotland to allemble and meet at Holy Rood Flouse, in Edinburgh, on Thursday the Fourth Day of December next ensuing, between the Hours of Twelve and Two in the Asternoon, to nominate and checke the Sixteen Peers to fit and vote in the House of Peers, in the faid ensuing Parliament, by open Election and Plurality of Voices of the Peers that shall be then prefent, and of the Proxies of fuch as shall be ablent, (fuch Proxies being Peers, and producing a Mandate in Writing, duly figned before Witnesses, and both the Constituent and Proxy being qualified according to Law). And the Lord Clerk Register, or such Two of the Principal Clerks of the Session as shall be appointed by him to officiate in his Name, are hereby respectively required to attend such Meeting, and to administer the Oaths required by Law to be taken there by the faid Peers, and to take their Votes; and immediately after such Election made, and duly examined, to certify the Names of the Sixteen Peers to elected, and fign and atteft the fame, in the Prefence of the faid Peers the Electors; and return such Certificate into Qur High Court of Chancery of Great Britain. And We do, by this Our Proclamation, firietly command and require the Provoft of Edinburgh, and all other the Magistrates of the said City, to take especial Care to preserve the Peace thereof, during the Time of the said Election; and to prevent all Manner of Riots, Tumults, Diforders, and Violence whatsoever. And We strictly charge and command, that this Our Royal Proclamation. be duly published at the Market Crois at Edinburgh, and in all the County Towns of Scotland, Twenty-five Days at least before the Time hereby appointed for the Meeting of the faid Peers to proceed to fuch Election.

BY THE LORDS COMMISSIONERS OF HIS MAJESTY'S TREASURY.

WHEREAS by an Act passed in the last Seffice of Parliament fion of Parliament, intituled "An Act for permitting certain Goods imported into Great Bri- in the faid Table annexed to the faid Act, and

tain to be secured in Warehouse, without Payment of Duty," it is (amongst other Things,) enacted as follows: "That it shall be lawful for the Importer or Importers, Proprietor or Proprietors, Confignee or Confignees of any of the Goods, Wares, or Merchandize enumerated or described in the Table hereunto annexed, marked (A), and which shall be legally imported and brought into the Port of London, to lodge and secure the same under the Joint Locks of the Crown and the Merchant in any Warehouse or Warehouses, situated at the Isle of Dogs, and belonging to the West India Dock Company, without Payment at the Time of the first Entry of such Goods, Wares, and Merchandize of the Duties of Customs or Excise due on the Importation thereof, subject nevertheless, to the Rules, Regulations, and Rellrictions directed by this Act; provided always, that no fuch Goods, Wares, or Merchandize shall be so lodged or secured unless, and until fuch Warehouses and other Works belonging, or to belong thereto, shall be so far completed, that in the Judgment of the Lord High Treasurer, or the Commissioners of His Majesty's Treasury for the Time being, or any Three or more of them, the fame shall be fit and proper, in every Respect for the Reception of such Goods, Wares, and Merchandize, and wherein the same may respectively be fafely and fecurely deposited, and remain under the Regulations and Directions of this Act; and the Lord High Treasurer or the Commissioners of His Majesty's Treasury for the Time being, or any Three or more of them, are hereby authorized and empowered, by Writing under his or their Hand or Hands, to certify and make known his or their Approbation of Iuch Warehouses, which Certificate shall be published Three Times at least, in the London Gazette, and in Two or more public Morning Newspapers, then usually circulated in London."

And whereas by a Certificate under the Hands of Three of the Lords Commissioners of His Majesty's Treasury granted in pursuance of the said Act, on the 16th Day of March 1804, the said Lords Commissioners did certify and make known, that the following Warehouses belonging to the West India Dock Company, were so far completed, that in their Judgment, the same were fit and properin every Respect, for the Reception of such Goods, Wares, and Merchandize as are enumerated and described in the said Table annexed to the said A& of Parliament, marked (A), and wherein the same might respectively be safely and securely deposited, and remain under the Regulations and Directions of the faid Act, viz.
