AT the Court at the Queen's Palace, the 1st of July 1807,

PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS by an Act, made and paffed in the Forty-fixth Year of His Majesty's Reign, ntituled, "An Act for authorizing His Majesty, in Council, to allow, during the present War, and for Six Months after the Ratification of a Definitive Treaty of Peace, the Importation and Exportation of certain Goods and Commodities, in Neutral Ships, into and from His Majesty's Territories in the West Indies, and Continent of South America;" it is enacted, that from and after the passing of the faid Act, it shall and may be lawful for His Majesty, His Heirs and Succeffors, by and with the Advice of His and Their Privy Council, to permit, or to authorize the Governors of the Islands and Territories hereinafter mentioned, in fuch Manner, and under fuch Restrictions, as to His Majesty, by and with the Advice of His Privy Council, shall feem fit, to permit, when the Necessity of the Case shall appear to His Majesty, with the Advice of His Privy Council, to require it, from Time to Time during the present War, and for Six Months after the Resissant of Permeters of Perm the Ratification of a Definitive Treaty of Peace, the Importation into, and the Exportation from, any Illand in the West Indies, (in which Description the Bahama Islands, and the Bermuda or Somer Islands, are included,) or any Lands or Territories on the Continent of South America, to His Majelly belonging, of any fuch Articles, Goods, and Commodities as shall be mentioned in such Order of His Majesty, in Council, in any Ships or Vessels belonging to the Subjects of any State in Amity with His Majesty, in such Manner as His Majesty, His Heirs and Successors, by and with the Advice aforefaid, shall direct, provided such Ships or Vesfels shall duly enter into, report, and deliver their respective Cargoes, and reload, at such Ports only where regular Custom-Houses shall have been established; and whereas, it appears at present to be necessary to permit, for a limited Time, subject to be fooner terminated, varied, or altered, as is hereinafter provided, the Importation into, and the Ex-portation from, the Islands and Territories of His Majesty in the West Indies, (including the Bahama

Islands, and the Bermuda or Somer Islands,) and the Lands and Territories on the Continent of South America, to His Majelty belonging, of certain Articles, Goods, and Commodities hereinafter mentioned, in any Ships or Veffels belonging to the Subjects of any State in Amity with His Majesty; His Majesty is thereupon pleased, by and with the Advice of His Privy Council, to order, and doth heteby order, that the Governors and Lieutenant-Governors of His Majesty's Islands and Colonies in the West Indies, (in which Description the Bahama Islands, and the Bermuda or Somer Islands, are included,) and of any Lands or Territories on the Continent of South America, to His Majesty belonging, and each and every of such Governors and Lieutenant-Governors shall be authorized, and they, and each and every of them, are hereby authorized to permit, for Twelve Months from the Date hereof, subject to be sooner terminated, varied, or altered, as is hereinafter provided, in any Ships or Vessels belonging to the Subjects of any State in Amity with His Majesty, the Importation into the said Islands, Colonies, Lands, and Territories respectively, of Staves and Lumber, and also of every Kind of Provisions, (Beef, Pork, Fish, and Butter excepted,) which are of the Growth or Produce of the Country to which fuch Ship or Veffel importing the same shall belong; the Exception of Fish, however, not to be in Force in any of the said Islands, Colonies, Lands, or Territories, in which there shall have been provided a Bounty on Fish taken in any Part of His Majesty's Dominions in North America, or on the Coalts thereof, by British Subjects, to an Amount equal to Two Shillings a Quintal on Cod, and imported in British Vessels from any of His Majesty's Provinces, Settlements, or Possessions in North America; and also the Exportation from the faid Islands, Colonies, Lands, and Territories respectively, into which such Importation of Staves, Lumber, and Provisions as aforefaid, shall be made, of Rum and Molasses, and of any other Articles, Goods, and Commodities whatloever, except Sugar, Indigo, Cotton-Wool, Coffee, and Cocoa; provided always, that fuch Ships or Veffels shall duly enter into, report, and deliver their respective Cargoes, and reload, at fuch Ports only where regular Custom-Houses shall have been established; and His Ma-jesty, by and with the Advice of His said Privy

Council, is further pleafed to 'order, and doth hereby order, that notwithstanding any Thing here-inbefore contained, the said Permission and Authority to import and export shall cease and determine, or be varied and altered, before the Expiration of the abovementioned Period of Twelve Months, at the Expiration of Six Months after the Notification in the London Gazette, of any Order of His Majesty, by and with the Advice of His Privy Council, for revoking, varying, or altering such Permission and Authority, or shall cease and determine at the Expiration of Six Months after the Ratissication of a Definitive Treaty of Peace.

WE, whose Names are hereunto subscribed, being Five of the Commissioners nominated and appointed in and by His Majesty's Commission under the Great Seal of Great Britain, bearing Date at Westminster the 29th Day of September 1806. for carrying into Execution an Act of Parliament, passed in the then last Session of Parliament, intituled " An Act to vest certain Messuages, Lands, Tenements, and Hereditaments in Truftees, for better fecuring His Majesty's Docks, Ships, and " Stores at Portsmouth, and for extending the " Lines and Works at Dover;" do hereby give Notice, that the Commissioners for that Purpose appointed, or Five or more of them, do intend to meet on Thursday the 20th Day of August, at the House called or known by the Name or Sign of the George, fituate at Portfmouth, in the County of Southampton, at Eleven of the Clock in the Forenoon of the fame Day, for the Purpose of executing the faid Commission according to the Powers and Authorities to the faid Commissioners, or any Five or more of them, given by the said Act of Parliament, (so far as respects the Lands and Hereditaments hereinafter-mentioned;) that is to fay, All that Piece or Parcel of Arable Land called the Further Sixteen Acres, containing, in Statute Measure, Twelve Acres and Eleven Perches, or thereabouts; and also all that Piece or Parcel of Arable Land adjoining the South East Side of the faid last-mentioned Premises, called the Sixteen Acres, containing, in Statute Meafure, Twelve Acres, Two Roods, and Twenty-feven
