The KING's Most Excellent Majesty in Council.

Its Majesty, taking into Consideration the Meadirers recently resorted to by the Enemy for distressing the Commerce of the United Kingdom, is pleased, by and with the Advice of His Privy Council, to order, and it is hereby ordered, that all Vessels under the Flag of Mecklenburgh, Oldenburgh, Papenburgh, or Kniphausen, shall be forthwith warned not to trade in future at any hostile Port, unless such Vessels shall be going from or coming to a Port of the United Kingdom; and in case any such Vessel, after having been so warned, shall be found trading, or to have traded, after such Warning; or in case any Vessel or Goods belonging to the Inhabitants of such Countries, after the Expitation of Six Weeks from the Date of this Order, shall be found trading, or to have traded, after Six Weeks have expired, at any hostile Port, such Vessel and Goods, unless going from or coming to a Port of the United Kingdom, shall be seized and brought in for legal Adjudication, and shall be condemned as lawful Prize to His Majesty:—And His Majesty's Principal Secretaries of State, the Lords Commissioners of the Admiralty, and the Judge of the High Court of Admiralty, and Judges of the Courts of Vice-Admiralty, are to take the necessary Measures herein as to them shall respectively appertain.

His Majesty's Service, and the Safety of this Kingdom, that the said Prohibition should be continued for some Time longer, His Majeky doth therefore, with the Advice of His Privy Council, hereby order, require, prohibit, and command, that no Person or Persons whosever do at any Time, for the Space of Six Months, from the said Eleventh Day of of Six Mouths, from the faid Eleventh Day of this inflant July, prefume to transport into any Parts out of this Kingdom any Pig-Iron, Bar-Iron, Hemp, Pitch, Tar, Rosin, Turpentine, Anchors, Cables, Cordage, Masts, Yards, Bowsprits, Oars, Oakum, Sheet-Copper, or other Naval Stores, or do ship or lade any Pig-Iron, Bar-Iron, Hemp, Pitch, Tar, Rosin, Turpentine, Anchors, Cables, Cordage, Masts, Yards, Bowsprits, Oars, Oakum, Sheet-Copper, or other Naval Stores, on board any Ship or Vessel, in order to transporting the same into any Parts beyond the Seas. porting the same into any Parts beyond the Seas, without Leave or Permillion first being had and ob-tained from His Majesty or His Privy Council, upon Pain of incurring the Forfeitures inflicted by an Act. passed in the Thirty-third Year of His Majesty's Reign, intituled "An Act to enable His Majelty "to restrain the Exportation of Naval Stores, and " more effectually to prevent the Exportation of " Salt-Petre, Arms, and Ammunition, when pro-"hibited by Proelamation or Order in Council:" But it is nevertheless His Majesty's Pleasure, that nothing herein contained shall extend, or be conitrued to extend, to any of His Majelly's Ships of War, or any other Ships or Vessels or Boats in the Service of His Majesty, or employed or freighted by His Majesty's Board of Ordnance, or by the Commissioners of His Majesty's Navy; nor to prevent any Ship or Vellel from taking or having on board fuch Quantities of Naval Stores as may be neces-fary for the Use of such Ship or Vessel during the Course of her intended Voyage, or by Licence from the Lord High Admiral of Great Britain, or the Commissioners of the Admiralty for the Time being; nor to the Exportation of the said several Articles to Ireland, or to His Majesty's Yards or Garrifons, or to His Majesty's Colonies or Planta-tions in America or the West Indies, or to New-foundland, or to His Majesty's Forts and Settle-ments on the Coast of Africa, or to the Island of St. Helena, or to the British Settlements or Factories in the East Indies: Provided that upon the Ex-

portation of any of the faid Articles for the Purposes of Trade to Incland, or to His Majetty's Yards and Garrisons, or to His Majetty's Colonics and Plantations in America or the West Indies, or to the Island of Newfoundland, or to His Majefty's Forts and Settlements on the Coast of Africa, or to the Island of St. Helena, or to the British Settlements or Factories in the East Indies, the Exporters of fuch Articles do first make Oath of the true Destination of the same to the Places for which they shall be entered outwards, before the Entry of the same shall be made, and do give full and fufficient Security, by Bond, (except as here-inafter excepted,) to the Satisfaction of the Commissioners of His Majesty's Customs, to carry the faid Articles to the Places for which they are for entered outwards, and for the Purposes specified, and none other; and such Bond shall not be cancelled or delivered up until Proof be made to the Satisfaction of the faid Commissioners, by the Production, within a Time to be fixed by the faid Commissioners, and specified in the Bond, of a Certificate or Certificates, in fuch Form and Manuer as shall be directed by the faid Commiffioners, shewing that the faid Articles have been all duly landed at the Places for which they were entered outwards: But it is His Majesty's Pleasure, nevertheless, that the following Articles, viz. Bar-Iron, White and Tarred Rope, Tallow or Mill Greafe, Tarpaulins for Waggon-Covers, Pitch, Tar, and Turpentine, shall be permitted to be exported, upon Payment of the proper Duties, without Bond being entered into by the Merchant Exporter, to any of the British Plantations in the West Indies, or to any of His Majesty's Settlements in South America; provided the Merchant Exporter shall first verify, upon Oath, that the Articles fo exported are intended for the Use of a particular Plantation or Settlement, to be named in the Entry Outwards, and not for Sale; and that the said Plantation or Settlement has not before been furnished with any Supply of the faid Articles during the fame Seafon; and provided also that the Exportation of the faid Articles shall, in no Case, exceed the Value of Fifty Pounds Sterling for any given Plantation or Settle-ment, whether by one or more Shipments within the same Season: And the Right Honourable the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, and the Lord Warden of the Cinque Ports, are to give the neceffary Directions herein as to them may refpec-tively appertain. LONDON DOCKS.

BY THE LORDS COMMISSIONERS OF HIS MAJESTY'S TREASURY.

WHEREAS by an Act, passed in the Forty-third Year of His present Majesty's Reign, intituled, " An Act for permitting certain Goods imported "into Great Britain to be secured in Warehouses, without Payment of Duty," it is enacted, That it should be lawful for the Importer or Importers, Proprietor or Proprietors, Confignee or Confignees of any of the Goods, Wares, or Mer-chandize enumerated or described in the Table thereunto annexed, marked (B), and which shall be legally imported and brought into the Port of London, to lodge and fecure the fame under the Joint Locks of the Crown and the London Dock Company, in any Warehouse or Warehouses erected or to be erected, situate within the Premises belonging to the London Dock Company, without Payment at the Time of the first Entry of such Goods, Wares, and Merchandize of the Duties of Customs or Excise due on the Importation thereof, fubject nevertheless, to the Rules, Regulations, and Retrictions therein contained; provided that no fuch Goods, Wares, or Merchandize should be fo lodged or fecured unless, and until fuch Warehouses or other Works belonging, or to belong thereto, should be so far completed, that in the Judgment of the Lord High Treasurer, or the Commissioners of His Majesty's Treasury for the Time being, or any Three or more of them, the fame shall be fit and proper, in every Respect, for the Reception of fuch Goods, Wares, and Merchandize, and wherein the same might respectively be fafely and securely deposited, and remain under the Regulations and Directions in the faid Act contained; and the faid Lord High Treasurer, or Commissioners of His Majesty's Treasury for the Time being, or any Three or more of them, were thereby authorized and empowered, by Writing under his or their Hand or Hands, to certify and make known his or their Approbation of fuch Warehouses, which Certificate should be published Three Times at least, in the London Gazette, and in Two or more public Morning Newspapers usually circulated in London.

III, c. 132, authorifing the Honourable the Commissioners of Northern Light-Houses to erect a Light-House on the Bell-Rock, to place a Floating Light there, and to collect Duties thereupon, Notice is hereby given, that a Vessel, fitted out for a Floating Light, is now moored off the Cape or Bell Rock, fituated at the Entrance of the Friths of Forth and Tay, in N. Lat. 56 Deg. 27 Min. and W. Long. 2 Deg. 27 Min.

The Moorings of this Light confift, of a Mushroom Anchor, with a Chain, laid down in 17 Fathoms Water, the Bell Rock bearing by the Compass, E. S. E. distant One Mile; the Red Head, N. by E. & E. distant Thirteen Miles; Fiseness, S. W. & W. distant Twelve Miles; and the Island of May, S. W. & S. distant Seventeen Miles.

The Light will be from Oil, and will be lighted upon the Night of the 15th Day of September

1807, and thereafter every Night, from the going away of Daylight in the Evening till the Return of Daylight in the Morning. To diftinguish this Light from the Double Lights at the Tay and Scares, and from the Single Light on the Island of May, Three diffinct Lights will be shewn by a Lantern hoisted to the Top of each Mast, and these will be visible from every Point of the Compass; the Lanterns on the Fore and Mizen Maft being elevated 23 Feet, and that on the Mizen Mast 31 Feet above the Veffel's Deck : the Lights, when feen from either Side of the Ship, will have the Appearance of a Triangle, but if feen End on, will appear as Two Lights, the one above the other.

This Vessel was formerly a Fishing Dogger, and at the Distance of Seven or Eight Miles is like a Ship under Jury-Masts; in the Daytime a Blue Flag, with a Light-House in the Field, will be displayed from the Main-Mast; and in thick and foggy Weather, a Bell will be tolled on board, with an

Although this Veffel has been fitted out in the completest Manner, and every Attention paid to mnoring her properly, yet as all floating Lights are liable to break adrift in the temperauous Weather of Winter, Mariners are recommended not to neglect their Land-Marks, and to run with Caution for the

floating Light.
