

Hague, April 15. The Sieur *Lieft*, Envoye Extraordinary from the Elector of *Brandenburg*, will now in a few days take his Audience of the States General, his Electoral Highness being, as we are informed, satisfied with the Declaration the States have made, That in case the Prince's Guards were at any time drawn out when an Envoye from a Crowned Head was Conducted to his first Audience, it was purely accidental, and without their Order; and that he, and those that shall hereafter succeed him in this Employment, shall be received with the same Respects and Honours that the Envoys from Crowned Heads are. The Ratifications of the Treaty of Peace and Commerce between the King of *Sweden* and this State, which was Concluded at *Nimeguen*, are not yet exchanged, notwithstanding the several Instances that have been made by the Dutch Minister at *Stockholme* for that purpose. From *Germany* we have Advice, That the French had demanded of the Bishop of *Basel*, a passage through his Territories for some of their Troops, which he refused, and that he had acquainted the *Swisse Cantons* with their Demand, and his Answer. Our Letters likewise tell us of the death of the Duke of *Deux-Ponts*, whose next Heir is the King of *Sweden*; and whether he will be kindlier Treated by the French than his Predecessor was, time must shew.

Amsterdam, April 15. This place affords very little News, but what we receive from abroad. What we have from *Germany* is, That the Treaty of Marriage between the Elector of *Bavaria* and the Princess of *Essex* is concluded; the Elector allowing her and all her Servants, a free exercise of her Religion, which is the *Lutheran*, and such Ministers as she shall make choice of. That the Sovereign Chamber at *Metz* goes on in forming Pretensions upon several Places, as Dependancies of the Bishopricks of *Metz*, *Toul*, or *Verdun*: and that the French Troops began to move, in order to their drawing together in several Bodies, one whereof is appointed to Encamp near *Saar-Louis*.

Brussels, April 15. The Nations having granted the Subsidies demanded by the Prince of *Parma* for the maintaining a Garrison of 2000 Foot and 500 Horse in this place; his Highness gave immediately Orders for the bringing several Regiments hither; and on Saturday last *Salzedo's* Regiment of Dragoons, on Sunday a Regiment of Spanish Foot, and yesterday a Regiment of Dragoons came hither, and we are expecting three or four Regiments more, to make up the number of the Garrison intended. The Prince of *Parma* purposes to go the next week for *Flanders*, and the Count *d'Archino* parted from hence yesterday for *Antwerp*. The daily Complaints that are brought hither from *Luxemburg*, where the French Troops live at Discretion have made the Prince of *Parma* resolve rather to deliver up *Vinton* to them, than suffer the Country to be quite ruined, and therefore his Highness has sent Orders to the Governor of that Place to put it into their hands.

Paris, April 16. Yesterday their Majesties went from *St. Germain* to *St. Clou*, where they will pass five or six days, and then go to *Versailles* or *Fontainebleau*. The King has granted the Count *de Lauzun*,

who has been for several years a prisoner at *Pignerol*, leave to go under a Guard to *Bourbon*, to use the Waters for his Health; and his friends hope he will at last obtain his Liberty. Some days since a Gentlewoman was seized in the *Faubourg of St. Germain*, being accused of Poisoning. From *Nancy* they write, that a Battalion of the Regiment of the Crown was marched from thence to *Saar Louis* to join the other Troops that are appointed to encamp near that place. There is very little appearance of Accommodating Matters with the Court of *Rome*.

Portsmouth, April 7. On Monday last in the Evening came to an Anchor in this Road, Capt. *Ledger* in the bound home from *Bantam*, from whence he came in *November* last. This morning His Majesties Ship the *Orange-Tree* sailed for the *Downs*.

Whitehal, April 7. This morning was held a Chapter of the most Noble Order of the Garter, in the Presence of the Sovereign, where *Charles* Duke of *Richmond* was Elected a Knight-Companion of the Order; and being introduced by the Duke of *Sourhampton*, and the Earl of *Mulgrave*, was Invested with the Collar and the Garter.

Whitehal, April 8. His Majesty was this day pleased to Order in Council, That His Majesties Declaration to all His Loving Subjects, touching the Causes and Reasons that moved Him to Dissolve the two last Parliaments, should be forthwith Printed and Published, and should be Read in all Churches and Chappels throughout the Kingdom.
