

ived the last week from France told us, That the King, upon the Spanish Ambassadors Declaring to him, that Orders had been sent for the Evacuation of *Virton*, had Commanded the Count de *Bissy* to retire with his Troops out of *Luxemburg*, which made us the more easily believe what was writ in some Letters from thence, that the said Troops were leaving that Countrey; but it proves a mistake, for we have fresh Letters which say, that they still continue there, and that the Count de *Bissy* had required some small Places, as *Rhemich*, *Cravenmacheren*, &c. to furnish him with great quantities of Provisions, and at the same time had forbidden them to send any to the City of *Luxemburg*.

Brussels, April 22. The Count d' *Archinto* is returned from *Antwerp*, having composed the difference between the Magistrates and the People, and Adjusted all Matters to his Highness's satisfaction. Count d' *Erpe* is likewise returned from *Limburg*, having obtained the Subsidies he went thither to Demand of the States of that Province in his Highness's Name. His Highness has received an account from *Guelderland*, that the Elector of *Brandenburg* will be at *Cleves* before the end of the next Month; that at *Wesel* and *Lipstadt* they are providing a great many Carriages for Cannon, Pontoons, and Ammunition-Waggons, and that several Officers are employed in raising of Men. From *Luxemburg* they write, that the French do not yet make any shew of leaving that Countrey; but that on the contrary, they make a new Claim to the Prevosty of *Rhemich*; and not content with the Evacuation of *Virton*, they Demand to have the same delivered into their hands by a formal Act, acknowledging their Right; but the Prince of *Parma*, thinks he has done enough in withdrawing the Spanish Troops, and leaving it to the Count de *Bissy* to take Possession if he please. Don *Alexander Farnese*, the Prince's Son, having entred himself a Volontier in the Marquis of *Bedmar's* Regiment of Spanish Foot, and Mounting the Guard yesterday for the first time, it was done with much Ceremony; the Prince de *Rache* *Maisiré* de Camp-General of the King's Forces in these Provinces, supplying the place of the Major, and Leading the Regiment, the Prince de *Vaudemont*, and Don *Antonio d'Agurto* General of the Artillery, discharging the Place of Adjutants, the Marquis de *Bedmar*, and Monsieur *Sarmiento*, Generals of *Bataliá*, that of Sergeants, and all the Colonels that were in Town, that of Corporals, besides several Persons of Quality accompanied Don *Alexander*, and carried Pikes; after which the Prince of *Parma* Entertained them at Supper, and with the same Solemnity the Guard was this day relieved.

Hague, April 22. The Count d' *Avaux*, Ambassador from France, has by a Memorial acquainted the States-General, that the French Commissioners will be at *Courtray* on the second of the next Month, to renew the Conferences for the determining the differences concerning the Limits. Our Letters from *Spain* give an Account, that the King, to prevent all misunderstanding between him and the Crown of *Portugal*, on occasion of what had happened in *America*, was sending the Duke of *Gisvanazzo* to *Lisbon* to accommodate that Matter.

Paris, April 23. What was said of Monsieur *Gassion's* going Ambassador to *Spain*, it seems a mistake, the King having nominated the Bishop of *Troyes* to succeed the Marquis de *Villars* in that Embassie. The Dutchess of *houillon* is returned to Court.

Falmouth, April 11. The 8th Instant came into this Port the Crown of *London*, *Richard Taylor* Master from *Bourdeaux*, bound for *Rotterdam* (he came from thence in the company of several other Ships, from whom he was separated by bad weather) and the *Grace of Fopsham*, *Richard Dodge* Master from the *Maderas*, he tells us of a great deal of bad weather they had there, in which several Vessels were lost; and that Sir *Richard Dutton*, whom His Majesty has appointed to succeed Sir *Fonabap Atkins* in the Government of the *Barbados*, sailed from the *Maderas* on the 22 of *February* to continue his Voyage. On Saturday last passed by this Harbor our *Streights Fleet*, the Wind at *S. W.*

Dcal, April 11. Yesterday arrived in the Downs above 30 Sail of small Vessels bound for *Holland* and other Parts, from France.

Whitehal, April 15. There having been Published a Paper, called the *Additional Information of Eustace Comyne*, in which is this Clause. *And this Information was told by John Welsh of Kilmore in the said County of Tipperary, That whatever Robert Low, Charles Alcocke, Esq; Sir William Davies, and John Welsh the Lawyer, should act or do, in the carrying on of the Plot against the Protestants; they had sufficient Authority from his Grace the Duke of Ormond for the doing it.* The said *Eustace Comyne* appeared this day of his own accord before the Council-Board, and Declared upon Oath, that *Mr. Herberington* put the above recited Clause into his said Information without his knowledge, and that he knows no such thing.

This day likewise *Francis Smith* (the Publisher of the *Protestant Intelligence*, at the *Elephant and Castle* in *Cornhill*) was by Order of the Board Committed to *Newgate* for High Treason.
