#### PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS the King of Denmark has iffued a Declaration of War againft His Majefty, His Subjects and People; and His Majefty's anxious and repeated Endeavours to obtain the Revocation of fuch Declaration, and to procure the Reftoration of Peace, have proved ineffectual; His Majefty therefore is pleafed, by and with the Advice of His Privy Council, to order, and it is hereby ordered, that General Reprizals be granted againft the Ships, Goods, and Subjects of the King of Denmark, (fave and except any Veffels to which His Majefty's Licence has been granted, or which have been directed to be releafed from the Embargo, and have not fince arrived at any Foreign Port,) fo that as well His Majefty's Fleets and Ships, as alfo all other Ships and Veffels that fhall be commiffionated by Letters of Marque or General Reprizals, or otherwife, by His Majefty's Commiffioners for executing the Office of Lord High Admiral of Great Britain, fhall and may lawfully feize all Ships, Veffels, and Goods belonging to the King of Denmark, or his Subjects, or others inhabiting within the Territories of the King of Denmark, and bring the fame to Judgment

in any of the Courts of Admiralty within His Majefty's Dominions ; and, to that End, His Majefty's Advocate-General, with the Advocate of the Admiralty, are forthwith to prepare the Draft of a Commiffion, and prefent the fame to His Majefty at this Board, authorizing the Commiffioners for exe-cuting the Office of Lord High Admiral, or any Perfon or Perfons by them empowered and appointed, to iffue forth and grant Letters of Marque and Reprizals to any of His Majefty's Subjects, or others whom the faid Commiffioners shall deem fitly qualified in that Behalf, for the apprehending, feiz-ing, and taking the Ships, Veffels, and Goods be-longing to Denmark, and the Vaffals and Subjects of the King of Denmark, or any inhabiting within his Countries, Territories, or Dominions, (except as aforefaid ;) and that fuch Powers and Claufes be inferted in the faid Commiffion as have been ufual, and are according to former Precedents; and His Ma-jefly's Advocate-General, with the Advocate of the Admiralty, are also forthwith to prepare the Draft of a Commission, and present the fame to His Majefty at this Board, authorizing the faid Commif-fioners for executing the Office of Lord High Admiral, to will and require the High Court of Admi-ralty of Great Britain, and the Lieutenant and Judge of the faid Court, his Surrogate or Surrogates, as also the feveral Courts of Admiralty within His Majefty's Dominions, to take Cognizance of, and judicially proceed upon, all and all Manner of Captures, Seizures, Prizes, and Reprizals of all Ships and Goods that are or fhall be taken, and to hear and determine the fame, and, according to the Courfe of Admiralty, and the Laws of Nations, to adjudge and condemn all fuch Ships, Veffels, and Goods as shall belong to Denmark, or the Vafials and Subjects of the King of Denmark, or to any others inhabit-ing within any of his Countries, Territories, and Dominions, (except as aforefaid ;) and that fuch Powers and Claufes be inferted in the faid Commiffion as have been ufual, and are according to former Precedents; and they are likewife to prepare, and lay before His Majeity at this Board, a Draft of fuch Inftructions as may be proper to be fent to the Courts of Admiralty in His Majefly's Foreign Governments and Plantations, for their Guidance herein; as allo another Draft of Inffractions for
