AT the Court at the Queen's Palace, the 11th of November 1807,

PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS certain Orders, establishing an unprecedented System of Warfare against this Kingdom, and aimed especially at the Destruction of its Commerce and Resources, were, some Time since, issued by the Government of France, by which "The British Islands were declared to be in a State of Blockade," thereby subjecting to Capture and Condemnation all Vessels, with their Cargoes, which should continue to trade with His Majesty's Dominions:

And whereas by the fame Orders, "all trading in English Merchandize is prohibited, and every Article of Merchandize belonging to England, or coming from her Colonies, or of her Manufacture, is declared lawful Prize:"

And whereas the Nations in Alliance with France, and under her Controul, were required to give, and have given, and do give, Effect to fuch Orders:

And whereas His Majesty's Order of the 7th of

And whereas His Majelty's Order of the 7th of January last has not answered the defired Purpose, either of compelling the Enemy to recall those Orders, or of inducing Neutral Nations to interpose, with Effect, to obtain their Revocation, but, on the contrary, the same have been recently enforced with increased Risson.

increased Rigour :

And whereas His Majesty, under these Circumstances, finds Himself compelled to take further Measures for afferting and vindicating His just Rights, and for supporting that Maritime Power which the Exertions and Valour of His People have, under the Blessing of Providence, enabled Him to establish and maintain; and the Maintenance of which is not more essential to the Safety and Prosperity of His Majesty's Dominions, than it is to the Protection of such States as still retain their Independence, and to the general Intercourse and Happiness of Mankind:

His Majesty is therefore pleased, by and with the Advice of His Privy Council, to order, and it is hereby ordered, that all the Ports and Places of France and her Allies, or of any other Country at War with His Majesty, and all other Ports or Places in Europe, from which, although not at

War with His Majesty, the British Flag is excluded, and all Ports or Places in the Colonies belonging to His Majesty's Enemics, shall, from henceforth, be subject to the same Restrictions in point of Trade and Navigation, with the Exceptions hereinastermentioned, as if the same were actually blockaded by His Majesty's Naval Forces, in the most strict and rigorous Manner:—And it is hereby surther ordered and declared, that all Trade in Articles which are of the Produce or Manusacture of the said Countries or Colonies, shall be deemed and considered to be unlawful; and that every Vessel trading from or to the said Countries or Colonies, together with all Goods and Merchandize on board, and all Articles of the Produce or Manusacture of the said Countries or Colonies, shall be captured, and condemued as Prize to the Captors.

But although His Majefty would be fully juftified, by the Circumstances and Considerations above recited, in establishing such System of Restrictions with respect to all the Countries and Colonies of His Enemies, without Exception or Qualification; yet His Majesty, being severtheless desirous not to subject Neutrals to any greater Iuconvenience than is absolutely inseparable from the carrying into effect His Majesty's just Determination to counteract the Designs of His Enemies, and to retort upon His Enemies themselves the Consequences of their own Violence and Injustice; and being yet willing to hope that it may be possible (consistently with that Object) still to allow to Neutrals the Opportunity of furnishing themselves with Colonial Produce for their own Consumption and Supply; and even to leave open, for the present, such Trade with His Majesty's Enemies as shall be carried on directly with the Ports of His Majesty's Dominions, or of His Allies, in the Manner hereinaster mentioned:

His Majely is therefore pleafed further to order, and it is hereby ordered, That nothing berein contained shall extend to subject to Capture or Condemnation any Vessel, or the Cargo of any Vessel, belonging to any Country not declared by this Order to be subjected to the Restrictions incident to a State of Blockade, which shall have cleared out with such Cargo from some Port or Place of the Country to which she belongs, either in Europe or America, or from some Free Port in His Majesty's

Colonies, under Circumstances in which such Trade from such Free Port is permitted, direct to some Port or Place in the Colonies of His Majesty's Enemies, or from those Colonies direct to the Country to which fuch Vessel belongs, or to some Free Port in His Majesty's Colonies, in such Cases, and with fuch Articles, as it may be lawful to import into fuch Free Port ;-Nor to any Vessel, or the Cargo of any Veffel, belonging to any Country not at War with His Majesty, which shall have cleared out from fome Port or Place in this Kingdom, or from Gibraltar or Malta, under fuch Regulations as His Majesty may think fit to prescribe, or from any Port belonging to His Majesty's Allies, and shall be proceeding direct to the Port specified in her Clearance ;- Nor to any Vessel, or the Cargo of any Veffel, belonging to any Country not at War with His Majesty, which shall be coming from any Port or Place in Europe which is declared by this Order to be subject to the Restrictions incident to a State of Blockade, destined to some Port or Place in Europe belonging to His Majesty, and which shall be on her Voyage direct thereto; but these Exceptions are not to be understood as exempting from Capture or Confifcation any Veffel or Goods which shall be liable thereto in respect of having entered or departed from any Port or Place actually blockaded by His Majesty's Squadrons or Ships of War, or for being Enemies' Property, or for any other Cause than the Contravention of this present Order.

And the Commanders of His Majesty's Ships of War and Privateers, and other Veffels acting under His Majesty's Commission, shall be, and are hereby, instructed to warn every Vessel which shall have commenced her Voyage prior to any Notice of this Order, and shall be destined to any Port of France, or of her Allies, or of any other Country at War with His Majelty, or to any Port or Place from which the British Flag as aforefaid is excluded, or to any Colony belonging to His Majesty's Enemies, and which shall not have cleared out as is hereinbefore allowed, to discontinue her Voyage, and to proceed to some Port or Place in this Kingdom, or to Gibraltar or Malta; and any Veffel which, after having been so warned, or after a reafonable Time shall have been afforded for the Arrival of Information of this His Majesty's Order at any Port or Place from which she failed, or which, after having Notice of this Order, shall be found in the Profecution of any Voyage contrary to the Restrictions contained in this Order, shall be captured, and, together with her Cargo, condemned as lawful Prize to the Captors:

And whereas Countries, not engaged in the War, have acquiesced in the Orders of France, prohibiting all Trade in any Articles the Produce or Manufacture of His Majesty's Dominions; and the Merchants of those Countries have given countenance and effect to those Prohibitions, by accepting from Persons styling themselves Commercial Agents of the Enemy, resident at Neutral Ports, certain Documents, termed "Certificates of Origin," being Certificates obtained at the Ports of Shipment, declaring that the Articles of the Cargo are not of the Produce or Manusacture of His Majesty's Dominions, or to that Effect:

And whereas this Expedient has been directed by France, and submitted to by such Merchants, as

Part of the new System of Warfare directed against the Trade of this Kingdom, and as the most effectual Instrument of accomplishing the same, and it is therefore essentially necessary to resist it;

His Majesty is therefore pleased, by and with the Advice of His Privy Council, to order, and it is hereby ordered, that if any Vessel, after reasonable Time shall have been afforded for receiving Notice of this His Majesty's Order at the Port or Place from which fuch Vessel shall have cleared out, shall be found carrying any such Certificate or Document as aforesaid, or any Document referring to, or authenticating the same, such Vessel shall be adjudged lawful Prize to the Captor, together with the Goods laden therein, belonging to the Person or Persons by whom, or on whose Behalf, any such Document was put on board.

And the Right Honourable the Lords Commiffioners of His Majefty's Treasury, His Majefty's Principal Secretaries of State, the Lords Commiffioners of the Admiralty, and the Judges of the High Court of Admiralty and Courts of Vice-Admiralty, are to take the necessary Measures herein, as to them shall respectively appertain.

WHEREAS Articles of the Growth and Manufacture of Foreign Countries cannot by Law be imported into this Country, except in British Ships, or in Ships belonging to the Countries of which such Articles are the Growth and Manufacture, without an Order in Council specially authorizing the same:

His Majesty, taking into Consideration the Order of this Day's Date, respecting the Trade to be carried on to and from the Ports of the Enemy, and deeming it expedient that any Vessel belonging to any Country in Alliance, or at Amity with His Majesty, may be permitted to import into this Country Articles of the Produce or Manufacture of Countries at War with His Majesty:

His Majesty, by and with the Advice of His Privy Council, is therefore pleased to order, and it is hereby ordered, that all Goods, Wares, or Mer-chandizes, fpecified and included in the Schedule of an Act, passed in the Forty-third Year of His present Majesty's Reign, intituled " An Act to re-" peal the Duties of Customs payable in Great Bri-" tain, and to grant other Duties in lieu thereof," may be imported from any Port or Place belonging to any State not at Amity with His Majesty, in Ships belonging to any State at Amity with His Majesty, subject to the Payment of such Duties, and liable to fuch Drawbacks as are now established by Law upon the Importation of the faid Goods, Wares, or Merchandize, in Ships navigated according to Law; and with respect to such of the faid Goods, Wares, or Merchandize, as are authorized to be warehoused under the Provisions of an Act, paffed in the Forty-third Year of His prefent Majesty's Reign, intituled "An Act for permitting " certain Goods imported into Great Britain, to be " fecured in Warehouses without Payment of "Duty," fubject to all the Regulations of the faid ! last mentioned Act; and with respect to all Articles which are prohibited by Law from being imported into this Country, it is ordered, that the fame thall be reported for Exportation to any Country in

Amity or Alliance with His Majesty

And His Majetty is further pleafed, by and with the Advice of His Privy Council, to order, and it is hereby ordered, That all Vessels which shall arrive at any Port of the United Kingdom, or at the Port of Gibraltar or Malta, in consequence of having been warned purfuant to the aforefaid Order, or in confequence of receiving Information, in any other Manner, of the faid Order subsequent to their having taken on board any Part of their Cargoes, whether previous or subsequent to their failing, shall be permitted to report their Cargoes for Exportation, and shall be allowed to proceed upon their Voyages to their original Ports of Destination, (if not unlawful before the iffuing of the faid Order,) or to any Port at Amity with His Majesty, upon receiving a Certificate from the Collector or Comptroller of the Customs at the Port at which they shall fo enter, (which Certificate the faid Collectors and Comptrollers of the Customs are hereby authorized and required to give,) fetting forth that such Vessels came into such Port in consequence of being so warned, or of receiving such Information as aforefaid; and that they were permitted to fail from fuch Port under the Regulations which His Majesty has been pleafed to establish in respect to such Vesfels. But in case any Vessel so arriving shall prefer to import her Cargo, then fuch Veffel shall be allowed to enter and import the same, upon such Terms and Conditions as the said Cargo might have been imported upon, according to Law, in case the faid Vessel had failed after having received Notice of the faid Order, and in conformity thereto.

And it is further ordered, that all Veffels which shall arrive at any Port of the United Kingdom, or at Gibraltar or Malta, in Conformity and Obedience to the faid Order, shall be allowed, in respect to all Articles which may be on board the fame, except Sugar, Coffee, Wine, Brandy, Snuff, and Tobacco, to clear out to any Port whatever, to be specified in fuch Clearance; and, with respect to the last mentioned Articles, to export the same to such Ports, and under fuch Conditions and Regulations only, as His Majesty, by any Licence to be granted

for that Purpose, may direct.

And the Right Honourable the Lords Commiffioners of His Majesty's Treasury, His Majesty's Principal Secretaries of State, the Lords Commisfioners of the Admiralty, and the Judges of the High Court of Admiralty and Courts of Vice-Admiralty, are to take the necessary Measures herein as to them shall respectively appertain. The KING's Most Excellent Majesty in Council.

HEREAS the Sale of Ships by a Belligerent to a Neutral is confidered by France to be illegal:

And whereas a great Part of the Shipping of France and her Allies has been protected from Capture during the present Hostilities by Transfers, or pretended Transfers, to Neutrals:

And whereas it is fully jultifiable to adopt the same Rule, in this Respect, towards the Enemy, which is applied by the Enemy to this Country :

His Majesty is pleased, by and with the Advice of His Privy Council, to order, and it is hereby ordered, That in future the Sale to a Neutral of any Vessel belonging to His Majesty's Enemies, shall not be deemed to be legal, nor in any Manner to transfer the Property, nor to alter the Character of fuch Vessel: And all Vessels now belonging, or which shall hereafter belong to any Enemy of His. Majesty, notwithstanding any Sale, or pretended Sale to a Neutral, after a reasonable Time shall have elapsed for receiving Information of this His Majesty's Order at the Place where fuch Sale, or pretended Sale, was effected, shall be captured and brought in, and shall be adjudged as lawful Prize to the Captors.

And the Right Honourable the Lords Commiffioners of His Majesty's Treasury, His Majesty's Principal Secretaries of State, the Lords Commiffioners of the Admiralty, and the Judges of the High Court of Admiralty and Courts of Vice-Admiralty, are to take the necessary Measures herein as to them shall respectively appertain. By the KING. A PROCLAMATION,

For granting the Distribution of Prizes during the present Hostilities.

GEORGE R.

WHEREAS by Our Order in Council, dated the Fourth of November instant, We have ordered that General Reprizals be granted against the Ships, Goods, and Subjects of the King of Denmark, (fave and except any Vessels to which Our Licence has been granted, or which have been directed to be released from the Embargo, and have not fince arrived at any Foreign Port:) And whereas by Our Order in Council, of the fame Date, We have ordered that General Reprizals be granted against the Ships, Goods, and Inhabitants of the Territories and Ports of Tuscany; the Kingdom of Naples; the Port and Territory of Ragufa; and those of the Islands lately composing the Republic of the Seven Islands; and all other Ports and Places in the Mediterranean and Adriatic Seas which are occupied by the Arms of France or her Allies, fo that as well Our Fleets and Ships, as also all other Ships and Veffels that shall be commisfionated by Letters of Marque or General Reprizals, or otherwife, by Our Commissioners for executing Our Office of Lord High Admiral of Great Britain, shall and may lawfully seize all Ships, Vessels, and Goods belonging to the King of Denmark, or to any of the Territories, Ports, or Places aforefaid, or to any Persons being Subjects of the King of Denmark, or inhabiting within any of the Territo-ries of Denmark, or within any of the Territories, Ports, or Places aforefaid, and bring the fame to Judgment in any of Our Courts of Admiralty within Our Dominions, duly authorized and required to take Cognizance thereof; We, being defirous to give due Encouragement to Our faithful Subjects who shall lawfully seize the same; and having declared in Council, by Our Order of the Fourth of

November instant, Our Intentions concerning the Distribution of all Manner of Captures, Seizures, Prizes, and Reprizals of all Ships and Goods during the present Hostilities, do now make known to all Our loving Subjects, and all others whom it may concern, by this Our Proclamation, by and with the Advice and Confent of Our Privy Council, that Our Will and Pleasure is, That the Neat Produce of all Prizes taken, the Right whereof is inherent in Us and Our Crown, be given to the Takers, (fave and except the Produce of fuch Prizes as are or shall be taken by Ships or Vessels belonging to, or hired by, or in the Service of, Our Commissioners of Customs or Excise, the Disposition of which We referve to our further Pleasure, and also save and except as hereinaster-mentioned;) but subject to the Payment of all fuch or the like Customs and Duties as the fame are now, or would have been, liable to, if the fame were or might have been imported as Merchandize; and that the fame may be fo given in the Proportion and Manner hereinafter fet forth; that is to fay,

That all Prizes taken by Ships and Vessels having Commissions of Letters of Marque and Reprizals, (fave and except such Prizes as are or shall be taken by the Ships or Vessels belonging to, or hired by, or in the Service of, Our Commissioners aforesaid,) may be fold and disposed of by the Merchants, Owners, Fitters, and others, to whom such Letters of Marque and Reprizals are granted, for their own Use and Benefit, after final Adjudication, and not before.

And We do hereby further order and direct, that the Neat Produce of all Prizes which are or shall be taken by any of Our Ships or Vessels of War, (save and except when they shall be acting on any conjusted Expedition with Our Army, in which Case We reserve to Ourselves the Division and Distribution of all Prize and Booty taken, and also save and except as hereinaster-mentioned;) shall be for the entire Benefit and Encouragement of Our Flag-Officers, Captains, Commanders, and other Commissioned Officers in Our Pay, and of the Seamen, Marines, and Soldiers on board Our said Ships and Vessels at the Time of the Capture; and that such Prizes may be lawfully sold and disposed of by them and their Agents, after the same shall have been to Us finally adjudged lawful Prize, and not otherwise. The Distribution shall be made as sollows:—The

Whole of the Neat Produce being first divided into Eight equal Parts,

The Captain or Captains of any of Our faid Ships or Vessels of War, who shall be actually on board at the Taking of any Prize, shall have Three Eighth Parts; but in case any such Prize shall be taken by any of Our Ships or Vessels of War, under the Command of a Flag or Flags, the Flag-Officer or Officers being actually on board, or directing and assisting in the Capture, shall have One of the Three Eighth Parts; the said One Eighth Part to be paid to such Flag or Flag-Officers in such Proportions, and subject to such Regulations, as are hereinaster-mentioned.

The Captains of Marines and Land Forces, Sea Lieutenants, and Master, on board, shall have One Eighth Part, to be equally divided amongst them: But that every Physician appointed, or hereafter to be appointed, to a Fleet or Squadron of Our Ships of War, shall, in the Distribution of Prizes which shall hereafter be taken by the Ships in which he shall serve, or in which such Ship's Company shall be entitled to share, be classed with the Sea Lieutenants with respect to the said One Eighth Part, and be allowed to share equally with them; provided such Physician be actually on board at the Time of taking such Prizes.

The Lieutenants and Quarter-Masters of Marines, and Lieutenants, Enligns, and Quarter-Masters of Land Forces, Secretaries of Admirals or of Commodores (with Captains under them), Second Masters of Line of Battle Ships, Boatswains'-Gunners, Pursers, Carpenters, Masters'-Mates, Chirurgeons, Pilots, and Chaplains, on board, shall have One Eighth Part, to be equally divided amongst them.

The Midshipmen, Captains'-Clerks, Master Sailmakers, Capenters'-Mates, Boatswains'-Mates, Gunners'-Mates, Masters at Arms, Corporals, Yeomen of the Sheets, Coxswains, Quarter-Masters, Quarter-Masters, Quarter-Masters, Yeomen of the Powder-Room, Serjeants of Marines and Land Forces, on board, shall have One Eighth Part, to be equally divided amongst them.

The Trumpeters, Quarter-Gunners, Carpenters'-Crew, Stewards, Cook, Armourers, Stewards'-Mates, Cook's-Mates, Gunfmiths, Coopers, Swabbers, Ordinary Trumpeters, Barbers, Able Seamen, Ordinary Seamen, and Marines and other Soldiers, and all other Perfons doing Duty and affilting on board, shall have Two Eighth Parts, to be equally divided amongst them.

And We do hereby further order, that in the Cafe of Cutters, Schooners, and other Armed Veffels, commanded by Lieutenants, the Share of fuch Lieutenants shall be Three Eighth Parts of the Prize, unless such Lieutenants shall be under the Command of a Flag-Officer or Officers; in which Cafe, the Flag-Officer or Officers shall have One of the faid Three Eighths, to be divided among fuch Flag-Officer or Officers in the fame Manner herein-before directed in the Case of Captains serving under Flag-Officers. Secondly, We direct that the Share of the Master, or other Person acting as Second in Command, and the Pilot, (if there happens to be one on board,) shall be One Eighth Part, to be divided into Three equal Parts, of which Two-Thirds fhall go to the Mafter, or other Person acting as Second in Command, and the remaining One-Third to the Pilot; but if there is no Pilot, then fuch Eighth Part to go wholly to the Master, or Person acting as Second in Command .- That the Share of the Chirurgeon, or Chirurgeon's-Mate, (where there is no Chirurgeon,) Midshipmen, Clerk, and Steward, shall be One-Eighth.—That the Share of the Boatfwains, Gunners, and Carpenters'-Mates, Yeomen of the Sheets, Sailmaker, Quarter-Master, and Quarter-Master's Mate, shall be One-Eighth.—And the Share of the Seamen, Marines, and other Persons on board, affifting in the Capture, shall be Two Eighth

But it is Our Intention, nevertheless, that the above Distribution shall only extend to such Captures as shall be made by any Cutter, Schooner, or Armed Vessel, without any of Our Ships or Vessels of War being present, or within Sight of, and adding to the Encouragement of the Captors, and Terror of the



Enemy; but in case any of Our Ships or Vessels of War shall be present, or in Sight, that then the Officers, Pilots, Petty Officers, and Men on board fuch Cutters and Schooners, or Armed Veffels, shall share in the fame Proportion as is allowed to Persons of the like Rank and Denomination on board of Our Ships and Vessels of War; and fuch Cutters, Schooners, or Armed Vessels shall not, in respect to fuch Captures, convey any Interest or Share in the Flag Eighth to the Flag Officer or Officers under whose Orders such Cutters, Schooners, and Armed Vessels may happen to be; and whereas it is judged expedient, during the present Hostilities, to hire into Our Service Armed Vessels, to be employed as Cruizers against the Enemy, which Vessels are the Property of, and their Mafters and Crews are paid by, the Merchants of whom they are hired, although feveral of them are commanded by Our Commif-fioned Officers in Our Pay, it is Our further Will and Pleasure that the Neat Produce of all Prizes taken by fuch Hired Armed Vessels, (except as hereinaster-mentioned,) shall be for the Benesit of Our Commissioned Officers in Our Pay, and of the Masters and Crews on board the said Hired Armed Vessels at the Time of the Capture; and that such Prizes may be lawfully fold and disposed of by them and their Agents, after the fame shall have been to Us finally adjudged lawful Prize, and not otherwise; the Distribution whereof shall be as follows:-The Whole of the Neat Produce being divided into Eight equal Parts,

Our Officer commanding any Hired Armed Veffel, who shall be actually on board at the Taking of any Prize, shall have Three-Eighths; but in case fuch Hired Armed Veffel shall be under the Command of a Flag or Flags, the Flag-Officer or Officers being actually on board, or directing and affifting in the Capture, shall have One of the faid Three Eighth Parts ; the faid One Eighth Part to be paid to such Flag or Flag-Officers in such Proportions, and fubject to fuch Regulations, as are hereinafter-mentioned .- In case there be acting on board fuch Hired Armed Veffel, befides Our Officer commanding the fame, One or more of Our Commissioned Sea Lieutenants in Our Pay, fuch Lieutenant or Lieutenants shall take One-Eighth .- One Eighth shall belong to the Mafter and Mate; of which the Mafter shall take Two-Thirds, and the Mate One-Third: But in case there shall be acting on board such Hired Armed Vessel One or more Midshipmen, or other Person in Our Pay, of those who are classed with Midshipmen in the former Part of this Our Proclamation, in that Cafe the Master shall take Ohe-Half of the Eighth, and the other Half shall be equally divided between the Mate, Midshipmen, and such other Persons in Our Pay.—Three-Eighths shall belong to and be divided among the other Officers and the rest of the Crew .- And, in the Cafe of Prizes taken by any Hired Armed Veffel not commanded by any of Our Commis-fioned Officers, One-Eighth shall belong to the Flag-Officers, to be divided as aforesaid, in case fuch Hired Armed Veffel shall be under the Command of a Flag .- Two Eighths shall belong to the Master and Mate; of which the Master shall take Two-Thirds, and the Mate One-Third .-Three-Eighths shall belong to and be divided among the other Officers and the rest of the

Crew, in Manner aforesaid .- The Surplus, the Distribution of which is not herein directed, shall remain at Our Disposal; and if not disposed of within a Year after final Adjudication, the same shall belong and be paid to Greenwich Hospital, -And in the Case of Prizes taken jointly, by any of Our Ships of War, and any Hired Armed Veffel, Our Commissioned Officer or Officers on board such Hired Armed Vessel shall share with Our Commissioned Officer or Officers of the same Rank on board Out Ship or Ships of War, being joint Captors; the Mafter of fuch Hired Armed Vessel shall share with the Warrant Officers; the Mate of fuch Hired Armed Vellel with the Petty Officers; and the Seamen of fuch Hired Armed Vellel with the Seamen on board Our faid Ship or Ships of War; fave and except, that, in cafe fuch Hired Armed Vessel shall be commanded by One of Our Commissioned Officers having the Rank of Master and Commander, and there shall be none of Our Lieutenants on board; or in cafe fuch Hired Armed Veffel shall be commanded by the Master, in both those Cases the Master of such Hired Armed Veffel shall share with the Lieutenants of Our Ships of War, and the Mate with the Warrant Officers .- And in cafe any Difficulty shall arise in Respect to the said Distribution, not herein sufficiently provided for, the same shall be referred to Our Lords Commissioners of the Admiralty, whose Direction thereupon shall be final, and have the same Force and Effect as if herein inserted: Provided that if any Officer, being on board any of Our Ships of War at the Time of taking any Prize, shall have more Commissions or Offices than one, such Officer shall be entitled only to the Share or Shares of the Prizes which, according to the abovementioned Distribution, shall belong to his fuperior Commission or Office. - Provided also, that in all Prizes taken by any of Our Squadrons, Ships, or Veffels, while acting in Conjunction with any Squadron, Ship, or Veffel of any other Power that may be in Alliance with Us, a Share of fuch Prizes shall be set apart, and be at Our further Disposal, equal to that Share which the Flag and other Officers and Crews of fuch Squadron, Ships, or Veffels would have been entitled to if they had belonged to Us.

And We do hereby strictly enjoin all Commanders of Our Ships and Vessels of War taking any Prize, to transmit, as soon as may be, or cause to be transmitted, to the Commissioners of Our Navy, a true Lift of the Names of all the Officers, Seamen, Marines, Soldiers, and others, who were actually on board Our Ships and Vessels of War under their Command at the Time of the Capture; which Lift shall contain the Quality of the Service of each Person on board, together with the Description of the Men, taken from the Description-Books of the capturing Ship or Ships, and their feveral Ratings, and be subscribed by the Captain or Commanding Officer, and Three or more of the Chief Officers on And We do hereby require and direct the Commissioners of Our Navy, or any Three or more of them, to examine, or cause to be examined, such Lists, by the Muller Books of such Ships and Vesfels of War, and Lists annexed thereto, to fee that fuch Lifts do agree with the faid Muster Books and annexed Lists, as to the Names, Qualities, or Ratings of the Officers, Seamen, Marines, Soldiers, and

others, belonging to such Ships and Vessels of War; and, upon Request, forthwith to grant a Certificate of the Truth of any List transmitted to them, to the Agents nominated and appointed by the Captors, to take care and dispose of such Prize; and also, upon Application to them (the faid Commissioners), they shall give, or cause to be given, to the faid Agents, all such Lists from the Muster-Books of any such Ships of War, and annexed Lists, as the said Agents shall sind requisite for their Direction in paying the Produce of such Prizes; and otherwise shall be aiding and affishing to the said Agents in all such Matters as shall be necessary—We do hereby surther will and direct, that the following Regulations shall be observed concerning the One-Eighth Part hereinbefore mentioned, to be granted to the Flag or Flag Officers who shall actually be on board at the taking of any Prize, or shall be

directing or affilling therein:
First, That a Captain of a Ship shall be deemed to be under the Command of a Flag, when he shall actually have received fome Order directly from, or be acting in execution of, fome Order iffued by a Flag-Officer; and shall be deemed to continue under the Command of fuch Flag, fo long as the Flag-Officer by whom the Order was iffued, or any other Flag-Officer acting upon the same Station, shall continue upon fuch Station; or until fuch Captain shall have received some Order directly from, or be acting in execution of, some Order issued by some other Flag-Officer, or the Lords Commissioners of the Admiralty .- Secondly, That a Flag-Officer, Commander in Chief, when there is but One Flag-Officer upon Service, fhall have to his own Use the faid One-Eighth Part of the Prizes taken by Ships and Veffels under his Command .- Thirdly, That a Flag-Officer fent to command on any Station shall have no Right to any Share of Prizes taken by Ships or Veilels employed there, before he arrives within the Limits of fuch Station, and actually takes upon him the Command, by communicating Orders to the Flag-Officer previously in Command; fave only that he shall be entitled to a Share of Prizes taken by those particular Ships to which he shall actually have given fome Order, and taken under his Command within the Limits of fuch Station .-Fourthly, That a Commander in Chief, or other Flag-Officer, appointed or belonging to any Station, and paffing through or into any other Station, shall not be entitled to share in any Prize taken out of the Limits of the Station to which he is appointed or belongs, by any Ship or Veffel under the Command of a Flag-Officer of any other Station, or under Admiralty Orders; unless fuch Commander in Chief, or Flag-Officer, is expressly authorized by the Lords Commissioners of the Admiralty to take upon him the Command in that Station in which the Prize is taken, and shall actually have taken upon him fueh Command in Manner aforesaid. -Fifthly, That when an inferior Flag-Officer is fent to reinforce a superior Flag Officer on any Station, the fuperior Flag-Officer shall have no Right to any Share of Prizes taken by the inferior Flag-Officer before the inferior Flag Officer shall arrive within the Limits of the Station, and, more-over, shall actually receive some Order directly from him, or be acting in execution of some Order issued by him .- Sixthly, That a Chief Flag-Officer quitting a Station, either to return Home or to assume

another Command, or otherwise, except upon fome particular urgent Service, with the Intention of returning to the Station as foon as fuch Service is performed, shall have no Share of Prizes taken by the Ships or Veffels left behind, after he shall have passed the Limits of the Station, or after he shall have furrendered the Command to another Flag-Officer, appointed by the Admiralty to be Commander in Chief upon fuch Station.—Seventhly, That an in-ferior Flag Officer quitting a Station, except when detached by Orders from his Commander in Chief, out of the Limits thereof upon a special Service, with Orders to return to fuch Station as foon asfuch Service is performed, shall have no Share in Prizes taken by the Ships and Vessels remaining on the Station, after he shall have passed the Limits thereof; and, in like Manner, the Flag-Officers re-maining on the Station shall have no Share of the Prizes taken by fuch inferior Flag Officer, or by the Ships and Veffels under his immediate Command, after he shall have quitted the Limits of the Station, except when detached as aforefaid.—Eighthly, That when Veffels under the Command of a Flag, which belong to separate Stations, shall happen to be joint Captors, the Captain of each Ship shall pay One-Third of the Share to which he is entitled, to the Flag-Officers of the Station to which he belongs; but the Captains of Vessels under Admiralty Orders, being joint Captors with other Veffels under a Flag, shall retain the Whole of their Share.—Ninthly, That if a Flag-Officer is fent to command in the Out-Ports of this Kingdom, he shall have no Share of the Prizes taken by Ships or Vessels which have failed, or shall fail, from that Port by Order from the Admiralty.—Tenthly, That when more Flag-Officers than One serve together, the Eighth Part of the Prizes taken by any Ships or Vessels of the Fleet or Squadron shall be divided in the following. Proportions, viz. If there be but Two Flag-Officers, the Chief shall have Two-Third Parts of the faid One-Eighth, and the other shall have the re-maining Third Part; but if the Number of Flag-Officers be more than Two, the Chief shall have only One-Half, and the other Half shall be equally divided among the other Flag. Officers .- Eleventhly, That Commodores, with Captains under them, shall be esteemed as Flag Officers with respect to the Eighth Part of Prizes taken, whether command-ing in Chief, or serving under Command.—Twelfthly, That the First Captain to the Admiral, and Commander in Chief of Our Fleet, and also the First Captain to Our Flag-Officer, appointed, or hereafter to be appointed, to command a Flect or Squadron of Ten Ships of the Line of Battle, or upwards, shall be deemed and taken to be a Flag-Officer, and shall be entitled to a Part or Share of Prizes as the Junior Flag-Officer of fuch Fleet or Squadron.

Copy of a Letter from Vice-Admiral Russell, Commander in Chief of His Majesty's Ships and Vessels off the Texel, to the Honourable W. W. Pole, dated on board His Majesty's Ship Majestic, Yarmouth Roads, the 14th Infant.

HEREWITH inclose a Letter from the Right Honourable Lord George Stuart, Captain of His Majesty's Ship L'Aimable, reporting to me that he has captured La Decidé, a French Privateer, which I beg you will be pleafed to lay before my Lords Commissioners of the Admiralty.

I am, &c. T. M. RUSSELL.

His Majesty's Ship L' Aimable, in Yarmouth SIR, Roads, November 13, 1807.

I BEG Leave to inform you, that on the 11th Instant at Daylight, (the Vlie Island then bearing S. 22 Deg. E. Distance Seventy-two Miles,) we perceived a Lugger bearing South of us, Distance about Seven Miles, but it being nearly calm, we were unable to chace; however, were fortunate enough to get the Breeze about One o'Clock, and I have great Satisfaction in acquainting you, that after a Chace of Five Hours, we succeeded in capturing her. She proves to be La Decidé, a beautiful large French Lugger Privateer, mounting Sixteen Guns, with a Complement of Fifty-one Men, (out from Dunkirk Three Days,) but having only Thirty-feven on board, the Rest being away in the Mary Transport, marked J. Z. (her only Capture this Cruife,) which she succeeded in taking the Day before at Two o'Clock, having on board Nine Artillery Drivers and Six Horses, from Copenhagen.

Though we had not the good Fortune to fall in with the Transport, I have the Pleasure to state, that we have found the Troops and Seamen on board the Lugger, with the Mafter of the Veffel.

The taking of this Lugger will, I truft, be of confiderable Import, as fhe is confidered the fastest failing Vessel out of Dunkirk, and has escaped the Vigilance of our Cruifers for the last Three Years pail, and has done confiderable Damage to the Trade during that Time.

His Majefly's Sloop Oberon, Yarmouth Roads, SIR, November 14, 1807.

I BEG Leave to acquaint you, for the Information of my Lords Commissioners of the Admiralty, that Yesterday at Half-past Eight A. M. Lowe-stoffe bearing W. by N. Distance Ten Leagues, I

Fell in with, and after a Chace of Four Hours, captured the French Lugger Privateer Ratafia, of Dunkirk, carrying Fourteen Guns, (only Two of which were mounted, the Rest in the Hold.) and Thirty-cight Men, commanded by Gilbert Lafozeste, a Lieutenant in the French Navy. She failed from Delfzyb, in the River Ems, the oth Instant, and, am happy to say, she has made no Captures. From the Number of Prisoners I thought it necessary to return to these Roads.
