- The Captains of Marines and Land Forces, Sea Lieutenants, and Mafter, on board, fhall have One Eighth Part, to be equally divided amongft them : But that every Phylician appointed, or hereafter to be appointed, to a Fleet or Squadron of Our Ships of War, fhall, in the Diftribution of Prizes, which fhall hereafter be taken by the Ships in which he fhall ferve, or in which fuch Ship's Company fhall be entitled to fhare, be claffed with the Sea Lieutenants with refpect to the faid One Eighth Part, and be allowed to fhare equally with them; provided fuch Phylician be actually on board at the Time of taking fuch Prizes.
- The Lieutenants and Quarter-Masters of Marines, and Lieutenants, Ensigns, and Quarter-Masters of Land Forces, Secretaries of Admirals or of Commodores (with Captains under them), Second Masters of Line of Battle Ships, Boatswains, Gunners, Purfers, Carpenters, Masters'-Mates, Chirurgeons, Pilots, and Chaplains, on board, shall have One Eighth Part, to be equally divided amongst them.
- The Midshipmen, Captains'-Clerks, Master Sailmakers, Carpenters'-Mates, Boatswains'-Mates, Gunners'-Mates, Masters at Arms, Corporals, Yeomen of the Sheets, Coxfwains, Quarter-Masters, Quarter-Masters'-Mates, Chirurgeons'-Mates, Yeomen of the Powder-Room, Serjeants of Marines and Land Forces, on board, shall have One Eighth Part, to be equally divided amongst them.
- The Trumpeters, Quarter-Gunners, Carpenters'-Crew, Stewards, Cook, Armourers, Stewards'-Mates, Cook's-Mates, Gunſmiths, Coopers, Swabbers, Ordinary Trumpeters, Barbers, Able Seamen, Ordinary Seamen, and Marines and other Soldiers, and all other Perfons doing Duty and affifting on board, shall have Two Eighth Parts, to be equally divided amongst them.

And We do hereby further order, that in the Cafe of Cutters, Schooners, and other Armed Veffels, commanded by Lieutenants, the Share of fuch Lieutenants shall be Three Eighth Parts of the Prize, unless such Lieutenants shall be under the Command of a Flag-Officer or Officers; in which Cafe, the Flag-Officer or Officers shall have One of the faid Three-Eighths, to be divided among fuch Flag-Officer or Officers in the fame Manner hereinbefore directed in the Cafe of Captains ferving under Flag-Officers. Secondly, We direct that the Share of the Master, or other Person acting as Second in Command, and the Pilot, (if there happens to be one on board,) shall be One Eighth Part, to be diwided into Three equal Parts, of which Two-Thirds shall go to the Matter, or other Person acting as Second in Command, and the remaining One Third to the Pilot; but if there is no Pilot, then fach Eighth Part to go wholly to the Maller, or Person acting as Second in Command .- That the Share of the Chirurgeon, or Chirurgeon's-Mate, (where there is no Chirurgeon,) Midshipmen, Clerk, and Steward, shall be One-Eighth.-That the Share of the Buatfwains, Gunners, and Carpenters'-Mates, Yeomen of the Sheets, Sailmaker, Quarter-Malter, and Quar-ter-Malter's-Mate, shall be One-Eighth .- And the Share of the Seamen, Marines, and other Perfons on board, affilting in the Capture, shall be Two Eighth Parts.

But it is Our Intention, neverthelefs, that the

above Distribution shall only extend to fuch Captures as shall be made by any Cutter, Schooner, or Armed Veffel, without any of Our Ships or Veffels of War being prefent, or within Sight of, and adding to the Encouragement of the Captors, and Terror of the Enemy; but in cafe any of Our Ships or Veffels of War shall be present, or in Sight, that then the Officers, Pilots, Petty Officers, and Men on board fuch Cutters and Schooners, or Armed Veffels, shall fhare in the fame Proportion as is allowed to Perfous of the like Rank and Denomination on board of Our Ships and Veffels of War; and fuch Cutters, Schooners, or Armed Veffels shall not, in respect to fuch Captures, convey any Interest or Share in the Flag Eighth to the Flag Officer or Officers under whofe Orders fuch Cutters, Schooners, and Armed Veffels may happen to be ; and whereas it is judged expedient, during the prefent Holtilities, to hire into Our Service Armed Veffels, to be employed as Cruizers against the Enemy, which Vessels are the Property of, and their Mafters and Crews are paid by, the Merchants of whom they are hired, although feveral of them are commanded by Our Commiffioned Officers in Our Pay, it is Our further Will and Pleasure that the Neat Produce of all Prizes taken by fuch Hired Armed Veffels, (except as hereinafter-mentioned,) shall be for the Benefit ot Our Commissioned Officers in Our Pay, and of the Masters and Crews on board the faid Hired Armed Veffels ät the Time of the Capture ; and that fuch Prizes may be lawfully fold and difpofed of by them and their Agents, after the fame shall have been to Us finally adjudged lawful Prize, and not otherwife; the Diftribution whereof shall be as follows :- The Whole of the Neat Produce being divided into Eight equal Parts,

Our Officer commanding any Hired Armed Veffel, who shall be actually on board at the Taking of any Prize, shall have Three Eighths; but in cafe fuch Hired Armed Veffel shall be under the Command of a Flag or Flags, the Flag-Officer or Officers being actually on board, or directing and affilting in the Capture, shall have One of the faid Three Eighth Parts ; the faid One Eighth Part to be paid to fuch Flag or Flag. Officers in fuch Proportions, and fubject to fuch Regulations, as as hereinafter-mentioned. - In cafe there be acting on board fuch Hired Armed Veffel, belides. Our Officer commanding the fame, One or more of Our Commiffioned Sea Lieutenants in Our Pay, fuch Lieutenant or Lieutenants shall take One Eighth.-One Eighth shall belong to the Master and Mate; of which the Master shall take Two-Thirds, and the Mate One-Third : But in cafe there shall be acting on board such Hired Armed Veffel One or more Midshipmen, or other Perfon in Our Pay, of those who are classed with Midshipmen in the former Part of this Our Proclamation, in that Cafe the Malter shall take One-Half of the Eighth, and the other Half shall be equally divided between the Mate, Midshipmen, and fuch other Persons in Our Pay.-Three-Eighths shall belong to and be divided among the other Officers and the reft of the Crew .- And, in the Cafe of Prizes taken by any Hired Armed Veffel not commanded by any of Our Commiffioned Officers, One-Eighth shall belong to the Flag Officers, to be divided as aforefaid, in cafe fuch Hired Armed Veffel shall be under the Com-
