The Speech of the Lords Commissioners to both Houses of Parliament, on Thursday, January 21, 1808.

My Lords, and Gentlemen,

WE have received His Majesty's Commands to assure you, that in calling you together at this important Conjunction of Affairs, He entertains the most perfect Conviction that He shall find in you the same Determination with which His Majesty Himself is animated, to uphold the Honour of His Crown, and the just Rights and Interests of His People.

We are commanded by His Majesty to inform you, that no sooner had the Result of the Negotiations at Tilsit confirmed the Influence and Controul of France over the Powers of the Continent, than His Majesty was apprized of the Intention of the Enemy to combine those Powers in one general Confederacy, to be directed either to the entire Subjugation of this Kingdom, or to the imposing upon His Majesty an insecure and ignominious Peace.

That, for this Purpose, it was determined to force into Hostility against His Majesty, States which had hitherto been allowed by France to maintain or to purchase their Neutrality, and to bring to bear against different Points of His Majesty's Dominions the Whole of the Naval Force of Europe, and specifically the Fleets of Portugal and Denmark. To place those Fleets out of the Power of such a Confederacy became therefore the indispensable Duty of His Majesty.

In the Execution of this Duty, so far as related to the Danish Fleet, His Majesty has commanded us to assure you, that it was with the deepest Reluctance that His Majesty found Himself compelled, after His earnest Endeavours to open a Negotiation with the Danish Government had failed, to authorize His Commanders to resort to the Extremity of Force; but that He has the greatest Satisfaction in congratulating you upon the successful Execution of this painful but necessary Service.

We are commanded farther to acquaint you, that

the Course which His Majesty had to pursue with respect to Portugal was happily of a Nature more congenial to His Majesty's Feelings: That the timely and unreserved Communication by the Court of Lisbon of the Demands and Designs of France, while it confirmed to His Majesty the Authenticity of the Advices which He had received from other Quarters, entitled that Court to His Majesty's Confidence in the Sincerity of the Assurances by which that Communication was accompanied.

The Fleet of Portugal was destined by France to be employed as an Instrument of Vengeance against Great Britain; that Fleet has been secured from the Grasp of France, and is now employed in conveying to its American Dominions the Hopes and Fortunes of the Portuguese Monarchy.

His Majesty implores the Protection of Divine Providence upon that Enterprize, rejoicing in the Preservation of a Power so long the Friend and Ally of Great Britain, and in the Prospect of its Establishment in the New World with augmented Strength and Splendour.

We have it in Command from His Majesty to inform you, that the Determination of the Enemy to excite Hostilities between His Majesty and His late Allies, the Emperors of Russia and Austria, and the King of Prussia, has been but too successful; and that the Ministers from those Powers have demanded and received their Passports.

This Measure, on the Part of Russia, has been attempted to be justified by a Statement of Wrongs and Grievances which have no real Foundation. The Emperor of Russia had indeed proffered his Mediation between His Majesty and France; His Majesty did not refuse that Mediation; but He is confident you will feel the Propriety of its not having been accepted, until His Majesty should have been enabled to ascertain that Russia was in a Condition to mediate impartially, and until the Principles and the Basis on which France was ready to negotiate were made known to His Majesty.

No Pretence of Justification has been alleged for the hostile Conduct of the Emperor of Austria, or for that of His Prussian Majesty. His Majesty has not given the slightest Ground of Complaint to either of those Sovereigns, nor even at the Moment when they have respectively withdrawn their Ministers, have they assigned to His Majesty any distinct Cause for that Proceeding.

His Majesty has directed that Copies of the Official Notes which passed between His Majesty's Ambassador and the Minister for Foreign Affairs of His Imperial Majesty the Emperor of Russia, pending the Negotiations at Tilsit, as well as of the Official Note of the Russian Minister at this Court, which contain the Offer of His Imperial Majesty's Mediation, and of the Answer returned to that Note by His Majesty's Command; and also Copies of the Official Notes of the Austrian Minister at this Court, and of the Answers which His Majesty commanded to be returned to them, shall be laid before you.

It is with Concern that His Majesty commands us to inform you, that notwithstanding His earnest Wishes to terminate the War in which He is engaged with the Ottoman Porte, His Majesty's Endeavours, unhappily for the Turkish Empire, have been defeated by the Machinations of France, not less the Enemy of the Porte than of Great Britain.

But while the Influence of France has been thus unfortunately successful in preventing the Termination of existing Hostilities, and in exciting new Wars against this Country, His Majesty commands us to inform you, that the King of Sweden has resisted every Attempt to induce him to abandon his Alliance with Great Britain; and that His Majesty entertains no Doubt that you will feel with Him the Sacredness of the Duty which the Firmness and Fidelity of the King of Sweden impose upon His Majesty, and that you will concur in enabling His Majesty to discharge it in a Manner worthy of this Country.

It remains for us, according to His Majesty's Commands, to state to you, that the Treaty of Amity, Commerce, and Navigation between His Majesty and the United States of America, which was concluded and signed by Commissioners, duly authorized for that Purpose, on the 31st of December 1806, has not taken Effect, in consequence of the Refusal of the President of the United States to ratify that Instrument.

For an unauthorized Act of Force committed against an American Ship of War, His Majesty did not hesitate to offer immediate and spontaneous Reparation: But an Attempt has been made by the American Government to connect with the Question, which has arisen out of this Act, Pretensions inconsistent with the maritime Rights of Great Britain: Such Pretensions His Majesty is determined never to admit. His Majesty nevertheless hopes, that the American Government will be actuated by the same

Desire to preserve the Relations of Peace and Friendship between the Two Countries, which has ever influenced His Majesty's Conduct, and that any Difficulties in the Discussion now depending may be effectually removed.

His Majesty has commanded us to state to you, that in consequence of the Decree by which France declared the Whole of His Majesty's Dominions to be in a State of Blockade, and subjected to Seizure and Confiscation the Produce and Manufactures of His Kingdom, His Majesty resorted in the first Instance to a Measure of mitigated Retaliation; and that this Measure having proved ineffectual for its Object, His Majesty has since found it necessary to adopt others of greater Rigour, which He commands us to state to you will require the Aid of Parliament to give them complete and effectual Operation.

His Majesty has directed Copies of the Orders which He has issued (with the Advice of His Privy Council) upon this Subject, to be laid before you; and He commands us to recommend them to your early Attention.

Gentlemen of the House of Commons,

His Majesty has directed the Estimates for the Year to be laid before you, in the fullest Confidence that your Loyalty and public Spirit will induce you to make such Provision for the public Service as the Urgency of Affairs may require.

His Majesty has great Satisfaction in informing you, that notwithstanding the Difficulties which the Enemy has endeavoured to impose upon the Commerce of His Subjects, and upon their Intercourse with other Nations, the Resources of the Country have continued in the last Year to be so abundant, as to have produced both from the permanent and temporary Revenue a Receipt considerably larger than that of the preceding Year.

The Satisfaction which His Majesty feels assured you will derive, in common with His Majesty, from this Proof of the Solidity of these Resources, cannot but be greatly increased, if, as His Majesty confidently hopes, it shall be found possible to raise the necessary Supplies for the present Year without any material Addition to the public Burdens.

My Lords, and Gentlemen,

We are especially commanded to say to you, in the Name of His Majesty, that if ever there was a just and national War, it is that which His Majesty is now compelled to prosecute.

This War is in its Principle purely defensive: His Majesty looks but to the Attainment of a secure and honourable Peace; but such a Peace can only be negotiated upon a Footing of perfect Equality.

The Eyes of Europe and of the World are fixed upon the British Parliament. If, as His Majesty confidently trusts, you display in this Crisis of the Fate of the Country, the characteristic Spirit of the

British Nation, and face unappalled the unnatural Combination which is gathered around us, His Majesty bids us to assure you of His firm Persuasion, that, under the Blessing of Divine Providence, the Struggle will prove ultimately successful and glorious to Great Britain.

We are lastly commanded to assure you, that in this awful and momentous Contest you may rely upon the Firmness of His Majesty, who has no Cause but that of His People; and that His Majesty reciprocally relies upon the Wisdom, the Constancy, and the affectionate Support of His Parliament.

The KING's Most Excellent Majesty in Council.

WHEREAS it is expedient in the present State of the Subjects of Her Most Faithful Majesty, and during the Interruption in Commercial Correspondence between Great Britain and Portugal, that Claims should be permitted to be given for Portuguese Property brought in and detained by His Majesty's Ships of War and Privateers; His Majesty is pleased, by and with the Advice of His Privy Council, to order, and it is hereby ordered, that Claims for Portuguese Property, given by Persons duly authorized by the Owners, or by the Consul or other Person authorized by the Portuguese Minister resident at this Court, shall be admitted in the High Court of Admiralty; and it is further ordered, that immediate Restitution shall pass of all such Property as shall appear by the Bills of Lading or other Documents found on board Portuguese Ships, coming from Portuguese Settlements to the Ports of Portugal, to belong to Her Most Faithful Majesty, or to any of Her Subjects residing at the Date of this Order, in the Brazils, or in any Foreign Settlement belonging to Her Crown, or in England, or in any Country in Amity with His Majesty, upon a general Claim for every such Ship and Goods, given by the Consul under the Authority aforesaid: And it is further ordered, that the Property of the Subjects of Her Most Faithful Majesty, at the Date of this Order, residing in Portugal, either belonging to them separately, or jointly with Subjects residing in the Brazils, or other Places beforementioned, shall be pronounced to belong as claimed, upon a general Claim given for the same on board such Portuguese Ships as aforesaid: And it is further ordered, that the Property last-mentioned, as well as all other Property, under private Claims

already given or to be given, and pronounced to be Portuguese Property, and belonging to Persons resident in Portugal at the Date of this Order, shall remain subject to His Majesty's further Orders; and, in the mean Time, shall be put into the Joint Custody of Agents to be named on Behalf of His Majesty, and on Behalf of the Portuguese Minister resident at this Court, or of any Claimant; and that such Parts thereof as are perishable, or which it may be otherwise expedient to sell, shall be sold by the aforesaid Agents, under Commissions to be issued by the High Court of Admiralty, and the Proceeds thereof deposited in the said Court: — And the Right Honourable the Lords Commissioners of His Majesty's Treasury, His Majesty's Principal Secretaries of State, the Lords Commissioners of the Admiralty, and the Judges of the High Court of Admiralty and Courts of Vice-Admiralty, are to take the necessary Measures herein as to them shall respectively appertain. *W. Copy of a Letter from Admiral Montagu, Commander in Chief of His Majesty's Ships and Vessels at Portsmouth and Spithead, to the Honourable W. W. Pole, dated on board the Royal Wilham, at Spithead, the 20th Instant.

SIR,

I HAVE the Honour to inclose, for the Information of my Lords Commissioners of the Admiralty, a Letter which I have received from Lieutenant Tracey, commanding the Linnet Brig, giving an Account of the Capture of La Courier, French Lugger Privateer, which shews much Judgment and Gallantry in that Officer.

SIR,

I HAVE the Honour to inform you, on Saturday the 16th Instant, Cape Barfleur W. by N. Six or Seven Leagues, I saw a French Lugger in chace of an English Ship and Brig: The Two latter I immediately joined, and thought proper to run in Company with them until Night should favour my closing with the Lugger. At half-past Six P. M. the Lugger commenced a Fire on the Ship, which she gallantly returned. At Seven the Lugger attempted to haul off; but my being within Musket-shot rendered his Attempt fruitless. Ten Minutes past Seven I fired a Broadside of Round and Grape, with a Volley of Musketry, which carried away his Bow-sprit and Main Lugg. I then hailed him to strike; instead of which she hoisted her Lugg. I then commenced a steady Fire, which lasted One Hour and a Half, (with Round, Grape, and Musketry;) during which Time her Luggs were knocked down, and as often hoisted, (at least Ten Times.) Fifty Minutes past Eight, being in a sinking State, hailed she had struck: proves to be Le Courier of Cherbourg, commanded by Captain Alex. Black, mounting Eighteen Guns, with a Complement of Sixty Men; Second Captain of which was killed, and Three Seamen wounded; sails remarkably fast; out Four Days; made no Capture; but came from under the Isles of Marcou at Eleven A. M. this Instant, where she anchored for Shelter from the late Gale.

I am happy to add we sustained no Loss, and that the Conduct of my Officers and Ship's Company merit my warmest Praise.

North Foreland W. Six Leagues,
January 14, 1808.

SIR,

I AM happy to inform you, that about Ten Minutes before Eight o'Clock last Evening, Folkitone bearing N. N. W. Six or Seven Miles, I fell in with the *L'Entreprenant*, French Privateer Lugger, of Sixteen Guns and Fifty-eight Men, commanded by Captain Bloudin, which, after a Chace of an Hour and Forty Minutes, we had the good Fortune to come up with and capture within Two Miles of the French Shore, Cape Grifnez bearing South. From his being so very close to his own Coast, (the Batteries firing over us,) he persevered in his Attempt to escape, till our Musketry had wounded the Captain, the Second Captain, and Four or Five Men, and would not shorten Sail till we run alongside of him. She has been out Three Days from Calais, and has taken the *Mary Brig* of Sunderland. She is a very fine large new Lugger, and sails exceedingly fast. The Active Cutter joined in the Chace, and assisted in removing the Prisoners.

To the KING's Most Excellent Majesty,

The humble Address of the Lord Provost, Magistrates, and Council of the City of Edinburgh, in Council assembled.

Most Gracious Sovereign,

WE, your Majesty's most loyal and dutiful Subjects, the Lord Provost, Magistrates, and Council of the City of Edinburgh, beg Leave to address your Majesty at this Period so interesting to

your Majesty's Kingdoms, and to the whole Nations of Europe.

We are not insensible of the Evils to which we are exposed, or of the Dangers with which we are threatened. We cannot and we do not wish to disguise from ourselves that the War in which your Majesty is engaged has been distinguished by Perils hitherto unknown to the civilized World. But it can never be forgotten that this War was not undertaken from Views of Ambition and Conquest, but for the just and necessary Purpose of defending the Honour of your Majesty's Crown, and the Liberty and Dignity of your People, against the presumptuous Usurpations of a Power, whose unceasing Aim, amid the Variety and Extent of its Designs against the Rights of independent Nations, has been the Subjugation of this happy Empire. And it is not without Feelings of an honourable Pride we reflect, that the Wisdom of your Majesty's Councils, and the Efforts of your Arms, have not been in vain; that by them the Encroachments of the Enemy have been stayed; and that Great Britain has been, and, under the Blessing of Almighty God, may continue to be the Refuge to which other Nations may still resort for Assistance and Protection.

With these Sentiments deeply impressed on our Hearts, we have felt it a Duty we owe to the Community of this ancient Metropolis, which we represent, humbly to express to your Majesty our firm Conviction, that a Peace suitable to the Interests and Dignity of your Realms is only to be attained by persevering in those Measures which have given to this Country the high Station the now holds among the People of the Earth; and that whatever Exertions or Sacrifices may be required, we are willing to support, or to fall with the Honour of your Majesty's Crown, the Independence of your Empire, and the Rights and Liberties of your Subjects.

SALTASH RIGHT OF ELECTION PETITION.

Veneris, 22^o Die Januarij, 1808.

JAMES BULLER, Esq; Arthur Champernowne, Esq; Matthew Russell, Esq; the Reverend John Buller, Clerk, John Evans, Gent. John Stephens Croft, and Isaac Toby, having this Day presented their Petition to the House of Commons, setting forth; That at the Election of Burgesses to serve in Parliament for the Borough of Saltash, in the County of Cornwall, held on or about the 5th Day of November 1806, the Petitioners, Arthur Champernowne and Matthew Russell, and also the Honourable Richard Neville and William Henry Freemantle, Esq; were Candidates to represent the said Borough in Parliament; and that the Mayor of the said Borough, who acted as Returning Officer, conceiving the Petitioners, Arthur Champernowne and

Matthew Russell, to have a considerable Majority of legal Voters at such Election, returned the Petitioners, Arthur Champernowne and Matthew Russell, as duly elected to serve in Parliament as Burgesses for the said Borough of Saltash; against which Return Two Petitions were presented to the House; one by and on the Behalf of the said Richard Neville and William Henry Freemantle, and the other by and on the Behalf of Nicholas Vincent, an Admiral in His Majesty's Navy; John Scott, Esq; the Reverend Robert Hughes, Clerk, Edmund Herring, John Smith, and Edmund Nepean, Gentlemen, stating, among other Things, that the said Richard Neville and William Henry Freemantle were duly elected, and ought to have been returned as Burgesses to serve in Parliament for the said Borough of Saltash, and praying such Relief as to the House should seem meet; and that on Wednesday the 28th Day of January last, a Select Committee of the House was appointed to try the Merits of the said Petitions; and that the said Committee, on the Hearing of the said Petitions, required the Counsel for the several Parties to deliver to the Clerk of the said Committee, Statements, in Writing, of the several Rights of Election for which they respectively contended; and that in consequence thereof, the Counsel for the Petitioners, the said Richard Neville and William Henry Freemantle, and also for the said several other Petitioners, delivered in a Statement as follows: "That the Right of voting for Members to serve in Parliament for the Borough of Saltash is in the Mayor and Free Burgesses of the Borough of Saltash, being Members of the Corporation within the same;" and that the Counsel for the said Sitting Members, Matthew Russell and Arthur Champernowne, delivered in a Statement as follows: "That the Right of Election of Members to serve in Parliament for the Borough of Saltash, in the County of Cornwall, is in every Person seized of an Estate for Life, or some greater Estate, in an entire Ancient Burgage Tenement situate within the Borough aforesaid, whereon an Ancient Dwelling-house now stands, or formerly stood, and in no other Persons;" and that upon the Statement delivered in by the Counsel for the then Sitting Members, the said Committee determined, that the Right of Election as set forth in the said Statement, is not the Right of Election for the said Borough of Saltash; and that upon the Statement delivered in by the Counsel for the said several Petitioners, the said Committee determined that the Right of Election, as set forth in the said Statement, is the Right of Election for the said Borough, so far as the said Right is therein described; and that the said Committee having considered the said Statements and Evidence adduced before them, touching the Right of Election for the said Borough of Saltash, did determine, "That the Right of voting for Members to serve in Parliament for the Borough of Saltash, is in the Mayor and Free Burgesses of the Borough of Saltash, being Members of the Corporation within the same, and in no other Persons;" and that the Petitioners are not satisfied with the said Resolutions and Determinations of the said Select Committee, and are advised that the same are contrary to Law, and are desirous of being admitted Parties to oppose the said Right of Election, deemed valid in the Judgment of the

said Select Committee as aforesaid; and to support and establish the said Right of Election for which the Petitioners, Arthur Champernowne and Matthew Russell contended before the said Select Committee, and which was negatived by the said Select Committee, or such other Right as shall be consistent with Law, and to have the Benefit of the Statutes in that Behalf made and provided; and therefore praying the House to take the Premises into their Consideration, and that the Petitioners may be admitted as Parties to oppose the said Right of Election, which was deemed valid in the Judgment of the said Select Committee, and to support and establish the said Right of Election for which the Petitioners, Matthew Russell and Arthur Champernowne contended before the said Select Committee, or such other Right as shall be consistent with Law; and that the House will be pleased to grant such Relief to the Petitioners as to the House shall seem meet, and the Justice of the Case may require:

And the House having appointed Tuesday the 9th Day of February next, at Three of the Clock in the Afternoon, to take the said Petition into Consideration, I do hereby give Notice, that the House will at that Time take the said Petition into Consideration.

As several Artificers and Manufacturers, Subjects of Great Britain, have, from Time to Time, gone into Foreign Countries to exercise their several Callings, contrary to the Laws of these Kingdoms, the following Abstracts of Acts of Parliament of Their late Majesties King George the First and Second, and of His present Majesty, for preventing such Practices, are published, for the Information of all Persons who may be ignorant of the Penalties they may incur by Disobedience to them: And it will be observed, that such Penalties likewise extend to those who are any ways concerned or instrumental in the Sending or Enticing Artificers or Manufacturers out of these Kingdoms, or in the Exportation of the Tools and Instruments used by them, as well as to the Artificers or Manufacturers themselves.

Statute 5. George I. Chap. 27.

IF any Person shall contract with, entice, or solicit, any Artificer in Wool, Iron, Steel, Brass, or other Metal, Clock-maker, Watch-maker, or any other Artificer of Great Britain, to go into Foreign Countries out of the King's Dominions, and shall

be convicted thereof, upon Indictment or Information in any of the Courts at Westminster, or at the Assizes or Quarter Sessions, he shall be fined any Sum not exceeding ONE HUNDRED POUNDS for the first Offence, and shall be imprisoned Three Months, and till the Fine be paid. And if any Person having been once convicted shall offend again, he shall be fined at the Discretion of the Court, and imprisoned Twelve Months, and till the Fine be paid.

If any of the King's Subjects, being such Artificers, shall go into any Country out of His Majesty's Dominions, to exercise or teach the said Trades to Foreigners; and if any of the King's Subjects in any such Foreign Country, exercising any of the said Trades, shall not return into this Realm within Six Months after Warning given by the Ambassador, Minister, or Consul of Great Britain, in the Country where such Artificers shall be, or by any Person authorized by such Ambassador, &c. or by one of the Secretaries of State, and from henceforth inhabit within this Realm; such Persons shall be incapable of taking any Legacy, or of being an Executor or Administrator, or of taking any Lands, &c. within this Kingdom, by Descent, Devise, or Purchase, and shall forfeit all Lands, Goods, &c. within this Kingdom, to His Majesty's Use, and shall be deemed Alien, and out of His Majesty's Protection.

Upon Complaint made, upon Oath; before any Justice of Peace, that any Person is endeavouring to seduce any such Artificer, or that any such Artificer hath contracted or is preparing to go out of His Majesty's Dominions, for the Purposes aforesaid, such Justice may send his Warrant to bring the Person complained of before him, or before some other Justice; and if it shall appear by the Oath of One Witness, or by Confession, that he was guilty of any of the said Offences, such Justice may bind him to appear at the next Assizes or Quarter Sessions: And if such Person shall refuse to give Security, the Justice may commit him to Gaol till the next Assizes or Quarter Sessions, and until he shall be delivered by due Course of Law. And if any such Artificer shall be convicted, upon Indictment, of any such Promise, Contract, or Preparation to go beyond the Seas, for the Purpose aforesaid, he shall give such Security to the King not to depart out of His Majesty's Dominions, as such Court shall think reasonable, and shall be imprisoned till Security given.

If any of the above Offences shall be committed in Scotland, the same shall be prosecuted in the Court of Judiciary or the Circuits there.

Statute 23 George II. Chap. 13.

IF any Person shall contract with, or endeavour to seduce any Artificer in Wool, Mohair, Cotton, or Silk, or in Iron, Steel, Brass, or other Metal, or any Clock-maker, Watch-maker, or any other Artificer in any other of the Manufactures of Great Britain or Ireland, to go out of this Kingdom or Ireland into any Foreign Country not within the Dominions of the Crown of Great Britain, and shall be convicted, upon Indictment or Information, in the King's Bench at Westminster, or by Indictment at the Assizes or General Gaol Delivery for the County, &c. wherein such Offence shall be committed in England, or by Indictment in the Court of Judiciary or any of the Circuit Courts in Scotland, or by

Indictment or Information in the King's Bench at Dublin, if such Offence be committed in Ireland; the Person so convicted shall, for every Artificer contracted with or seduced, forfeit FIVE HUNDRED POUNDS, and shall suffer Imprisonment in the Common Gaol of the County or Stewartry wherein such Offender shall be convicted for Twelve Calendar Months, and until Forfeiture be paid: And in case of a subsequent Offence of the same Kind, the Persons so again offending shall forfeit, for every Person contracted with or seduced, ONE THOUSAND POUNDS, and shall suffer Imprisonment in the Common Gaol of the County or Stewartry wherein such Offender shall be convicted, for Two Years, and until such Forfeiture be paid.

If any Person in Great Britain or Ireland shall put on board any Ship or Boat, not bound directly to some Port in Great Britain or Ireland, or to some other of the Dominions of the Crown of Great Britain, any such Tools or Utensils as are commonly used in, or proper for the Preparing, Working up, or Finishing of the Woollen or Silk Manufactures, or any Part of such Tools, he shall, for every Offence, forfeit all such Tools, or Parts thereof, put on board, and TWO HUNDRED POUNDS, to be recovered by Action of Debt, &c. in any Court of Record at Westminster, or in the Court of Session in Scotland, or at any of the Four Courts in Dublin respectively, wherein no Essoin, &c. shall be allowed.

It shall be lawful for any Officer of the Customs in Great Britain, or for any Officer of the Revenue in Ireland, to seize and secure, in some of His Majesty's Warehouses, all such Tools or Utensils prohibited to be exported, as such Officer shall find on board any Vessel not bound directly to some Port in Great Britain or Ireland, or to some other of the Dominions of the Crown of Great Britain; and all Tools so seized shall, after Condemnation, be publicly sold to the best Bidder; and one Moiety of the Produce shall be to the Use of His Majesty, and the other Moiety to the Officer who shall seize and secure the same.

If the Captain of any Vessel in Great Britain or Ireland knowingly permit any of the said Tools, prohibited to be exported, to be put on board his Vessel, he shall, for every such Offence, forfeit ONE HUNDRED POUNDS, to be recovered as the Penalties inflicted upon Persons exporting the Tools; and, if the Vessel belongs to His Majesty, the Captain shall not only forfeit ONE HUNDRED POUNDS, but shall also forfeit his Employment, and be incapable of any Employment under His Majesty.

If any Officer of the Customs in Great Britain or of the Revenue in Ireland, take, or knowingly suffer to be taken, any Entry outward, or sign any Cocket or Sufferance for the Shipping or Exporting of any of the said Tools, or knowingly suffer the same to be done, he shall forfeit ONE HUNDRED POUNDS, to be recovered as aforesaid, and also forfeit his Office, and be incapable of any Office under His Majesty.

One Moiety of the Forfeitures shall be applied to the Use of His Majesty, and the other Moiety to the Use of the Person who shall sue for the same.

Statutes 14, 21, 25, and 26 of His present Majesty.

BY these Statutes the like Penalties and Forfeitures as above-mentioned are extended to Persons packing or putting on board any Vessel, not bound directly for some Port in Great Britain or Ireland, any Machine, Engine, Tool, Press, Paper, Utensil, or Implement whatsoever, used in or proper for the working or finishing of the Cotton, Steel, or Iron Manufactures of this Kingdom, or any Part or Parts of such Machines or Implements, or any Models or Plans thereof; and all Captains of Ships and other Persons receiving or being in Possession of any such Articles, with an Intent to export the same to Foreign Parts, and all Custom-house Officers suffering an Entry to be made thereof, are respectively liable to the like Penalties as are above-mentioned, in the case of Tools and Utensils used in the Woollen and Silk Manufactures.

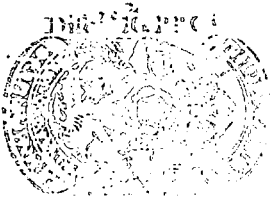
