#### PROCLAMATION, А

For parelsning fuch Seamen and Marines as have de-ferted, and shall return into His Majely's Service on or before the Thirty-first Day of December next.

WHEREAS We are defirous to give all due Encouragement to fuch Seamen as may have deferted from any of Our Ships fince the Tenth Day of October One thousand eight hundred and five, and that be willing to return to Our Service ; We have thought fit, by and with the Advice of Our Privy Council, to publish this Our Royal Proclamation, and do hereby promife Our most gracious Par-don to all such Deferters as shall repair on board any of Our Ships or Veffels on or before the Thirty-first Day of December next; and We do hereby further premife Cur most gracious Pardon to all such Sea-men as, having deferted, are now belonging to fome one of Our Ships; and We do alfo hereby premife Our moil gracious Pardon to all Marines who may have deferted from our Service tince the faid Tenth Day of October One thousand eight hundred and five, and shall on or before the faid Thirty-first Day of December next, furrender themfelves at the Head-Quarters of the Royal Marines eftablished at Ports. mouth, Plymouth, or Chatham, or to any Recruit-ing Party of Cur faid Forces; and We do hereby declars, that all Seamen and Royal Matines fo furrendering themfelves as aforelaid, shall be releafed and diffcharged from all Projecutions, Imprifon-ments, and Penalties commenced or incurred by reason of any such Offence; but that such Pardon shall not en itle Deferters, whether Seamen or Ma-rines, to any Arrears of Pay forfeited by fuch De-fertion : And We do hereby further declare, that all fuch Deferters, whether Seamen or Marines, who shall not on or before the faid Thirty-first Day of December next, furrender themfelves on board One of Our Ships or Veffels of War, or at the Head-Quarters of the Royal Marines established at Portsmouth, Piymouth, or Chatham, or to fome Recruiting Party of the faid Forces, or who shall hereafter abient themselves from the Ships to which they belong, or from the Marine Quarters, without Leave count to the Prince Regent of Portugal for such from their Commanding Officers, shall be tried at a Part of the said joint Property as shall belong to

Court Martial, and being found guilty, shall be deemed unfit Objects of Our Royal Mercy, and shall fuffer the Punishment of Death, or such other Punishment as they shall be condemned to fuffer by Sentence of the faid Court.

The KING's Most Excellent Majesty in Council.

**HIS** Majefly, by and with the Advice of His Privy Council, is pleafed to order, and it is hereby ordered, that all Portuguefe Property now detained, and not already decreed to be reflored, nor entitled to Restitution under His Majesty's Order of the Sixth of January last, shall be forthwith decread to be reftored upon Claime given or to be given for the fame, either by the Portuguese Con-ful, or other Perfon duly authorized by the Por-tuguese Minister resident at this Court, or by the Agents (duly authorized) of those Owners and Proprietors who are not relident in Portugal, or in other Places subject to the Influence and Controul of France, and that the Part of the Property fo reftored belonging to Perfons not refiding in Por-tugal, or in other Places subject to the Influence and Controul of France, shall be for the Ufe and Benefit of the Owners and Proprietors thereof; and the Part belonging jointly to Persons resident in Portugal, and Persons resident in the Brazils, or in any Settlement belonging to the Crown of Portu-gal, or in the United Kingdom, or in any Country in Amity with His Majefty, shall be given up to fuch of the Owners and Proprietors thereof as are refident as last mentioned, upon an Engagement entered into and Security given by or on the Be-half of the faid Part Owners and Proprietors, to the Satisfaction of the Portuguele Minister, to acPerfons refident in Portugal, or in other Places subject to the Influence and Controul of France; and the Part belonging to Perfons refident in Portugal, or in other Places subject to the Influence and Controul of France, shall be at the future Disposition of the Prince Regent of Portugal.

And it is further ordered, that the joint Agents to whom the Property has been or shall be delivered purfuant to the faid Order of the Sixth of January last, shall be, and they are hereby authorized and directed, after the faid Property shall have been decreed to be reftored, to proceed to the Sale of fuch Property, or of fuch Parts thereof, as the Portuguele Minister resident at this Court shall fignify to them, in Writing, the Expediency of felling in the Manner molt beneficial for the Parties interested therein, and to invest the Proceeds of such Part as shall be fold in Government Securities, under the previous Sanction, in Writing, of the Portu-guese Minister, and to hold the same, together with the Property not fold, at the Disposal and subject to the future Directions of the Prince Regent of Portugal, to be fignified to them through his Minister resident in London: And the Right Honourable the Lords Commiffioners of His Majefty's Treafury, His Majefty's Principal Secretaries of State, the Lords Commiffioners of the Admiralty, and the Judge of the High Court of Admiralty, and Judges of the Courts of Vice-Admiralty, are to take the neceffary Measures herein as to them shall respectively appertain. THIS Day the Lords being met, a Meffage was fent to the Honorable Houle of Commons by Sir Francis Molyneux, Gentleman Ufher of the Black Rod, acquainting them, that The Lords, authorifed by virtue of His Majefly's Commission for declaring His Royal Affent to feveral Acts agreed upon by both Houfes, do defire the immediate Attendance of the Honorable Houfe in the Houfe of Peers to hear the Commission read; and the Commons being come thither, the faid Commission, empowering the Lord Archbishop of Canterbury, the Lord High Chancellor of Great Britain, and feveral other Lords therein named, to declare and notify the Royal Affent to the faid Acts, was read accordingly, and the Royal Affent given to

An Aft for railing the Sum of Three Millions by Exchequer Bills, for the Service of Great Britain for the Year 1808.

An Act for railing the Sum of One Million Five Hundred Thouland Pounds by Exchequer Bills, for the Service of Great Britain for the Year 1808.

An AA to grant to His Majelty certain Duties and Taxes in Ireland in refpect of Carriages, Dogs, Fire Hearths, Horfes, Male Servants, and Windows, in lieu of former Duties and Taxes in refpect of the like Articles.

An Act to repeal certain Duties of Excile in Ireland, and to grant certain Stamp Duties in lieu thereof, and also certain other Stamp Duties, and to amend the Laws relating to the Stamp Duties in Ireland.

#### May it please your Majesty,

THE gracious Letter with which your Majefly hath been pleafed to honour this Meeting of the General Affembly of the Church of Scotland, hath been received with equal Refpect and Gratitude.

The renewed Appointment of Francis Lord Napier to be your Majefty's High Commiffioner in this Affembly, is in the higheft Degree acceptable to the Church of Scotland. We regard it as a Proof of your Majefty's Care and Attention to the general Interefts of Religion, and more particularly of your gracious Attachment and Regard to our National Church, that your Royal Perfon is represented among us by one whom we fo highly and fo juftly value.

We are deeply impressed with the Importance of the Trust committed to us of instructing so confiderable a Portion of your Majesty's Subjects in the great and awful Truths of Religion, and in those unerring Rules of Morality, of which the Founda-

sion is fought in vain in mere speculative Reasoning, or in the unfatisfying Hypothelis of Philosophy. It is our anxious Wish and Hope that those Doc-

trines, which have fo long flourished in our Church, may still be preferved in their original Purity. And we are most fincerely grateful for the paternal Solicitude with which your Majelty calls forth our Zeal in their Defence, at a Time when we are menaced by fo gigantic a Power, and nearly furrounded by the Inftruments of his unprincipled Devastation. Ĩt shall be our earnest Study that the loyal Endeavours and perfevering Efforts of your Mejefty's Subjects may never be wanting in the Caule of Virtue and Morality; that Religion and Honour may still be respected in our Land. And we trust in the infinite Mercy of God, that however ill we have deferved of that Almighty Power, by whole Command aloue Empires rife or fall, He will not vigoroufly vifit the Sins of his People, nor fend forth the avenging Angel to deftroy.

We shall endeavour to guard with the most vigilant Care against every Irregularity or Abuse which Time, Accident, or the Attempts of evil deligning Perfons, may have a Tendency to introduce into our Church Government. And we entreat your Majelly to believe, that every Exhortation which it is in our Power to employ shall be used in preparing the People under our Charge for the many Hardfhips which they may be called to endure in the arduous Contelt in which we are at prefent involved.

We have received with respectful Gratitude, and shall endeavour faithfully and zealoufly to employ your Majelly's Royal Donation of One Thouland Pounds for propag ting the Knowlege of the Gofpei in the Highlands and Islands of Scotland.

We entreat your Majelly to be at all Times affured of our affectionate Attachment to your Perfon and Government. And that Almighty God, the Father of our Lord Jelus Chrift, may protect your Majefty and profper your Councils; that he may blefs abundantly our gracious Queen, the Prince and Princefs of Wales, and all the Members of your il-Inftrious Houfe ; that he may long continue to us the ineftimable Benefits which we enjoy under your Majelty's Reign; and that he may bellow upon you hereafter a Crown of Glory, are the Prayers of, May it pleafe your Majefty, your Majefty's molt faithful, molt obedient, and molt loyal Subjects, the Miniflers and Elders met in this National Affembly of the Church of Scotland.

I HAVE the Pleafure to acquaint you of the Capture of the Friedland Italian Brig of War, commanded by Captain Angelo Thomasi, this Evening, by the Standard and Active, after feveral Hours' chace, clofe in with Cape Blanco, which the would foon have rounded, had not her Topmafts fortunately gone over the Side, which enabled Captain Monbray to take Poffeffion of her; and I have given him Directions to proceed to Malta with her and the Prifoners.

The Friedland is Twelve Months old, carries Sixteen French Twelve-Pounder long Guns, built at Venice, and is a very fine Brig. Embarked on board her is Commodore Don Aunilear Paolucei, commanding in Chief the Italian Marine, and Knight of the Iron Crown.

BEG to inclose, to be laid before my Lords Commissioners of the Admiralty, the Copy of a Letter from Captain Sir Thomas Livingstone, which I have Te-day received from Rear-Admiral Purvis, giving an Account of the Boats of the Renommée and Grasshopper having, on the Night of the 6th of November last, attacked and captured Two Armed Veffels which lay at Anchor under the Protection of the Torre de Effacio.

The Officers and Men employed on this Service, under the Direction of acting Lieutenant Webster, appear to have displayed confiderable Gallantry.

#### COLLINGWOOD. I am, &c.

His Majefly's Ship Renommée, off Carthagena, Nov. 12, 1807.

SIR, I HAVE to acquaint you, that on the Night of the 6th Inflant 1 fent a Detachment of Boats from this Ship and the Grasshopper, under the Direction of Lieutenant William Webster of the Renommée, for the Purpole of cutting out fome Enemy's Vessels that lay at Anchor under the Torre de Effacio.

By Four o'Clock in the Morning the Boats were in Poffeffion of the Veffels, viz. a Spanish Brig and a French Tartan, each of them mounting Six Guns, with a proportionable Number of Men; but unfortunately there was fo little Wind, and the Current ran fo firong, that they both got aground ; and notwithstanding every Exertion was used for the Purpose of getting them off, it was found impossible, and at about Seven o'Clock they were abandoned; they would have been burnt had there not been fo many Men, Women, and Children on board them, (many of whom were badly wounded, and our Boats could not remove them,) and Humanity induced Lieutenant Webster not to fet them on Fire.

During the Performance of the abovementioned Service the Torre de Effacio kept up a con tant Fire of Grape and Cannifler upon our Boats and the captured Veffels, which wounded feveral of the Enemy and Two of our brave Fellows, viz. Mr. Thomas Baftin, Purfer of the Grafshopper, who was a Volunteer, and commanded a Boat upon the Occation, and Henry Garrett, Coxfwain of the Renommée's Pinnace, both very badly.

The Lofs the Enemy fultained was confiderable in wounded, but none killed. The cool and gallant Conduct of every Officer and Man employed on the abovementioned Service entitles them to every Praife which is in my Power to beftow.

Lieutenant William Webster, who commanded, has in feveral fuch Inftances diftinguished himfelf. I have the Honour to be, &c.

SIR,

HAVE the Honour to include you, for the In-I formation of my Lords Commillioners of the Admiralty, a Copy of a Letter I have received from Captain Ulsher, of His Majefty's Sloop the Redwing, reprefenting another Inflance of Bravery difplayed by him on the 7th Inftant, off Cape Trafalgar.

I have the Honour to be, &c. JOHN. C. PURVIS.

His Majefly's Sloup Redwing, at Sea, 7th May 1808. · SIR,

I HAVE the Honour to acquaint you, that this Morning at Daylight, Cape Trafalgar bearing W. N. W. about Six Miles, an Enemy's Convoy was difcovered coming down along Shore. The Winds being very light and variable, I was not enabled to clofe with them before Seven o'Clock; at that Time, being within point-blank Shot, the Armed Veffels handed their Sails, and forming a clofe Line, fwept towards us, indicating an Inten-tion to board. The just Confidence I place in the Officers and Men that I have the Honour to command induced me to meet the Enemy upon his own Terms, and I endeavoured to close, to decide the Bufinels as quick as possible, in order to fecure the Merchantmen. Upon arriving within Musket-Shot, a quick and well-directed Fire was opened, our Guns doing great Execution. At Nine o'Clock, the Enemy completely Panic-struck and beaten, pussed their Vessels into a heavy Surf, facriscing all their Wounded. I instantly fent a Boat to try and fave as many as I could, as it was diffreffing to fee their Situation, but our Men were unable to refcue one of them. The Merchant Veffels, feeing the Fate of their Convoy, attempted to difperfe ; fome we funk ; others ran into the Surf, and, in a fhort Time, difappeared ; the reft were captured, excepting Three, (Two of which were armed,) that it was not in my Power to come up wich, owing to our crippled State, having Two Twenty-four-Pounders fluot through the Foremaft, One through the Mainmalt, and One through the Gammoning of the Bowfprit, that likewise cut the Knee of the Head alunder.

The flendy and cool Conduct of the Officers and Men throughout deferve my warmeft Praife; and had the Enemy poffeffed Relolution enough to have boarded, I could not doubt of the Refult, though oppoled to fuch fuperior Numbers. My First Lieutenant, Ferguion, on this as well as on many other Occasions, was a good Assistant to me. Nothing can exceed his cool determined Conduct, which I have fo often witneffed. Lieutenant Webster likewife executed his Duty entirely to my Satisfaction, as well as Mr. Davis, Mafter, and Mr. Horniman, Purfer, who were both wounded ; the latter, I fear, will lose an Eye. It is with the most heartfelt Gratification I acquaint you our Lols in Men is small, as herewith annexed. I am now on my Way to Gibraltar, as our Malts must be taken out ; but I shall lofe no Time in refitting, and refuming my Station.
