PRESENT,.

The KING's Most Excellent Majesty in Council. HEREAS the Time limited by His Majefty's Order in Council of the Twenty-fifth Day of November One thousand eight hundred and seven, prehibiting the transporting into any Parts out of this Kingdom of any Pig-Iron, Bar-Iron, Hemp, Pitch, Tar, Rosin, Turpentine, Anchors, Cables, Cordage, Masts, Yards, Bowsprits, Oars. Oakum, Sheet-Copper, or other Naval Oars, Oakum, Sheet-Copper, or other Naval Stores, will expire upon the Eleventh Day of this instant July: And whereas it is judged expedient for His Majesty's Service, and the Safety of this Kingdom, that the said Prohibition should be continued for some Time longer, His Majesty doth therefore, with the Advice of His Privy Council, hereby order, require, prohibit, and command, that no Perfon or Persons whosoever do at any Time, for the Space of Six Months, from the said Eleventh Day of this instant July, presume to transport into any Parts out of this Kingdom any Pig-Iron, Bar-Iron, Hemp, Pitch, Tar, Rosin, Turpentine, Anchors, Cables, Cordage, Masts, Yards, Bowsprits, Oars, Oakum, Sheet-Copper, Sail-Cloth or Canvas, or other Naval Stores, or do ship or lade any Pig-Iron, Bar-Iron, Hemp, Pitch, Tar, Rosin, Turpentine, Anchors, Cables, Cordage, Masts, Yards, Bow-Iprits, Oars, Oakum, Sheet-Copper, Sail-Cloth or Canvas, or other Naval Stores, on board any Ship or Vessel, in order to transporting the same into any Parts beyond the Seas, without Leave or Permission tirth being had and obtained from His Majesty or His Privy Council, upon Pain of incurring the Forfeitures inflicted by an Act passed in the Thirty-third Year of His Majesty's Reign, intituled "An "Act to enable His Majesty to restrain the Expor-" tation of Naval Stores, and more effectually to " prevent the Exportation of Salt-Petre, Arms, and "Ammunition, when prohibited by Proclamation or Order in Council:" But it is nevertheless His Majesty's Pleasure, that nothing herein contained thall extend, or be construed to extend, to any of His Majesty's Ships of War, or any other Ships or Vessels or Boats in the Service of His Majesty, or

Ordnance, or by the Commissioners of His Majesty's Navy; nor to prevent any Ship or Vessel from taking or having on board such Quantities of Naval Stores as may be necessary for the Use of such Ship or Velfel during the Course of her intended Voyage, or by Licence from the Lord High Admiral of Great Britain, or the Commissioners of the Admiralty for the Time being; nor to the Exportation of the faid several Articles to Ireland, or to His Majesty's Yards or Garrisons, or to His Majesty's Colonies and Plantations in America or the West Indies, or to Newfoundland, or to His Majesty's Forts and Settle-ments on the Coast of Africa, or to the Island of St. Helena, or to the British Settlements or Factories in the East Indies: Provided that upon the Exportation of any of the said Articles for the Purpose of Trade to Ireland, or to His Majesty's Yards and Garrisons, or to His Majesty's Colonies and Plantations in America or the West Indies, or to the Island of Newfoundland, or to His Majesty's Forts and Settlements on the Coast of Africa, or to the Island of St. Helena, or to the British Settlements or Factories in the East Indies, the Exporters of fuch Articles do first make Oath of the true Destination of the same to the Places for which they shall be entered outwards, before the Entry of the fame shall be made, and do give full and sufficient Security, by Bond, (except as here-inaster excepted,) to the Satisfaction of the Commissioners of His Majesty's Customs, to carry the said Articles to the Places for which they are fo entered outwards, and for the Purposes specified, and none other; and such Bond shall not be cancelled or delivered up until Proof be made to the Satisfaction of the faid Commissioners, by the Production, within a Time to be fixed by the faid Commissioners, and specified in the Bond, of a Certificate or Certificates, in such Form and Manner as shall be directed by the said Commisfioners, shewing that the said Articles have been all duly lauded at the Places for which they were en-tered outwards: But it is His Majesty's Pleasure, nevertheless, that the following Articles, viz. Bar-Iron, White and Tarred Rope, Tallow or Mill Greafe, Tarpaulins for Waggon-Covers, Pitch, Tar, and Turpentine, shall be permitted to be exported, upon Payment of the proper Duties, without Bond employed or freighted by His Majesty's Board of I being entered into by the Merchant Exporter, to any of the British Plantations in the West Indies, or to any of His Majesty's Settlements in South America; provided the Merchant Exporter shall first verify, upon Oath, that the Articles fo exported are intended for the Use of a particular Plantation or Settlement, to be named in the Entry Outwards, and not for Sale; and that the faid Plantation or Settlement has not before been furnished with any Supply of the faid Articles during the same Season; and provided also that the Exportation of the said Articles shall, in no Case, exceed the Value of Fifty Pounds Sterling for any given Plantation or Settlement, whether by one or more Shipments within the fame Season: And the Right Honourable the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, and the Lord Warden of the Cinque Ports, are to give the neceffary Directions herein as to them may respec-tively appertain. Whitehall, July 26, 1808.

As several Artificers and Manufacturers, Subjects of Great Britain, have, from Time to Time, gone into Foreign Countries to exercise their several Callings, contrary to the Laws of these Kingdoms, the following Abstracts of Acts of Parliament of Their late Majesties King George the First and Second, and of His present Majesty, for preventing such Practices, are published, for the Information of all Persons who may be ignorant of the Penalties they may incur by Disobelience to them: And it will be observed, that such Penalties likewise extend to those who are any ways concerned or instrumental in the Sending or Enticing Artishers or Manufacturers out of these Kingdoms, or in the Exportation of the Tools and Instruments used by them, as well as to the Artisheers or Manufacturers themselves.

Statute 5 George I. Chap. 27.

If any Person shall contract with, entice, or solicit, any Artificer in Wool, Iron, Steel, Brass, or other Metal, Clock-maker, Watch-maker, or any other Artificer of Great Britain, to go into Foreign Countries out of the King's Dominions, and shall be convicted thereof, upon Indictment or Information in any of the Courts at Westminster, or at the Assizes or Quarter Sessions, he shall be fined any Sum not exceeding ONE HUNDRED POUNDS for the first Ossence, and shall be imprisoned Three Months, and till the Fine be paid. And if any Person having been once convicted shall offend again, he shall be fined at the Discretion of the Court, and imprisoned Twelve Months, and till the Fine be paid. If any of the King's Subjects, being such Arti-

ficers, shall go into any Country out of His Majesty's Dominions, to exercise or teach the said Trades to Foreigners; and if any of the King's Subjects in any such Foreign Country, exercising any of the said Trades, shall not return into this Realm within Six Months after Warning given by the Ambassador, Minister, or Consul of Great Butain, in the Country where such Artisticers shall be, or by any Person authorised by such Ambassador, &c. or by one of the Secretaries of State, and from henceforth inhabit within this Realm; such Persons shall be incapable of taking any Legacy, or of being an Executor or Administrator, or of taking any Lands, &c. within this Kingdom, by Descent, Devise, or Purchase, and shall forseit all Lands, Goods, &c. within this Kingdom, to His Majesty's Use, and shall be deemed Alien, and out of His Majesty's Protection.

Upon Complaint made, upon Oath, before any Justice of Peace, that any Person is endeavouring to feduce any fuch Artificer, or that any fuch Artificer hath contracted or is preparing to go out of His Majesty's Dominions, for the Purposes aforefaid, fuch Justice may fend his Warrant to bring the Person complained of before him, or before some other Justice; and if it shall appear by the Oath of One Witness, or by Confession, that he was guilty of any of the faid Offences, such Justice may bind him to appear at the next Affizes or Quarter Seffions: And if fuch Perfon shall refuse to give Security, the Justice may commit him to Gaol till the next Affizes or Quarter Seffions, and until he shall be delivered by due Course of Law. And if any fuch Artificer shall be convicted, upon Indictment, of any fuch Promife, Contract, or Preparation to go beyond the Seas, for the Purpose aforesaid, he shall give fuch Security to the King not to depart out of His Majesty's Dominions, as such Court shall think reasonable, and shall be imprisoned till Security given.

If any of the above Offences shall be committed in Scotland, the same shall be prosecuted in the

Court of Justiciary or the Circuits there.

Statute 23 George II. Chap. 13. IF any Person shall contract with, or endeavour to seduce any Artisieer in Wool, Mohair, Cot. ton, or Silk, or in Iron, Steel, Brass, or other Metal, or any Clock-maker, Watch-maker, or any other Artificer in any other of the Manufactures of Great Britain or Ireland, to go out of this Kingdom or Ireland into any Foreign Coun-try not within the Dominions of the Crown of Great Britain, and shall be convicted, upon Indictment or Information, in the King's Beach at Westminster, or by Indistment at the Assizes of General Gaol Delivery for the County, &c. wherein such Offence shall be committed in England, or by Indictment in the Court of Justiciary or any of the Circuit Courts in Scotland, or by Indictment or Information in the King's Bench at Dublin, if such Offence be committed in Ireland; the Person so convicted shall, for every Artificer contracted with or seduced, forseit FIVE 'HUNDRED POUNDS, and shall suffer Impri-forment in the Common Gaol of the County or Stewartry wherein fuch Offender shall be convicted for Twelve Calendar Months, and until Forfeiture be paid: And in case of a subsequent Offence of the fame Kind, the Persons so again offending

shall forfeit, for every Person contracted with or seduced, ONE THOUSAND POUNDS, and shall suffer Imprisonment in the Common Gaol of the County or Stewartry wherein such Offender shall be convicted, for Two Years, and until such Forfeiture be paid.

If any Person in Great Britain or Ireland shall put on board any Ship or Boat, not bound directly to some Port in Great Britain or Ireland, or to some other of the Dominions of the Crown of Great Britain, any such Tools or Utensils as are commonly used in, or proper for the Preparing, Working up, or Finishing of the Woollen or Silk Manusactures, or any Part of such Tools, he shall, for every Offence, forfeit all such Tools, or Parts thereof, put on board, and TWO HUNDRED POUNDS, to be recovered by Action of Debt, &c. in any Court of Record at Westminster, or in the Court of Section in Scotland, or at any of the Four Courts in Dublin respectively, wherein no Essoin, &c. shall be allowed.

It shall be lawful for any Officer of the Customs in Great Britain, or for any Officer of the Revenue in Ireland, to seize and secure, in some of His Majesty's Warehouses, all such Tools or Utensils prohibited to be exported, as such Officer shall sind on board any Vessel not bound directly to some Port in Great Britain or Ireland, or to some other of the Dominious of the Crown of Great Britain; and all Tools so seized shall, after Condemnation, be publicly sold to the best Bidder; and one Moiety of the Produce shall be to the Use of His Majesty, and the other Moiety to the Officer who shall seize and secure the same.

If the Captain of any Vessel in Great Britain or Ireland knowingly permit any of the said Tools, prohibited to be exported, to be put on board his Vessel, he shall, for every such Ossence, forfeit ONE HUNDRED POUNDS, to be recovered as the Penalties inslicted upon Persons exporting the Tools; and, if the Vessel belongs to His Majesty, the Captain shall not only forfeit ONE HUNDRED POUNDS, but shall also forfeit his Employment, and be incapable of any Employment under His Majesty.

If any Officer of the Customs in Great Britain or of the Revenue in Ireland, take, or knowingly suffer to be taken, any Entry outward, or sign any Cocket or Sufferance for the Shipping or Exporting of any of the said Tools, or knowingly suffer the same to be done, he shall forfeit ONE HUNDRED POUNDS, to be recovered as aforesaid, and also forfeit his Office, and be incapable of any Office under His Majesty.

One Moiety of the Forfeitures shall be applied to the Use of His Majesty, and the other Moiety to the Use of the Person who shall sue for the same.

Statutes 14, 21, 25, and 26 of His present Majesty.

BY these Statutes the like Penalties and Forseitures as above-mentioned are extended to Persons
packing or putting on board any Vessel, not bound
directly for some Port in Great Britain or Ireland,
any Machine, Engine, Tool, Press, Paper, Utensil,
or Implement whatsoever, used in or proper for
the working or sinishing of the Cotton, Steel, or
Iron Manusactures of this Kingdom, or any Part

or Parts of fuch Machines or Implements, or any Models or Plans thereof; and all Captains of Ships and other Perfons receiving or being in Possession of any such Articles, with an Intent to export the same to Foreign Parts, and all Custom-house Officers suffering an Entry to be made thereof, are respectively liable to the like Penalties as are above-mentioned, in the case of Tools and Utensils used in the Woollen and Silk Manusactures.
