AT the Court at the Queen's Palace, the 21st of September 1808,

PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS His Majesty was pleased by His Orders in Council, of the Sixth of January and Fourth of May last, to direct certain Measures to be taken for the Care and Custody of Portuguese Property belonging to Persons residing in Portugal or elsewhere, under the Controul of France, which had been detained by British Cruizers, and to subject such Property to the suture Disposition of the Prince Regent of Portugal, in Consideration of the Owners not being entitled to the Possessino of it while they remained under the Controul of the Enemy:

And whereas the Deliverance of Portugal from fuch Control has fince been effected, and the Inhabitants of that Country are again become duly qualified to receive the Restitution of their Property;

His Majesty is therefore pleased, by and with the Advice of His Privy Council, to order, and it is hereby ordered, that all Portuguese Property shall be forthwith rellored to the respective Owners thereof, or their lawful Agents; and the Persons appointed by virtue of the Order in Council of the 6th of January last, for the Care and Management of the Portuguele Property, are hereby ordered to sectore the same accordingly; such Property nevertheless being subject to the Payment of the legal Charges thereon, and of the Expences justly incorred in respect thereto; and all Questions regarding the Ownership of such Property, where any Doubt shall be entertained by the Persons aforesaid, with respect to the same, and the Charges and Expences thereon, shall be decided upon fummarily by the High Court of Admiralty, or the Court of Vice-Admiralty, in which such Property may have been brought to Adjudication.—And the Right Honourable the Lords Commissioners of His Majestý's Treasury, His Majesty's Principal Secretaries of State, the Lords Commissioners of the Admiralty, and the Judge of the High Court of Admiralty, and the Judges of the High Courts of Vice-Admiralty are to take the necessary Measures herein as to them shall respectively appertain.

HEREAS by an Act, passed in the last Ses-VV fion of Parliament, intituled "An Act for further continuing, until Three Months after the Ratification of a Definitive Treaty of Peace, an Act, made in the Forty-fourth Year of His present Majesty, for permitting the Importation into Great Britain of Hides and other Articles in Foreign Ships," it is enacted, that an Act, made in the Forty-fourth Year of His present Majesty, intituled "An Act for permitting, until the Fifth Day of May, One thousand eight hundred and five, the Importation of Hides, Calf-Skins, Horns, Tallow, and Wool, (except Cotton Wool,) in Foreign Ships, on Payment of the like Duties, as if imported in British or Irisk Ships;" which, by an Act, made in the Forty-fifth Year of His present Majesty, was revived and further continued until the Twenty-fifth Day of March One thousand eight hundred and six, and extended to Goat-Skins imported in Foreign Ships; and which was further continued by an Act, made in the Forty-seventh Year of His present Ma-jesty, until the Twenty-fifth Day of March, One thousand eight hundred and eight, shall be, and the same is thereby further continued until the Three Months after the Ratification of a Definitive Treaty of Peace: And whereas His Majesty was pleased, by His Order in Council of the Twentythird Day of March last, pursuant to the Powers vested in His Majesty by the said Act, to allow, for the Space of Six Months from the Twentyfifth Day of the said Month of March, the Importation in Foreign Ships of any Hides, Pieces of Hides, dressed or undressed, Calf-Skins, or Pieces of Calf-Skins, dreffed or undreffed, Horns, or Pieces of Horns, Tallow, and Wool, (except Cotton Wool,) and Goat-Skins, dreffed or undreffed, on the Terms specified in the said Order: And whereas it is judged expedient for His Majesty's Service, that the said Permission should be continued for some Time longer, Fary Measures His Majesty is thereupon pleased, by and with the sertain.

Advice of His Privy Council, to allow, and doth hereby allow, for the Space of Six Months from

the Twenty-fifth Day 6f this inflant September, the Importation of any Hides, Pieces of Hides, dreffed or undreffed. Calf-Skins, or Pieces of Calf-Skins, dreffed or undreffed. Horns, or Pieces of Horns, Tallow, and Wool, (except Cotton Wool,) and Goat-Skins, dreffed or undreffed, in any Foreign Ship or Veffel; and His Majefty doth hereby order, that, on the Arrival at any Port of the United Kingdom of any Foreign Ship or Veffel, with any of the Articles above mentioned, the fail Goods shall be admitted to Entry on Payninent of the fame Daties of Customs and Excite as are due and payable on the like Goods when imported in any British or Krish-built Ship or Vessel.

And the Right Honourable the Lords Commissioners of His Majesty's Treasury are to give the necessary Directions herein accordingly.

PRESENT,

The KING's Most Excellent Majesty in Council.

7 HEREAS, in virtue of the Powers velted in His Majetty by an Act, passed in the Fortyfixth Year of His Majesty's Reign, Cap 20, inti-tuled "An Act for reviving and continuing se-veral Laws of Customs relating to the chablishing Courts of Judicature in the Alland of Newfoundland; and to the prohibiting the Exportation from, , and permitting the Importation to, Great Britain, of Corn, and for allowing the Importation of other Articles of Provision without Payment of Duty, until the Twenty-fifth Day of March, One thoufand eight hundred and nine; and for continuing several Laws relating to the granting a Bounty supon certain Species of British and Irish Linens exported from Great Britain, and taking off the , Duties on Importation into Great Britain of Foreign Raw Linen Yarns made of Flax ; to the granting a Bounty upon the Importation into Great Britain of Hemp, and rough and undressed Flax, from "His Majelly's Colonies in America, and to the Encouragement of the Greenland Whale Fisheries; and for reviving and continuing several Laws relating to the regulating the Prices at which Corn and . Grain may be exported from Great Britain to Iteland, and from Ireland to Great Britain; and to the Admission to Entry in Great Britain of Oil and , Blubber of Newfoundland, taken by His Majesty's Subjects carrying on the Fishery from, and seliding in, the faid Hand; and for continuing an Act of the Twenty third Year of His present Majesty, for the more effectual Encouragement of the Manufactures of Flax and Cotton in Great Britain ; and for reviving and continuing feveral Laws relating to the permitting the Importation into Great Britain of Hides and other Articles in Foreign Ships; and to the prohibiting the Exportation from Ireland of Corn or Potatoes, or other Provisions, and to the permitting the Importation into Ireland of Corn, Fifth, and Provisions, without Payment of Duty, until the Twenty fifth Day of March One thousand eight hundred and eight; and for reviving and continuing an Act, passed in the Parliament of Ireland in the Twenty-fifth Year of His present Majesty,

for the Encouragement of the Flaxen and Hempes Manufactures of Ireland until the Twenty-fifth Day of Match One thousand eight hundred and twenty-fevens and for amending and further continuing an Act made in the Seventh Year of His present Majesty for the free Importation into Great Britain of Cochineal and Indigo, until the Twenty-fish Day of March One thousand eight hundred and nine."

His Majelly was pleased by His Order in Council, bearing Date the Sixth Day of April laft, to permit, for the Space of Six Months, from the Sixteenth Day of the faid Month of April, the Importation of fundry Articles of Provilions, therein specified, Duty free: And whereas it is judged expedient that the faid Permission should be continued for some Time longer, His Majesty is thereupon pleased, by and with the Advice of His Privy Council to allow, and doth hereby allow, until the Twenty-fifth Day of March One thousand eight hundred and nine, the Importation into any Port or Place of Great Britain of any Beans, called Kidney or French Beans, Tares, Lentiles, Calavancies, and all other Sorts of Pulse; and also of Bulls, Cows, Oxen, Calves, Sheep, Lambs, and Swine, and of Beef, Pork, Mutton, Weal; and Lamb, (except Salted Beef, and Pork,) and of Bacon, Hams, Tongues, Butter. Cheese, Potatoes, Rice, Sago, Sago Powder, Tapioca, Vermicelli, Millet Seed, Poultry, Fowls, Eggs, Game, and Sour Crout, in any Bri. tish Ship or Vessel, or in any other Ship or Vessel belonging to Persons of any Kingdom or State in Amity with His Majesty, and navigated in any Manner whatever, without Payment of any Duty whatfoever; provided that a due Entry shall be made of all fuch Articles as aforefaid, that shall be imported with the proper Officers of the Customs at the Port where the same shall be imported, under the Penalties and Forfeitures mentioned and referred to in an Act passed in the Thirty-ninth Year of His present Majeky; and the Right Honourable the Lords Commissioners of His Majesty's Treasury are to give the necessary Directions herein accordingly. PROCLAMATION for pardoning Deferters from-His Majesly's Regular Land Forces.

War-Office, August 25, 1808. HEREAS it has been represented to the King, that there are at this Time several Deserters from the different Regular Corps in His Majesty's Land Service, who might be induced to return to their Duty by an Offer of His Majesty's gracious Pardon, and that fuch an Instance of His Royal Clemency would have a due Instance upon their future Behaviour; His Majesty has been graciously pleased to grant His Free Pardon to all Deferters from His Regular Land Forces, who shall furrender themselves on or before the Twenty-fourth Day of October, to the Commanding Officer of any Regiment, or to any of the Superintending Field Officers of the Recruiting Service, whose Stations, are mentioned in the Margin hereof,

or to the Commandant of the Army

Durham. Carlifle. Leeds. Manchester. Nottingham. Ipfwich. Shrewfbury. Birmingbam. Hereford. Bedford. Maidstone. Gloucester. Southampton. Wells. London.

Depôt in the Isle of Wight.
Such Deferters, if Able bodied Men, and fit for Service, shall be fent to the Regiments from which they: respectively deserted, or be appointed to fuch Regiments in the United. Kingdom as His Majesty may be pleased to command; and when so placed, shall not be liable to be claimed by any other Corps to which they may formerly have belonged.

And whereas many of the faid Deferters may have enlifted in other Regular Corps, and are now ferring

therein, His Majesty is graciously pleased to extend to such Deserters the Benefit of this Pardon; and to direct that they shall continue to ferve in the Corps wherein they now are, upon declaring themselves to their respective Commanding Officers on or before the Twenty-fourth of October next, and they shall not be liable at any future Time to be claimed by the Regiments in which they for-. merly ferved

The Magistrate to whom any Deserter from His Majesty's Regular Forces may furrender himself, is authorized and required to certify the Day on which fuch Deferter furrendered himfelf; which Certificate is to continue in Force until the Arrival of the De-. Serter at the Head-Quarters of the nearest Military Post, provided he proceed at the Rate of Ten Miles , a Day, unless prevented by Sickness, to be certified by some Medical Practitioner on the Back of the. Magistrate's Certificate, or to be otherwise proved to the Satisfaction of the Officer commanding at such Military Post.

And, with a View to prevent as far as possible all Soldiers from Desertion after these His Majelly's most gracious Intentions shall be made, known, His Majelly has been pleased to command, that the Name of every Soldier who may hereafter defert shall be transmitted, through the Secretary at War, to the Church Wardens of the Parishes to which

the Deferters belong, in order that their Names may be exposed to public View in the Church, or fuch other conspicuous Place as may render it impossible for Men, who have been guilty of this Crime, to return Home to their Friends, on whom they have brought Difgrace by their Visconduct, without immediate Detection; and His Majetty has further commanded that this Measure shall be made public, that every Soldier may be affured that the greatest Exertions will be used for the Apprehention of any Man who may hereafter defert, and that those who have already been guilty of that Crime may be aware of the daily Risk they incur of Detection, and of the most severe Punishment, if they do not immediately avail themselves of the Pardon held out in this His Majesty's most gracious Proclamation.

Any Soldier who may defert after these His Majesty's gracious Intentions are made public, shall not be included in the above Pardon, but be proceeded

against with the utmost Severity.

It is to be clearly understood, that this Proclamation of Pardon is intended to include all Deferters from the Army of Reserve and Additional Force. Act, but not to extend to any Deserter from His Majesty's Militia Forces.
