The KING's Most Excellent Majesty in Council.

THEREAS the Time limited by His Majesty's Order in Council of the Fourth Day of July last, prohibiting the transporting into any Parts out of this Kingdom of any Pig-Iron, Bar-Iron, Hemp, Pitch, Tar, Rosin, Turpentine, Anchors, Cables, Cordage, Malts, Yards, Bowsprits, Oars, Oakum, Sheet-Copper, or other Naval Stores, will expire upon the Eleventh Day of January next: And whereas it is judged expedient for His Majelly's Service, and the Safety of this Kingdom, that the faid Prohibition should be continued for some Time longer, His Majetty doth therefore, with the Advice of His Privy Council, hereby order, require, prohibit, and command, that no Perfon or Persons whosoever do at any Time, for the Space of Six Months, from the faid Eleventh Day of January next, prelume to transport into any Parts out of this Kingdom any Pig-Iron, Bar-Iron, Hemp, Pitch, Tar, Rosin, Turpentine, Anchors, Cables, Cordage, Maits, Yards, Bowiprits, Oars, Oakum, Sheet-Copper, Sail-Cloth or Canvas, or other Naval Stores, or do ship or lade any Pig-Iron, Bar-Iron, Hemp, Pitch, Tar, Rosin, Turpentine, Anchors, Cables, Cordage, Masts, Yards, Bowsprits, Oars, Oakum, Sheet-Copper, Sail-Cloth or Canvas, or other Naval Stores, on board any Ship or Vessel, in order to transporting the same into any Parts beyond the Seas, without Leave or Permission first being had and obtained from His Majesty or His Privy Council, upon Pain of incurring the Forfeitures inflicted by an Act passed in the Thirtythird Year of His Majelly's Reign, intituled " An 44 Act to enable His Majesty to restrain the Exportation of Naval Stores, and more effectually to " prevent the Exportation of Salt-Petre, Arms, and

Majesty's Pleasure, that nothing herein contained shall extend, or be construed to extend, to any of His Majesty's Ships of War, or any other Ships or Vessels or Boats in the Service of His Majesty, or employed or freighted by His Majesty's Board of Ordnance, or by the Commissioners of His Majesty's Navy; nor to prevent any Ship or Vessel from taking or having on board such Quantities of Naval Stores as may be necessary for the Use of such Ship or Vesfel during the Course of her intended Voyage, or by Licence from the Lord High Admiral of Great Britain, or the Commissioners of the Admiralty for the Time being; nor to the Exportation of the faid feveral Articles to Ireland, or to His Majesty's Yards or Garrisons, or to His Majesty's Colonies and Plantations in America or the West Indies, or to Newfoundland, or to His Majesty's Forts and Settlements on the Coast of Africa, or to the Island of St. Helena, or to the British Settlements or Factories in the East Indies: Provided that upon the Exportation of any of the faid Articles for the Purpole of Trade to Ireland, or to His Majcity's Yards and Garrisons, or to His Majesty's Colonies and Plantations in America or the West Indies, or to the Island of Newfoundland, or to His Majelly's Forts and Settlements on the Coast of Africa, or to the Island of St. Helena, or to the British Settlements or Factories in the East Indies, the Exporters of such Articles do sirst make Oath of the true Destination of the same to the Places for which they shall be entered outwards, before the Entry of the same shall be made, and do give full and sufficient Security, by Boud, (except as hereinafter excepted,) to the Satisfaction of the Commissioners of His Majesty's Customs, to carry the faid Articles to the Places for which they, are fo entered outwards, and for the Purposes frecified, and none other; and tuch Bond shall nor be cancelled or delivered up until Proof be made

the Production, within a Time to be fixed by the faid Commissioners, and specified in the Bond, of a Certificate or Certificates, in fuch Form and Manner as shall be directed by the said Commisfioners, shewing that the faid Articles have been all duly landed at the Places for which they were entered outwards: But it is His Majesty's Pleasure, nevertheless, that the following Articles, viz. Bar-Iron, White and Tarred Rope, Tallow or Mill Greafe, Tarpaulins for Waggon-Covers, Pitch, Tar, and Turpentine, shall be permitted to be exported, upon Payment of the proper Duties, without Bond being entered into by the Merchant Exporter, to any of the British Plantations in the West Indies, or to any of His Majesty's Settlements in South America; provided the Merchant Exporter shall first verify, upon Oath, that the Articles so exported are intended for the Use of a particular Plantation or Settlement, to be named in the Entry Outwards, and not for Sale; and that the faid Plantation or Settlement has not before been furnished with any Supply of the faid Articles during the same Season; and provided also that the Exportation of the said Articles shall, in no Case, exceed the Value of Fifty Pounds Sterling, for any given Plantation or Settlement, whether by one or more Shipments within the same Season: And the Right Honourable the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, and the Lord Warden of the Cinque Ports, are to give the neceffary Directions herein as to them may respectively appertain. I IS Majesty, in virtue of the Powers reserved to Him by Two certain Acts, passed in the Forty-eighth Year of His Majesty's Reign, the one intituled "An Act for granting to His Majelly, until the End of the next Session of Parliament, Duties of Customs on the Goods, Wares, and Merchandises therein enumerated, in furtherance of the Provisions of certain Orders in Council;' the other intituled "An Act for granting to His Majelly, until the End of the next Sellion of Parliament, certain Duties on the Exportation from Ireland of Goods, Wares, and Merchandise therein enumerated;" is pleased, by and with the Advice of His Privy Council, to order, and it is hereby ordered, that, until further Order shall be made herein, the Operation of the aforesaid Acts be sufpended as to any Duties on Exportation granted by the faid Acts, so far as relates to Articles being the Growth, Produce, or Manufacture of any Country for the Time being in Amity with His Majelty, and from the Ports of which the British Flag is not excluded, which Articles have been or shall be imported direct from such Country into any Port or Place of the United Kingdom, either in British Ships, or in Ships of the Country of which such Articles are the Growth, Produce, or Manufacture:

And His Majesty is further pleased, with the Advice aforesaid, to order, and it is hereby ordered, that the Operation of the aforesaid Acts be in like Manner suspended as to any Duties on the Exportation of Goods, Wares, or Merchandise which have been or may be condemned as Prize:

And the Right Honourable the Lords Commissioners of His Majesty's Treasury are to give the necessary Directions herein accordingly.

His Majesty's Sloop Egeria, Yarmouth Roads, Dec. 27, 1808. HAVE the Honour to inform you, that, on the 21st Instant, the Scaw bearing S. by E. Twelve Leagues, I fell in with and, after a Chace of Two Hours, captured the Danish Schooner Privateer Notiois, of Ten Guns, Giermund Holm, Master, with a Complement of Thirty-fix Men, but had on board only Twenty-six; out from Fridricksvern one Day, without taking any Thing.

Admiralty-Office, December 31, 1808. Extrad of a Letter from Captain Dundas, of His Majesty's Ship Naiad, to Captain Beresford, of the Theseus, dated off the Entrance of the Loire, the 17th Inflant, and transmitted by the latter to the Honourable W. W. Pole.

I BEG Leave to acquaint you, for the Information of the Commander in Chief, that last Evening at Eight, the Naiad and Narcissus being close inwith Noirmountier, we discovered and foon captured the French Privateer Brig Fanny, of Sixteen Guns and Eighty Men, commanded by Charles Hamon, and only a few Hours from Nantz, and confequently had made no Capture. She was intended to cruize off the Coast of Ireland; and at Midnight we captured the French Sloop Superb, Letter of Marque. of Four Guns and Twenty Men, with a Cargo of Sundries for Martinique. Mr. Hamon lately commanded the Venus Privateer, that did great Injury to our Trade.
