PARESENT,

The KING's Most Excellent Majesty in Council. W HEREAS the Time limited by His Majefty's Order in Council of the Fourth Day of July last, prohibiting the transporting into any Parts out of this Kingdom of any Pig-Iron, Bar-Iron, Hemp, Pitch, Tar, Rosin, Turpentine, Anchors, Cables, Cordage, Masts, Yards, Bowsprits, Oars, Oakum, Sheet-Copper, or other Naval Stores, will expire upon the Eleventh Day of January parts. And whereas it is judged expedient for nuary next: And whereas it is judged expedient for His Majesty's Service, and the Sasety of this King-. dom, that the faid Prohibition should be continued for some Time longer, His Majelty doth therefore, with the Advice of His Privy Council, hereby order, require, prohibit, and command, that no Perfon or Persons whosoever do at any Time, for the Space of Six Months, from the faid Eleventh Day of January next, prefume to transport into any Parts out of this Kingdom any Pig-Iron, Bar-Iron, Hemp, Pitch, Tar, Rosin, Turpentine, Anchors, Cables, Cordage, Masts, Yards, Bowsprits, Oars, Oakum, Sheet-Copper, Sail-Cloth or Canvas, or other Naval Stores, or do ship or lade any Pigor other Naval Stores, or do ship or lade any Pig-Iron, Bar-Iron, Hemp, Pitch, Tar, Rosin, Turpen-tine, Anchors, Cables, Cordage, Masts, Yards, Bowprits, Oars, Oakum, Sheet-Copper, Sail-Cloth or Canvas, or other Naval Stores, on board any Ship or Vessel, in order to transporting the same into any Parts beyond the Seas, without Leave or Permission first being had and obtained from His Majesty or His Privy Council, upon Pain of incurring the Forfeitures inflicted by an Act palled in the Thirtythird Year of His Majelty's Reign, intituled " Au "Act to enable His Majesty to restrain the Expor-tation of Naval Stores, and more effectually to or prevent the Exportation of Salt-Petre, Arms, and "Annunition, when prohibited by Proclamation or Order in Council:" But it is neverthelets. His Mejesty's Pleasure, that nothing herein contained shall extend, or be construed to extend, to any of His Majelly's Ships of War, or any other Ships or Veffels or Boats in the Service of His Majelly, or employed or freighted by His Majesty's Board of Ordnance, or by the Commissioners of His Majesty's

is may be necessary for the Use of such Ship or Vesiel during the Course of her intended Voyage, or by Licence from the Lord High Admiral of Great Bricain, or the Commissioners of the Admiralty for the Time being; nor to the Exportation of the faid feveral Articles to Ireland, or to His Majesty's Yards or Garrisons, or to His Majesty's Colonies and Flantations in America or the West Indies, or to Newfoundland, or to His Majesty's Forts and Settle-ments on the Coast of Africa, or to the Island of St. Helena, or to the British-Settlements or Factorics in the East Indies: Provided that upon the Exportation of any of the said Articles for the Purpose of Trade to Ireland, or to His Majesty's Yards and Garrisons, or to His Majesty's Colonies and Plantations in America or the West Indies, or to the Island of Newfoundland, or to His Majefty's Forts and Settlements on the Coast of Africa, or to the Island of St. Helena, or to the British Settlements or Factories in the East Indies, the Exporters of fuch Articles do first make Oath of the true Destination of the same to the Places for which they shall be entered outwards, before the Entry of the fame shall be made, and do give full and fufficient Security, by Bond, (except as here-inafter excepted,) to the Satisfaction of the Commissioners of His Majesty's Customs, to carry the faid Articles to the Places for which they are so entered outwards, and for the Purposes specified, and none other; and such Bond shall not be cancelled or delivered up until Proof be made to the Satisfaction of the faid Commissioners, by to the Satisfaction of the faid Commissioners, by the Production, within a Time to be fixed by the faid Commillioners, and specified in the Bond, of a Certificate or Certificates, in fuch Form and Manner as shall be directed by the said Commis-sioners, shewing that the said Articles have been all duly lauded at the Places for which they were entered outwards: But it is His Majelly's Pleasure, nevertheless, that the following Articles, viz. Bar-Iron, White and Tarred Rope, Tallow or Mill Greafe, Tarpaulins for Waggon-Covers, Pitch, Tar, and Turpentine, shall be permitted to be exported, upon Payment of the proper Duties, without Bond being entered into by the Merchant Exporter, to any of the British Plantations in the West Indies, or

to any of His Majesty's Settlements in South America; provided the Merchant Exporter shall first verify, upon Oath, that the Articles so exported are intended for the Use of a particular Plantation or Settlement, to be named in the Entry Outwards, and not for Sale; and that the said Plantation or Settlement has not before been furnished with any Supply of the faid Articles during the same Season; and provided also that the Exportation of the said Articles shall, in no Case, exceed the Value of Fifty Pounds Sterling for any given Plantation or Settlement, whether by one or more Shipments within the same Season: And the Right Honourable the Lords Commissioners of His Majesty's Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, and the Lord Warden of the Cinque Ports, are to give the neceffary Directions herein as to them may respectively appertain. Downing-Street, January 10, 1809. ISPATCHES, from which the following are Extracts, were, on the 8th Inflant, received at the Office of Lord Viscount Cathlereagh, one of His Majetly's Principal Secretaries of State, from Lieutenant-General Sir John Moore, K. B. Commander in Chief of His Majelly's Forces employed in Spain;

Benevente, December 28, 1808. INCE I had the Honour to address you upon the 16th, from Toro, the Army has been almost constantly marching through Snow, and with Cold that has been very intense. The Weather, within thefe few Days, has turned to Rain, which is much more uncomfortable than the Cold, and has rendered the Roads almost impassable. On the 21st the Army reached Sahagun; it was necessary to halt there in order to refresh the Men, and on account of Provisions. The Information I received was, that Marshal Soult was at Saldana with about Sixteen Thousand Men, with Polts along the River from Guarda to Carrion.

The Army was ordered to march in Two Columns at Eight o'Clock on the Night of the 23d, to force the Bridge at Carrion, and from thence proceed to Saldana. At Six o'Clock that Evening, I received Information that confiderable, Reinforcements had arrived at Carrion from Palencia, and a Letter from the Marquis de la Romana informed me that the French were advancing from Madrid either to Valladolid or Salamanca. It was evident that it was too fate to profecute the Attempt upon Soult, that I must be fatished with the Divertion I had occasioned, and that I had no Time to lose to lecure my Retreat.

The next Morning Lieutenant-General Hope, with his own Division and that of Lieutenant-General Fraser, marched to Majorga. I sent Sir David Baird with his Divition to pals the River at Valmira, and followed Lieutenant-General Hope on the 25th with the Reserve and the Light Brigades, by Majorga, Valderas, to Benevente. The Cavalry under Lord Paget followed the Referve on the 20th; both the latter Corps entered this Place Yetterday. We continue our March on Astorga. Generals Hope and Fraser are already gone on; and I shall leave this with the Reserve at the same Time; Lord Paget will remain with the Cavalry, to give us Notice of the Approach of the Enemy; hitherto their Infantry have not come up, but they are near, and the Cavalry is round us in great Numbers; they are checked by our Cavalry, which have obtained, by their Spirit and Enterprize, an Ascendancy over that of the French which nothing but great Superiority of Numbers on their Part will get the better of.

The Diversion made by our March on Sahagun, though at great Risk to ourselves, has been complete; it remains to be feen what Advantage the Spaniards in the South will be able to take of it; but the March of the French on Badajoz was stopped when its Advanced Guard had reached Talaveira de la Reine, and every Thing disposeable is

now turned in this Direction.

The only Part of the Army which has been his therto engaged with the Enemy, has been the Cavalry, and it is impossible for me to say too much in their Praise. I mentioned to your Lordship in my Letter of the 16th the Success Brigadier-General Stewart had met with in defeating a Detachment of Cavalry at Rueda. Since that few Days have paffed without his taking or killing diverent Parties of the French, generally superior in sorce to those which attacked them. On the March to Sahagun Lord Paget had Information of Six or Seven Hundred Cavalry being in that Town. He marched on the Night of the 20th from some Villages where he was polled in Front of the Enemy at Majorga with the Tenth and Fifteenth Husfars. The Penth marched straight to the Town, whill Lord Pager with the Fifteenth endeavoured to turn it. Unfortunately he fell in with a Patrol, One of whom escaped and gave the Alarm. By this Means the French had Time to form on the Outlide of the Town before Lord Paget got round. He immediately charged them, beat them, and took from One Hundred and Forty to One Hundred and Fifty Prisoners, amongst whom were Two Lieutenant-Colonels and Eleven Officers, with the Lofs on our Part of Six or Eight Men, and perhaps Twenty wounded.

There have been taken by the Cavalry from Four to Five Hundred French, besides a considerable Number killed;—this since we begun our March from Salamanca. On his March from Sahagun, on the 20th, Lord Paget, with Two Squadrons of the 10th, attacked a Detachment of Cavairy at Majorga, killed Twenty, and took above One Hundred Prisoners. Our Cavalry is very superior in Quality to any the French have; and the right Spirit has been infused into them by the Example and Instruction of their Two Leaders, Lord Paget and Briga-

dier-General Stewart.

Aftorga, December 31, 1808. I ARRIVED here Yesterday. Major General Fraser, with his Division, will be at Villa Franca this Day, and will proceed on to Lugo. Lieutenant-General Hope, with his Division, stopped Yesterday Two Leagues from this, and proceeds this Morning, followed by Sic David Baird. The Two Flank Brigades go by the Road of Penferada. I shall follow, with the Reserve and Cavalry, to Villa Franca either this Night or To morrow Morning, Sir David Paird proceeds to-morrow from Valencia; according as I hear the Approach of the French.

The Morning I marched from Benevente, Seven Squadrons of Bonaparte's Guards passed the River at a Ford above the Bridge. They were attacked by Brigadier-General Stewart, at the Head of the Piquets of the 18th and 3d German Light Bragoons, and driven across the Ford. Their Colonel, a General of Division, Lefebre, was taken, together with about Seventy Officers and Men.

The Affair was well contested The Numbers with which Brigadier-General Stewart attacked were inferior to the French; it is the Corps of the greatest Character in their Army; but the Superiority of the British was, I am told, very conspicuous. I enclose, for your Lordship's Satisfaction, Lord Paget's Report of it.

Benevente, December 20, 1808. I HAVE the Honour to inform you, that about Nine o'Clock this Morning 1 received a Report that the Enemy's Cavalry was in the act of crofling the River at the Ford near the Bridge. 1 immediately sent down the Piquets of the Night under Lieutenant-Colonel Otway, of the 18th. Having left Orders that the Cavalry should repair to their Alarm Polts, I went forward to reconnoitre, and found Four Squadrons of Imperial Guard formed and skirmishing with the Piquets and other Cavalry in the Act of passing. I sent for the 10th Hussars, who having arrived, Brigadier-General Stewart immediately placed himself at the Head of the Piquets, and, with the utmost Gallantry, attacked. The 10th Hussars supported in the most perfect Order.

The Result of the Affair, as far as I have yet been able to collect, is about Thirty killed, Twentyfive wounded, Seventy Priloners, and about the fame

Number of Horses.

It is impossible for me to avoid speaking in the highest Terms of all those engaged. Lieutenant-Colonel Otway and Major Bagweil headed the respective Night Piquets. The latter is flightly wounded. The utmost Zeal was conspicuous in the whole of my Staff; and I had many Volunteers from Head Quarters, and other Officers of your Army. Amongst the Prisoners is the General of Division Lefebre, (who commands the Cavalry of the Imperial Guard.) and Two Captains. Our Loss is, I cear, nearly Fifty Men killed and wounded. I will Send a Return the Moment I can collect the Reports.
