Copy of a Letter from Vice-Admiral Rowley, Com-mander in Chief of His Majefly's Ships and Vef-fels at Jamaica, to the Hon. W. W. Pole, dated at Port Royal, the 22d November 1808.

SIR

THAVE the Honour to transmit, for the Information of the Lords Commissioners of the Admiralty, a Copy of a Letter which I have received from Captain Cumby, of His Majefty's Ship Polyphemus, reporting the Capture by Lieutenaut Joseph Daly, in that Ship's Barge, of the French National Schooner Colibry, of Three Guns, commanded by a Lieutenant de Vailleau, and having a Complement of Sixty-three Men.

Polyphemus, off the City of St. Domingo, 14th November 1808.

SIR, HAVING detached the Boats of His Majelty's Ship under my Command at Half paft Eight o'Clock this Morning, in Chace of a Schooner that was attempting to enter the Harbour, I had the Satisfac-tion, at Twenty Minutes path Nine, to fee her boarded and carried in the most handfome Manner by Lieutenant Joseph Daly, in the Barge, under as brifk a Fire of Grape and Musketry as the Impe-tuofity with which our Boats advanced would allow the Enemy to keep up She proves to be the French National Schooner Colibiy, of Three Carriage Guns, commanded by Monf. Devriffe, Lieutenant de Vaiffeau, with a Complement of Sixty-three Men; reputed the faltest failing Veffel attached to this Colony, and, I trust, may be found well calculated for His Majefty's Service.

In the Execution of this Service I have to regret the Lofs of One Marine (Samuel Crompton) killed, in the Barge; and on the Part of the Enemy One killed and Five feverely wounded. I have the Honour to be, &c. W. PRYCE CUMBY, Captain.

SIR,

HE inclosed Copy of a Letter which I have received from Captain Dashwood, of His Majelty's Ship Franchife, will acquaint the Lords Commiffioners of the Admiralty with the Capture of the French Privateers Guerriere and Exchange, and fome other Veffels, in the Harbour of Samana, by the Ships named in the Margin *; and I have no Doubt that their Lordinips will be pleafed with the Promptitude and Decifion by which the Enemy have been difpoffeffed of almost the last Port of Refuge for their Privateers in thefe Seas.

His Majefly's Ship Franchife, Port Royal, SIR, December 1, 1808.

HIS Majelty's Ships named in the Margin* having accidentally met on the 10th Ultimo, and conceiving the taking of the Town and Port of Samana would facilitate the Operations of the Spanish Patriots blockading the City of St. Domingo, I the next Morning entered and took Poffeffion of the Harbour without any Opposition, together with the Vessels, agreeably to the Lift which I have the Honour of inclosing.

I have very fincere Pleafure in reporting, that, in addition to the Afliftance rendered our Allies, I have every Reafon to fuppole the Commerce of His Majefty's Subjects will now pafs unmolefted, as Samana was the laft Refuge for the Hoft of Privateers which have fo long infelted the various Paffages to Wind-

ward of St. Domingo; particularly fo, as the Enemy were in the Act of crecting Batteries for their permanent Effablishment, which, had they been completed, would, from their Polition, have foon rendered the Place tenable against almost any Force which might attack it.

I have allowed the French Inhabitants to remain on their Plantations, and affured them that their Perfons and Property will be refpected by the Spaniards, for which Purpole I have entered into an Agreement with Don Diego de Lira, a Spanish Officer, and authorifed him to hoist Spanish Colours, and to keep the Place, in Truft, until your further Pleasure is known.

I have fupplied them with fuch Arms and Ammunition as were taken in the Privateers; and Don Diego deems himfelf competent to repel any Force which the common Enemy might be enabled to bring against him. I have, &c.

NCLOSED I transmit, for their Lordships' Information, a Letter I have received through Commodore Owen from Captain Newcombe, of the Beagle, stating his having captured Le Vengeur French Privateer, of Sixteen Guns and Forty-eight Men, being the fecond this active Officer has captured within a very short Period.

On examining her Log it appears this Privateer h s made no Captures, and that fhe has been repeatedly chafed; which will fhew that our Cruizers are conftantly on the Alert when at Sea.

SIR, January 24, 1869. I BEG Leave to flate that laft Night, 1119 Majefty's Ship under my Command chafed Two of the Encmy's Privateers, South Foreland bearing about N.N.E. Five Leagues, the one, named Le Vengeur, of Sixteen Guns and Forty-eight Men, was captured; but fuch was the Temerity of her Commander, (Captain Bourgnie,) who was wounded with another of his Crew, that he did not yield until the Bengle ran him on board; the other Veffel, the Grand Napoleon, I am forry to observe, made her Efcape; they were both from Boulogne, and had not made any Captures. TO EXECUTORS AND ADMINISTRATORS. WHEREAS it appears by the Abltracts of Wills and Letters of Administration, returned to the Stamp-Office from the feveral Ecclefiastical Courts, that the Duties granted by the Acts of the 36 Geo. 3. c. 52, 44 Geo. 3. c. 98, and 45 Geo. 3. c. 28, have not been paid in respect of divers Legacies and Annuities bequeathed by Will out of Perfonal or Real Estate, and in respect of divers Relidues of Personal Estate given by Will, or devolved to Next of Kin upon Intellacies, particularly in Cafes where the Executors were themfelves Legatees, or Refiduary Legatees; and where the Administrators were the fole Next of Kin of the Deceafed ;
