The KING's Most Excellent Majesty in Council.

WHEREAS His Majelty was pleafed, by His Order in Council of the Twenty fixth of April laft, to declare certain Ports and Places of the Countries which have been lately ftyled the Kingdom of Holland, to be subject to the Restrictions incident to a strict and rigorous Blockade, as continued from His Majesty's former Order of the Eleventh of November One thousand eight hundred and feven; and whereas Advices have been received of a certain provisional Agreement entered into by His Majeity's Envoy Extraordinary and Minister Plenipotentiary in America, with the Government of the United States, whereby it is underftood that His Majefty's Orders in Council of the Seventh of January and of the Eleventh of November One thousand eight hundred and feven, shall be withdrawn to far as respects the United States, on the Tenth of June next.

And whereas, although the faid Provisional Agree-ment is not fuch as was authorized by His Majefty's Instructions, or fuch as His Majesty can approve, it may already have happened, or may happen, that Perfons being Citizens of the faid United States may be led by a Reliance on the faid Provifional Agreement, to engage in Trade with and to the faid Ports and Places of Holland, contrary to, and in violation of the Restrictions imposed by the faid Orders of the Seventh of January and of the Eleventh of November One thousand eight hundred and seven, as altered by the Order of the Twenty-fixth of April lalt; His Majelty, in order to prevent any Inconveniences that may enfue from the Circum-flance above recited, is pleafed, by and with the Advice of His Privy Council, to order, and it is hereby ordered, That the faid feveral Orders shall be fulpended, fo far as is necessary for the Protection of Vellels of the faid United States, fo failing under the Faith of the faid Provisional Agreement, videlicet, That after the Ninth Day of June next, no Veffel of the United States, which shall have cleared out between the Nineteenth of April last, and the Twentieth of July enfuing, for any of the Ports of I

T the Court at the Queen's Palace, the 24th of Holland aforefaid from any Port of the United States, shall be molested or interrupted in her Voyage by the Commanders of His Majelty's Ships or Privateers.

And it is further ordered, that no Veffels of the United States, which shall have cleared out from any Port of America previous to the Twentieth of July, next, for any other permitted Port, and shall, during her Voyage, have changed her Defination, in confequence of Information of the faid Provisional Agreement, and shall be proceeding to any of the Ports of Holland aforefaid, shall be molested or interrupted by the Commanders of any of His Majefty's Ships or Prizateers, unlefs fuch Veffel shall have been informed of this Order on her Voyage, and shall have been warned not to proceed to any of the Ports of Hol-land aforefaid, and shall, notwithstanding fuch Warning, be found attempting to proceed to any fuch Port

And it is further ordered, that after the faid Ninth Day of June next, no Veffel of the faid United States which shall have cleared out, or be destined to any of the Ports of Holland from any other Port or Place not subject to the Restrictions of the faid Order of the Twenty-fixth of April last, after Notice of fuch Provisional Agreement as aforefaid, shall be molested or interrupted in her Voyage by the Commanders of His Majesty's Ships or Privateers, provided fuch Vessel shall have so cleared out previous to actual Notice of this Order at fuch Place of Clearance, or in default of Proof of actual Notice previous to the like Periods of Time after the Date of this Order, as are fixed for constructive Notice of His Majefty's Order of the Eleventh of November, One thoufand eight hundréd and feven, by the Orders of the Twenty fifth November, One thouland eight hundred and feven, and of the Eighteenth of May One thouland eight hundred and eight, at certain Places and Latitudes therein mentioned, unless fuch Veffel shall been informed of this Order on her Voyage, and warned by high of His Majefty's Ships or Privateers not to proceed to any Port of Holland, and shall, notwithstanding such Warning, attempt to proceed to any fuch Port.

And His Majefty is pleafed further to order, and it is hereby ordered, that the faid feveral Orders or the Seventh of January and Eleventh of Novembef One thouland eight hundred and feven, as altered by

the faid Order of the Twenty fixth of April laft, fhall alfo be fufpended, fo far as is neceffary for the Protection of Veffels of the faid United States which fhall clear out, to any Ports not declared to be under the Reftriction of Blockade from any Port of Holland between the Ninth Day of June and the Firft Day of July next; provided always, that nothing that is contained in the prefent Order fhall extend, or be conflued to extend, to protect any Veffels or their Cargoes, that may be liable to Condemnation or Detention for any other Caufe than the Violation of the aforefaid Orders of the Seventh of January and the Eleventh of November One thoufand eight hundred and feven, as altered by the faid Order of the Twenty-fixth of April laft.

Provided alfo, that nothing in this Order contained (hall extend, or be conftrued to extend to protect any Veffel which (hall attempt to enter any Port actually blockaded by any of His Majelly's Ships of War.

And the Right Honourable the Lords Commillioners of His Majelty's Treafury, His Majelty's Principal Secretaries of State, the Lords Commiftioners of the Admiralty, and the Judge of the High Court of Admiralty, and the Judges of the Courts of Vice-Admiralty, are to give the neceflary Directions herein as to them may respectively appertain. #### PRESENT,

The KING's Most Excellent Majesty in Council.

Hereas by an Act, passed in the Twentyeighth Year of the Reign of His prefent Majesty, intituled " An Act for regulating the Trade between the Subjects of His Majesty's Colonies and Plantations in North America, and in the Weft India Iflands, and the Countries belonging to the United States of America, and between His Majeity's faid Subjects and the Foreign Iflands in the Weit Indies," it is, amongst other Things, enacted, that it shall and may be lawful for His Majelly in Council, by Order or Orders to be iffued and published from Time to Time, to authorife, or by Warrant or Warrants under His Sign Manual, to empower the Governor of Newfoundland for the Time being to authorife, in Cafe of Necessity, the Importation into Newfoundland of Bread, Flour, Indian Corn, and Live Stock, from any of the Territories belonging to the faid United States, for the Supply of the Inhabitants and Filhermen of the Island of Newfoundland for the then enfuing Seafon only; provided always, that fuch Bread, Flour, Indian Corn, and Live Stock, fo authorifed to be imported into the Island of Newfoundland, shall not be imported except in Conformity to fuch Rules, Regulations, and Reftrictions as shall be specified in fuch Order or Orders, Warrant or Warrants refpectively; and except by British Subjects, and in British-built Ships owned by His Majetty's Subjects, and navigated according to Law: And whereas it is expedient and neceffary that Provision be made for fully fupplying the Inhabitants and Fishermen of the Island of Newfoundland for the enfuing Seafon, with Bread, Flour, Peafe, Indian Corn, and Live Stock, and also Pitch, Tar, and

Terpentine, His Majefty doth thereupon, by and with the Advice of His Privy Council, hereby order and declare, that for the Supply of the Inhabitants and Fishermen of the Island of Newfoundland for the enfuing Seafon only, Bread, Flour, Peafe, Indian Corn, and Live Stock, and also Pitch, Tar, and Turpentine, may be imported into the faid Island from any of the Territories belonging to the faid United States, by British Subjects, and in Britishbuilt Ships owned by His Majefty's Subjects, and navigated according to Law, and which within the Space of Nine Months previous to the Time of fuch Importation, have cleared out from fome Port of the United Kingdom of Great Britain and Ireland, or other His Majesty's Dominions in Europe; for which Purpofe a Licence shall have been granted by the Commiffioners of His Majelty's Cultoms in England or Scotland, or the Commiffioners of His Majesty's Revenue in Ireland, or any other Person or Persons who may be duly authorised in that Kingdom respectively, in the Manner and Form hereinafter mentioned; which Licence shall continue and be in Force for Nine Calendar Months from the Day of the Date upon which fuch Licence is refpectively granted, and no longer; provided that no fuch Licence as aforefaid, granted after the Thirtieth Day of September next, shall be of any Force or Effect : And His Majefty is hereby further pleased to order, that the Master or Person having the Charge or Command of any Ship or Veffel to whom fuch Licence shall be granted, shall, upon the Arrival of the faid Ship or Vessel at the Port, Harbour, or Place in the faid Ifland of Newfoundland where he shall discharge such Bread, Flour, Peafe, Indian Corn, Live Stock, Pitch, Tar, and Turpentine, deliver up the faid Licence to the Collector or other proper Officer of the Cultoms there, having first endorsed on the Back of fuch Licence the Marks, Numbers, and Contents of each Package of Bread, Flour, Peafe, Indian Corn, Pitch, Tar, and Turpentine, and the Number of Live Stock, under the Penalty of the Forfeiture in the faid Act mentioned; and the Collector or other proper Officer of the Cuitoms 'at Newfoundland is hereby enjoined and required to give a Certificate to the Mailter or Perfon having the Charge or Command of fuch Ship or Veffel, of his having received the faid Licence fo endorfed as before directed, and to transmit the fame to the Commissioners of His Majetty's Cuftoms in England or Scotland, or to the Commiffioners of His Majetty's Revenue in Ireland refpectively, by whom fuch Licence was granted.

Now be it known, that the faid [Perfon's Name], hath a Licence to lade on board the faid Ship, [Ship's Name] at and from any Port or Place belonging to the United States of America, Bread, Flour, Peafe, Indian Corn, and Live Stock, and also Pitch, Tar, and Turpentine, the Produce of the faid United States, and no other Article whatfoever; and to carry the faid Bread, Flour, Peale, Indian Corn, Live Stock, Pitch, Tar, and Turpen-tine to fome Port or Place in the Island of Newfoundland; and on the Arrival of the faid Ship at any Port, Harbour, or Piace of Discharge in Newfoundland, the Mafter or Perfon having the Charge or Command of the faid Ship, is required and enjoined to deliver up the faid Licence to the Collector or other proper Officer of His Majefty's Cultoms there, and to indorfe on the Back thereof the Marks, Numbers, and Contents of each Pack-age of Bread, Flour, Peafe, Indian Corn, Pitch, Tar, and Turpentine, and the Number of Live Stock, and shall thereupon receive a Certificate thereof from the faid Collector, or other proper Officer of the Cuftoms.

W HEREAS the Time limited by His Majefty's Order in Council of the Twenty-third Day of November last, for prohibiting the Exportation out of this Kingdom, or carrying Coastwile, Gunpowder or Salt-Petre, or any Sort of Arms and Ammunition, will expire upon the Sixth Day of June next: And whereas it is judged expedient for His Majelty's Service, and the Safety of this Kingdom, that the faid Prohibition should be continued for some Time longer, His Majefty doth therefore, by and with the Advice of His Privy Council, hereby order, require, prohibit, and command, that no Perfon or Perfons whatfoever, (except the Mafter General of the Ord-nance for His Majefty's Service,) do at any Time, during the Space of Six Months, to commence from the faid Sixth Day of June next, prefume to transport into any Parts out of this Kingdom, or carry Coastwife, any Gunpowder or Salt-Petre, or any Sort of Arms or Ammunition, or thip or lade any Gunpowder or Salt-Petre, or any Sort of Arms or Ammunition, on board any Ship or Veffel, in order

to transporting the lame into any Parts beyond the Seas, or carrying the lame Coaltwife, without Leave or Permiffion in that Behalf first obtained from His Majefty or His Privy Council, upon Pain of incurring and fuffering the respective Forfeitures and Penalties inflicted by an Act, passed in the Twenty-ninth Year of His late Majefty's Reign, initialed "An "Act to empower His Majefty to prohibit the "Exportation of Salt-Petre, and to enforce the "Law for empowering His Majefty to prohibit "the Exportation of Gunpowder, or any Sort of "Arms or Ammunition; and also to empower "His Majefty to restrain the carrying Coastwife of "Salt-Petre, Gunpowder, or any Sort of Arms or "Ammunition:"—And the Right Honorable the Lords Commiffioners of His Majefty's Treafury, the Commiffioners of the Master-General and the principal Officers of the Ordnance, and His Majefty's Secretary at War, are to give the neceffary Directions herein, as to them may respectively appertain.


