The KING's Most Excellent Majesty in Council.

WHEREAS there was this Day read at the Board, the humble Memorial of Sir Lucas Pepys, Baronet, Phyfician to His Majefty, and Prefident of the College or Commonalty of the Faculty of Phyfic in London, fetting forth, that the faid President and College have, with great Care, Pains, and Indultry, reviled, corrected, and reformed a Book by them formerly published, initialed "Pharmacopœia Collegii Regalis Medicorum Londinenfis," preferibing and directing the Manner of preparing all Sorts of Medicines therein contained, together with the true Weights and Meafures by which they ought to be made; which Book is now perfected, and ready to be published, and it is conceived will contribute to the Public Good of His Majefly's Subjects, by preventing all Deccits, Differences and Uncertainties in making or compounding of Medicines, if, for the future, the Manner and Form preferibed therein fhould be practified by Apothecaries, and others, in their Computitions of Medicines; the Memorialill therefore humbly prays that His Majelly will be graciously pleased to enforce the Observance thereof in fuch Mauner as to His Majefty shall feem meet; His Majefty this Day took the faid Memorial into His Royal Confideration, and being defirons to pro-vide, in all Cafes, for the common Good of His People, and being perfuaded that the effablishing the general Use of the laid Book may tend to the Prevention of fuch Deceits in the making and compounding Medicines, wherein the Lives and Health of His Majelty's Subjects are to highly concerned, hath therefore thought fit, by and with the Advice of His Privy Council, hereby to notify to all Apothecaries, and others concerned, to the Intent they may not pretend Ignorance thereof, that the faid Book, called Pharmacopœia Collegii Regalis Medicorum Londinentis, is perfected and ready to be published; and His Majelty doth therefore ftrictly require, charge, and command all and fingular Apothecaries, and others whole Bufinels it is to compound Me-dicines, or dittil Oils or Waters, or make other Extracts, within any Part of His Majelly's

AT the Court at the Queen's Palace, the 26th of Kingdom of Great Britain called England, Domithat they and every of them, immediately after the laid Pharmacopæia Collegii Regalis Medicorum Londinenfis shall be printed and published, do not compound or make any Medicine or Medicinal Receipt or Prescription, or distil any Oil or Waters, or make other Extracts that are or fhall be in the faid Pharmacopœia Collegii Regalis Medicorum Londinenfis mentioned or named, in any other Manner or Form than is or shall be directed, prescribed, and fet down by the faid Book, and according to the Weights and Meafures that are or shall be therein limited, except it shall be by the special Direction or Prescription of some learned Phylician in that Behalf: And His Majelty doth hereby declare, that the Offenders to the contrary shall not only incur His Majefty's just Displeasure, but be pro-ceeded against for such their Contempt and Offences, according to the utmost Severity of Law.

WHEREAS by an Act, paffed in the Forty-VV third Year of the Reign of His prefent Ma-jefty, intituled " An Act for permitting certain Goods imported into Great Britain, to be fecured in Warehouses without Payment of Duty," it was enacted, that it shall and may be lawful for the Importer or Importers, Proprietor or Proprietors, Confignee or Confignees of any Goods, Wares, or Merchandize enumerated or described in the Table thereunto annexed, marked (C), which shall be legally imported or brought into the Port of London, to land any fuch Goods, without Payment at the Time of the first Entry of fuch Goods, Wares, and Merchandize, of the Duties of Cultom due on the Importation thereof; and fuch Goods may be lodged and fecured at or in fuch Places, and under fuch Rules, Regulations, and Reflrictions as the Commissioners of the Cultoms in England, or any Four or more of them, shall approve and direct, upon the faid Importer, Proprietor, or Confignee entering into Bond to His Majefty, his Heirs, and Succeffors, with One fufficient Surety, to be approved of by the Collector and Comptroller of the Cuftoms of the faid Port of London, in double the Amount of the full Duties due and payable on the Importation of fuch Goods, Wares, and Merchandize, with Condition that fuch Goods, Wares, and Merchandize shall be either duly exported, in the Manner and under fuch Rules, Regulations, and Restrictions, fo far as the same are applicable thereto, as by the faid Act are directed in respect of Goods, Wares, or Merchandize fecured in Warehouses

as aforefaid, and exported directly from thence, or that the full Duties due and payable on the Importation of such Goods, Wares, or Merchandize fhall be paid to the Collector or other proper Officer of the Cultoms, within the Space of Twelve Months from the Date of the first Entry of fuch Goods; and it was further enacted, that if the Lord High Treasurer, or the Commissioners of His Majefty's Treatury for the Time being, or any Three or more of them, shall deem it expedient that the Provisions of the faid Act should be extended to any Goods, Wares, and Merchandize not enumerated or defcribed in either of the Tables annexed thereto, and should cause a List of such Goods, Wares, and Merchandize to be published in the London Gazette, then and from thenceforth all and every the Provisions, Regulations, and Re-flrictions of the faid Act shall extend to such Goods, Wares, and Merchaudize, in every Respect in as full and ample a Manner as if the fame had been inferted and enumerated in the faid Tables respectively at the Time of paffing the faid Act:

We the underfigned Lords Commissioners of His Majefty's Treafury, purfuant to and in Execution of the Powers veiled in us, in and by the faid Act, do hereby declare that it appears to us to be expedient, that the Provisions of the Act should be extended to Oil of Turpentine, legally imported or brought into the Port of London (not being imported by the United Company of Merchants of England, trading to the East Indies, or not being imported from the West Indies, and that fuch Oil of Turpentine should be added to the Lift of Goods, Wares, and Merchandizes enumerated and defcribed in the Table annexed to the faid recited Act, marked (C), and that fuch Oil of Turpentine should be lodged and fecured at or in fuch Places as aforefaid, under the Regulations and Directions of the faid AC: And we do further declare, that from and after the Publication of this our Certificate in the London Gazette, conformably to the Directions of the faid Act, all and every the Provisions, Regulations, and Kestrictions of the laid Act shall extend, and be construed to extend, to all fuch Oil of Turpentine in every respect in as full and ample a Manner as if the fame had been inferted and enumerated in the Table annexed to the faid Act, marked (C,) at the Time of paffing the fame Act.
