WHEREAS the Time limited by His Majesty's Order in Council of the Twenty-fourth Day of May last, for prohibiting the Exportation out of this Kingdom, or carrying Coastwife, Gunpowder or Salt-Petre, or any Sort of Arms or Ammunition, will expire upon the Sixth Day of December next: And whereas it is judged expedient for His Majesty's Service, and the Safety of this Kingdom, that the faid Prohibition should be continued for some Time longer, His Majesty doth therefore, by and with the Advice of His Privy Council, hereby order, require, prohibit, and command, that no Person or Persons w hatsoever, (except the Master General of the Ordnance for His Majesty's Service,) do at any Time, during the Space of Six Months, to commence from the said Sixth Day of December next, presume to transport into any Parts out of this Kingdom, or carry Coastwife, any Gunpowden or Salt-Petre, or any Sort of Arms or Ammunition, or ship or lade any Gunpowder or Salt-Petre, or any Sort of Arms or Ammunition, on board any Ship or Veffel, in order to transporting the same into any Parts beyond the : Seas, or carrying the same Coastwise, without Leave or Permission in that Behalf first obtained from His Majesty or His Privy Council, upon Pain of incurring and suffering the respective Forseitures and Penalties inflicted by an Act, passed in the Twenty-ninth Year of His late Majesty's Reign, intituled; "An "Act to empower His Majesty to prohibit the "Exportation of Salt-Petre, and to enforce the Law for empowering His Majesty to prohibit the Exportation of Gunpowder, or any Sort of "Arms or Ammunition; and also to empower His Majesty to restrain the carrying Coastwife of " Salt-Petre, Gunpowder, or any Sort of Arms or "Ammunition:"—And the Right Honorable; the Lords Commissioners of His Majesty's: Treasury, the Commissioners for executing the Office of Lord High Admiral of Great Britain, the Lord Warden of the Cinque Ports, the Master-General and the principal Officers of the Ordnance, and His Majesty's Secretary at War, are to give the necessary Directions herein, as to them may respectively appertain. And We do further hereby, with the Advice aforefaid, declare Our Royal Will and Pleasure, That the said Parliament shall, on the said Twenty-third Day of January next, be held and fit for the Dispatch of divers urgent and important Affairs: And the Lords Spiritual and Temporal, and the Knights, Citizens, and Burgeffes, and the Commissioners of Shires and Burghs of the House of Commons, are hereby required and commanded to give their Attendance accordingly at Wellminster, on the faid Twenty-third Day of January next.
