

An Act to provide for a durable Allowance of Superannuation to the Officers of Excise in Scotland, under certain Restrictions.

An Act for discontinuing the Bounty on Exportation of Oil of Vitriol, and allowing a Drawback of a Proportion of the Duties paid on the Importation of foreign Brimstone, used in making Oil of Vitriol.

An Act for placing the Duties of Hawkers and Pedlars under the Management of the Commissioners of Hackney Coaches.

An Act to extend the Provisions of an Act passed in the Forty-eighth Year of His present Majesty's Reign, intituled, An Act to permit certain Goods imported into Ireland to be warehoused or secured without the Duties due on the Importation thereof being first paid, and to amend the same.

An Act to alter, amend and enlarge the Powers of Two Acts passed, for making and maintaining a navigable Canal from the River Thames or Isis, at or near the Town of Abingdon, in the County of Berks, to join or communicate with the Kennet and Avon Canal at or near the Town of Trowbridge, in the County of Wilts; and also certain navigable Cuts therein described.

An Act for inclosing, draining and preserving Lands in the Parish of Thirne, in the County of Norfolk.

An Act for amending and enlarging the Powers of an Act of the Ninth Year of His present Majesty, for the more effectual draining and preserving certain Fen Lands and Low Grounds in the Hamlet of Wimblington, in the Parish of Doddington, and in the Parish of Chatteris, in the Isle of Ely, in the County of Cambridge, so far as the said Act relates to the Lands in the second District therein described.

An Act for amending, enlarging and extending the Powers of an Act passed in the last Session of Parliament, relating to the Execution of the Commission of Sewers for the Limits, from East Moulsey, in Surrey, to Ravensthorpe, in Kent.

An Act for repairing or re-building the Parish Church of Stockport, in the County-Palatine of Chester; and for re-building the Tower thereof; and for making a Cemetery or Church Yard for the Use of the said Parish.

An Act for better and more effectually paving, lighting, cleansing, watching and otherwise improving the Streets, Ways and other public Passages and Places in the City and County of the City of Exeter.

An Act for forming, paving and otherwise improving certain Streets and other public Passages and Places in the Parish of Saint Pancras, in the County of Middlesex, which are or shall be made upon Ground belonging to Joseph Lucas, Esquire.

An Act for paving the Footways and Cross Paths, and lighting, cleansing and regulating the Streets, Lanes and other public Passages and Places in the Town and Parish of Romsey-Infra, and in the Parish of Romsey-Extra, in the County of Southampton.

An Act for making more effectual Provision for lighting, watching, paving, cleansing, regulating and improving the Streets and other public Places in the Parish of Saint Luke, in the County of Middlesex.

An Act for supplying with Water Upper and Lower Holloway, Highbury, Cannonbury, Upper

Islington and their respective Vicinities, all in the Parish of Saint Mary Islington, in the County of Middlesex; and for other Purposes relating thereto.

An Act for raising a further Sum of Money for carrying into Execution the several Acts passed for making Wet Docks, Basons, Cuts and other Works for the greater Accommodation and Security of Shipping, Commerce and Revenue within the Port of London.

An Act for maintaining and keeping in Repair Roads made and Bridges built in Scotland, under the Authority of the parliamentary Commissioners for Highland Roads and Bridges.

An Act for authorizing the Removal of the Infirmary of the County of Kildare, from the Town of Kildare to the Town of Naas.

An Act for repealing an Act passed in the Thirty-third Year of His present Majesty, intituled, An Act for amending, improving and keeping in Repair several Roads leading to and from the City of Bath, and for granting other Powers for more effectually improving the several Roads therein described, being in and leading to and from the said City.

An Act for more effectually amending, widening and keeping in Repair the Roads leading from the Town of Northampton to Chain Bridge, near the Town of Market Harborough, and from the Direction Post in Kingsthorpe, in the County of Northampton, to Welford Bridge, in the same County.

And Twenty-six Private Acts.

The King has been graciously pleased to give and grant unto Francis Brian Hill, Esq; His Majesty's Secretary of Legation at the Court of Rio Janeiro, His Royal Licence and Permission that he may, in compliance with the Desire of His Royal Highness the Prince Regent of Portugal, accept the Rank, and wear the Insignia, of a Knight Commander of the Royal Portuguese Order of the Tower and Sword, which that Prince has been pleased to confer upon the said Francis Brian Hill, as a Mark of His Royal Esteem and Regard:

And also to order, that His Majesty's said Concession and Declaration be registered, together with the relative Documents, in His College of Arms.

VICE-ADMIRAL SIR JAMES SAUMAREZ has transmitted to John Wilson Croker, Esq; a Letter he had received from Captain Sayer, of His Majesty's Sloop the Raleigh, giving an Account of his having, in Company with the Alban and Princess of Wales Cutters, engaged off the Scaw, on the 23d of last Month, a Danish Flotilla of Seven Gun-Boats, one of which was blown up, and the rest dispersed, greatly damaged:

And also a Letter from Captain Watts, of His Majesty's Sloop the Woodlark, reporting the Destruction of a Danish Cutter Privateer the Swan, of Six Guns and Thirty-five Men, on the 27th of the same Month, under the Protection of Batteries and Field-Pieces on the Island of Lassoc, by the Boats of the Woodlark, commanded by Lieutenant Thomas-Crawford.
