A DMIRAL LORD GAMBIER has transmitted to John Wilson Croker, Elq; a Letter from Captain Hotham, of His Majesty's Ship the Defiance, giving an Account of the Boats of that Ship, under the Directions of Lieutenants William Style and George Hutchinson, having on the 1st Instant, after a Pursuit of Six Hours rowing, captured and brought out from under Two Batteries at Belleisle, and the Fire of some Field Pieces and Armed Vessels, Three Co ffe Marées, laden with Wine and Rosinfor L'Orunt.

HE following Address has been transmitted to His Majesty's Principal Secretary of State for the Home Department, and has been presented by him to the King; His Majesty was pleased to receive it in the most gracious Manner.

To the KING's Most Excellent Majesty.

Most Gracious Sovereign,

WE. Your Majesty's most dutiful and loyal Subjects, the Mayor, Aldermen, Burgeffes and Commonalty of the Borough of Great Yarmouth, in the County of Norfolk, in Common Council affembled, beg Leave to approach Your Majesty, with the most unfeigned Assurances of our Attachment to Your Majelty's facred Person, and to express with what Sorrow and Indignation we have viewed the late infidious Efforts to alienate the Af-fections of Your Majesty's People from the Government, as well as to bring into Distrust and Contempt that most essential Part of our legislative Body the House of Commons; Efforts which, professing Reform, have no other Object in view than the total Destruction of our most invaluable Constitution and System of Society, at once the noblest Monument and the firmest Bulwark of Civilization.

Under these Circumstances we beg to assure Your Majesty, it is our fixed Determination to rally round the Throne; to maintain unimpaired the Privileges of both Houses of Parliament; to result all Attempts at specious Innovation; and to place our perfect Confidence in the Wisdom of the Legislature, and

in the Purity of the Judges of the Land.

An Act for granting to His Majesty a Sum of Money to be railed by Lotteries.

An Act to grant to His Majesty certain additional Duties upon Letters and Packets sent by the Post within Ireland.

An Act to grant to His Majesty an additional Duty on Dwelling Houses in Ireland, in respect of the Windows or Lights therein.

An Act to repeal certain Duties under the Care of the Commissioners for managing the Stamp Duties in Ireland, and to grant new and additional Duties,
