BEG leave to inform you, that at Two o'Clock this Morning, St. Valery en Ceaux, bearing S. S. E. about Four Miles, His Majesty's Sloop under my Command captured, after a short Chace, the French Lugger Privateer Roi de Naples, of Fourteen Guns and Forty-eight Men; a few Hours from Dieppe, and had made no Capture.

WHEREAS by an Act passed in the Forty-third Year of His present Majesty's Reign, intituled, "An Act for permitting certain Goods, imported into Great Britain, to be secured in Warehouses, without Payment of Duty," it is amongst other things enacted, That it shall and may be lawful for the Importer or Importers, Proprietor or Proprietors, Confignee or Confignees, of any of the Goods, Wares, or Merchandizes enumerated or described in the Table thereunto annexed, marked (E); and which shall have been legally imported or brought into the Port of London, to lodge and fecure in a Warehouse or Warehouses to be provided for that Purpose any such Goods, Wares, and Merchandize, under the joint Locks of the Crown and the Merchant, without Payment, at the Time of the first Entry, of the Duties of Customs due on the Importation thereof: Provided always, and it is thereby further enacted, that no Goods, Wares, or Merchandize so enumerated or described in the faid Table marked (E), shall be permitted to be so lodged or secured, unless and until it shall have been made appear to the Satisfaction of the Lord High Treasurer, or the Commissioners of His Majesly's Treasury for the Time being, or any Three or more of them, that the said Warehouse or Warehouses are complete, fit, and proper, in every respect, for the Reception of such Goods, Wares, or Merchandize, and wherein the same may be safely and securely deposited; and such Goods, Wares, and Merchandize so lodged and secured in such Warehouses, shall, in all other respects, be subject and liable to the Rules, Regulations, and Restrictions in that Act contained:

Provided always, and it is thereby enacted, that if the Lord High Treasurer, or the Commissioners of His Majesty's Treasury for the Time being, or any Three or more of them, shall deem it expedient that the Bariston of the first A. A. Stell he are traded. that the Provisions of the said Act shall be extended to any Goods, Wares, and Merchandize not enumerated or described in either of the Tables thereto annexed, and shall cause a List of such Goods,

Wares, and Merchandize to be published in the London Gazette, then and from thenceforth all and every the Provisions, Regulations, and Restrictions of the faid Act shall extend and be construed to extend to fuch Goods, Wares, and Merchandize in every respect, in as full and ample a Manner as if the same had been inserted and enumerated in the faid Tables respectively at the Time of passing this Act.

We the underligned Lords Commissioners of His Majesty's Treasury, pursuant to and in Execution of the Powers vested in us, in and by the said Act, do hereby declare that it appears to us to be expedient that the Provisions of the said A& should be extended to Gum Copal, legally imported or brought into the Port of London, (not being imported by the United Company of Merchants of England, trading to the East Indies, or not being imported from the West Indies), and that such Gum Copal should be added to the List of Goods, Wares, and Merchandize enumerated and described in the faid Table annexed to the faid recited Act, marked (E), and that fuch Gum Copal should be lodged and secured under the joint Locks of the Crown and the Merchant in such Warehouse or Warchouses as aforesaid, under the Regulations and Directions of the faid Act: And we do further declare, that from and after the Publication of this our Certificate in the London Gazette, conformable to the Directions of the faid Act, all and every the Provisions, Regulations, and Restrictions of the said Act, shall extend, and be construed to extend to all fuch Gum Copal in every respect, in as full and ample Manner as if the fame had been inserted and enumerated in Table (E) annexed to the faid Act, at the Time of the passing the same A&.
