and to take care that the fame be timely difperfed throughout their respective Diocefes.

may be jully inflicted on all fuch as contemn and neglect the Performance of fo religious and neceffary a Duty: Our Will is, therefore, and We charge, That this Our Proclamation feen, ye forthwith proceed to the Market Crofs of Edinburgh, and all other Places needful, and there, in His Majefty's Name and Authority, make Publication hereof, that none pretend Ignorance : And Our Will and Pleasure is, That His Majelty's Solicitor do cause printed Copies hereof to be fent to the Sheriffs of the feveral Shires, Stewarts of Stewartries, and Bailiffs of Regalities, and their Clerks, whom We ordain to fee the fame publifhed; and We do appoint them to fend Copies hereof to the feveral Parish Churches within their Bounds; and that, upon the Lord's Day imme-diately preceding the Day above-mentioned, the fame may be published, and read from the Pulpits rimmediately after Divine Service.

WHEREAS the Time limited by His Majely's VV Order in Council, bearing Date the Fif-teenth Day of November One thousand eight hundred and nine, for the Payment of the Bounties for the Encouragement of Seamen and Landmen to enter into His Majelly's Royal Navy, and the Re-enter of diffeovering Seamen who may conceal "themfelves, fo that fuch Seamen should be taken for His Majefty's Service ; and alfo the Rewards to Perfons who thould procure the voluntary Service of Able and Ordinary Seamen, and Landmen, fit for His Majefty's Naval Service, and fhould convey fuch Sea-men and Landmen on board any of His Majefty's Ships and Veffels, or to any of His Majefty's Sca-Officers employed in raifing Men, has expired; which Bounties and Rewards are as follows, that is to fay, To every Able Seaman not above the Age of Fifty, nor under the Age of Twenty Years, who fhould enter himfelf to ferve in His Majefty's Royal Navy, a Bounty of Five Pounds; and to every Ordinary Seaman lo entering himfelf, and not above the Age of Fifty, nor under the Age of Twenty Years, a Bounty of Two Pounds Ten Shillings; to every Able-bodied Landman not above the Age of Thirty-five, nor under the Age of Eighteen Years, fo en-tering himfelf, a Bounty of Thirty Shillings; to every Perfon or Perfons who shall diffeover any Able or Ordinary Seaman or Seamen who may have concealed him or themfelves, fo that fuch Seaman or Seamen shall be taken for His Majelty's Service by any of His Majetty's Officers employed to raife Men, a Reward of Three Pounds for every fuch Able Seaman, and Fifty Shillings for every fuch Ordinary -Seaman, fit to ferve on board His Majelly's Ships ;

to any Perfon or Perfons who shall procure the voluntary Service of Able or Ordinary Seamen or Landmen fit for His Majefty's Service, and fhall convey them on board any of His Majefty's Ships or Veffels, or to any of His Majefty's Sea Officers employed in raifing Men, a Reward of Three Gui-neas for every foch Able Seaman, Two Guineas for every fuch Ordinary Seaman, and One Guinea for every fuch Landman, together with an Allowance, at the Rate of One Penny per Mile, for each Able Seaman, Ordinary Seaman, and Landman, for every Mile fuch Men may refpectively travel to the nearest of His Majelly's Ships of War, or nearest Place of Refidence of any of His Majelty's Sea Officers employed in railing Men ; provided fuch Man shall be found fit for His Majesty's Service, and there shall not be Reason to suppose that he is an Apprentice: And whereas it is expedient that the faid feveral Bounties, Rewards, and Travelling Allowance (hould be continued to be paid for fome Time longer, His Royal Highnefs the Prince Regent, in the Name and on the Behalf of His Majelly, and by and with the Advice of His Privy Council, doth therefore order, and it is hereby accordingly ordered, that the Payment of the faid Bounties, Rewards, and Travelling Allowance be continued to the Thirty-first Day of December One thousand eight hundred and eleven, inclusive; and that the fame be paid in the Manner fpecified in His Majefty's feveral Proclamations now in Force for the Encouragement of Seamen and Landmen to enter into His Majefty's Royal Navy, and for the different Seamen who may conceal themfelves, and for giving Rewards for procuring the voluntary. N reply to your Letter of this Day's Date, tranf-1 mitting to me a Copy of a Letter from Captain Peter Parker, of His Majefty's Ship Menelaus, requefting that a Reference may be made to me with regard to the Proceedings of that Ship in the late Operations at the Isle of France, her Name not appearing in the Dilpatch from Vice-Admiral Bertie, as having been prefent on that Occafion, and fignifying to me their Lordships' Directions to report to them what I may know of the Circum-flances of the Cafe; I beg Leave to flate my full Perfuation that the Omifion of the Name of the Menelaus, in the Vice-Admiral's Difpatch, was entirely accidental; that the joined the Squadron previous to any Operations being undertaken for an Attack on the Island; that upwards of One Hun-dred Scamen and Marines of her Crew, were landed to co-operate with the Troops; and that Capitain Parker having been employed under my immediate Direction off Port Louis, I am happy to have an Opportunity of bearing Teflimony to the diffin-guished Zeal and Ability of his Conduct.

Copy of a Letter from Lieutenant Richard Barton, alling in the temporary Command of His Majesty's Ship the Blanche, addreffed to Captain Flint of the Wilhelmina, and transmitted by Vice-Admiral Drury to John Wilfon Croker, Efq.

His Majesty's Ship Blanche, Port Cornwallis, SIR, Prince of Wales's Island, Aug. 2, 1810. BEG Leave to acquaint you, for the Informa

tion of his Excellency the Commander in Chief, that on the 26th Ult. in Latitude 5° 20' North, Longitude 98° 22' East, I had the Satisfaction of falling in with, and after a chase of Eight Hours, captured La Confiance French Privateer, of Two long Six-Pounders and a Quantity of fmall Arms, having on board a Complement of Thirty Men. The Confiance failed from the Isle of France in May last, and had made Two or Three Captures.


