may be jully inflicted on all fuch as contemn and neglect the Performance of fo religious and necessary a Duty: Our Will is, therefore, and We charge, That this Our Proclamation feen, ye forthwith proceed to the Market Cross of Edinburgh, and all other Places needful, and there, in His Majesty's Name and Authority, make Publication hereof, that none pretend Ignorance: And Our Will and Pleasure is, That His Majesty's Solicitor do cause printed Copies hereof to be fent to the Sheriffs of the several Shires, Stewarts of Stewartries, and Bailiffs of Regalities, and their Clerks, whom We ordain to fee the same published; and We do appoint them to fend Copies hereof to the feveral Parish Churches within their Bounds; and that, upon the Lord's Day immediately preceding the Day above-mentioned, the fame may be published, and read from the Pulpits rimmediately after Divine Service.

Given at Our Court at Carlton-House, this Eighth Day of February One thousand eight hundred and eleven, in the Fifty-first Year of His Majesty's Reign.

AT the Court at Carlton-House, the 8th Day of February 1811,

PRESENT,

His Royal Highness the PRINCE REGENT in Council.

WHEREAS the Time limited by His Majetty's VV Order in Council, bearing Date the Fif-teenth Day of November One thousand eight hundred and nine, for the Payment of the Bounties for the Encouragement of Seamen and Landmen to enter into His Majesty's Royal Navy, and the Re-caused for discovering Seamen who may concean themselves, fo that such Seamen should be taken for His Majesty's Service; and also the Rewards to Perfons who thould procure the voluntary Service of Able and Ordinary Seamen, and Landmen, fit for His Majesty's Naval Service, and should convey such Sea-men and Landmen on board any of His Majesty's Ships and Vessels, or to any of His Majesty's Sca-Officers employed in raifing Men, has expired; which Bounties and Rewards are as follows, that is to fay, To every Able Seaman not above the Age of Fifty, nor under the Age of Twenty Years, who should enter himself to serve in His Majesty's Royal Navy, a Bounty of Five Pounds; and to every Ordinary Seaman to entering himself, and not above the Age of Fifty, nor under the Age of Twenty Years, a Bounty of Two Pounds Ten Shillings; to every Able-bodied Landman not above the Age of Thirty-five, nor under the Age of Eighteen Years, fo entering himself, a Bounty of Thirty Shillings; to every Person or Persons who shall discover any Able of Ordinary Seamon by Saamon who many the control of the Control or Ordinary Seaman or Seamen who may have concealed him or themselves, so that such Seaman or Seamen shall be taken for His Majesty's Service by any of His Majesty's Officers employed to raise Men, a Reward of Three Pounds for every such Able Seaman, and Fifty Shillings for every such Ordinary Seaman, fit to serve on board His Majesty's Ships;

to any Person or Persons who shall procure the voluntary Service of Able or Ordinary Seamen or Landmen fit for His Majesty's Service, and shall convey them on board any of His Majesty's Ships or Vessels, or to any of His Majesty's Sea Officers employed in raising Men, a Reward of Three Guineas for every such Able Seaman, Two Guineas for every such Ordinary Seaman, and One Guinea for every such Landman, together with an Allowance, at the Rate of One Penny per Mile, for each Able Seaman, Ordinary Seaman, and Landman, for every Mile such Men may respectively travel to the nearest of His Majesty's Ships of War, or nearest Place of Residence of any of His Majesty's Sea Officers employed in raising Men; provided such Man shall be found fit for His Majesty's Service, and there shall not be Reason to suppose that he is an Apprentice: And whereas it is expedient that the faid feveral Bounties, Rewards, and Travelling Allowance should be continued to be paid for fome Time longer, His Royal Highness the Prince Regent, in the Name and on the Behalf of His Majetty, and by and with the Advice of His Privy Council, doth therefore order, and it is hereby accordingly ordered, that the Payment of the faid Bounties, Rewards, and Travelling Allowance be continued to the Thirty-first Day of December One thousand eight hundred and eleven, inclusive; and that the same be paid in the Manner specified in His Majesty's several Proclamations now in Force for the Encouragement of Seamen and Landmen to enter into His Majesty's Royal Navy, and for the discovering Seamen who may conceal themselves, and for giving Rewards for procuring the voluntary Service of Seamen and Landmen; whereof all Persons concerned are to take Notice and govern themselves accord-W.
