 - The dutiful and loyal Address of the Freeholders of the County of Tipperary, legally convened and affembled at Thurles, on Monday the 15th Day of April 1811.

May it please Your Royal Highness, WE, the Freeholders of the County of Tipperary, legally convened and affembled at Thurles, most humbly approach Your Royal Highness, with the warmest Assurances of affectionate Attachment to Your Royal Perfon, and unfhaken Adherence to those facred Principles which feated your Family on the Throne of these Realms; fully convinced that those Principles afford the beft Security to the Honour and Dignity of the Sovereign, and the Rights and Interests of the People.

In offering to Your Royal Highnels our fincere Condolence upon the fevere Affliction with which it has pleased Divine Providence to visit our most gracious Sovereign, it is with heart-felt Confolation that in common with all Ranks of our Fellow-Subjects, we behold the momentous Functions of the Executive Power vefted in a Prince fo highly endowed and fo eminently qualified to exercise the Regal Duties-a Prince who has fo greatly endeared himfelf to the Hearts of all His Majelty's People by his Moderation and Forbearance on various trying Occations, and by the Attachment he has to uniformly shewn to their Rights and Liberties. Much more proudly and confidently fhould we have felt this confolatory Sentiment, had the Defire and Expectation of the United Kingdom been realized by confiding to Your Royal Highness the full Powers of the Executive Authority, affured as we feel that these Powers would be wifely and beneficially exercifed to enable the whole Body of your People to meet the extraordinary Exigencies of fo perilous a Crifis ; allured as we are that the national Valour would be ftimulated by a wile and dignified,

Favour; that Patriotism, in its purest and molt genuine Meaning, would be identified with Power; and that the only Medium by which the People of thefe Realms could view the Supreme Magittrate of the State, would be through the Irradiations diffuled around him from Acts of Benignity and Munificence.

Fain would we have been to forbear clouding the Dawn of our Intercourfe with Your Royal High-nels by a Glance even at the Name of Grievances, manifold, weighty, and pernicious as those are to which we more particularly apply ourfelves; but the Duty we owe to our Sovereign and our Country, the Reverence we owe to the Memory and Example of our Forefathers, and the Justice that is claimed towards our Posterity, the Fame, the Hap-pinefs, and the Safety of the Empire, all with irre-fillible Force forbid us to difguife our Thoughts or fmother our Feelings.

We fee, with a mixed Contemplation of Shame and Sorrow, the political Unity of a great People hazarded; we fee Ireland, the most effential Bulwark of the British Name and Glory, paralyzed in her Exertions, degraded in her Character, her Valour checked by unworthy Sufpicion, her Emu lation represed by fervile and unwarrantable Diftinctions, her People divided without Meaning, and her Strength and her Integrity depreciated by Im-putations that at once fhe difclaims and detefts; and laying before Your Royal Highness the common Sentiments of a loyal, generous, and ardent People, of all religious Perfuations, we do most humbly implore Your Royal Highnefs's early and earnelt Atiention to the Situation of the Irith Catholics.

By the prefent Syllem of Laws, the Catholic of Ireland is mocked and tantalized, by having laid open to him every Avenue, (that to the Church alone excepted,) which leads to Wealth, and Power, and Dignity; and in this he may drudge and labour in the dull and difcouraging Purfuits of Science that are diminished as the bulk to the terms to Science that are diverted of all those Lures to Activity by which every other Defcription of Men are incited to great Exertion; or he may fight and fall in the Field, under a Senfe of Duty abitracted from all the nobleft and most inspiring Incentives to Glory. In either Cafe he is fo circumstanced, that the Zeal which in others animates Study, or invigorates Labour, and the Heroifm that impels to Deeds of Valour, are damped and chilled in him by the heartrending Reflection that, however meritorioufly or nobly he may itruggle for the final Advantage, he can never attain it; that however he may be permitted to wafte his Life in purfuing the Path to Fame and Power, the Entrance, when he arrives at it, is that for ever against him.

By this Syllem of Laws, and the Syllem of Government confequently acting upon them, the remaining Reffrictions which operate against the Roman Catholics exhibit the Appearance of a blind Infatuation, conferring on French and other foreign Roman Catholic Officers what it offenfively refules to Native Irifh; filling the Hearts of the Irifh Millions with Indignation and Refentment, and laying them open to the Influence of Paffions which cannot be contemplated without Terror.

In befeeching Your Royal Highnets's favourable Attention to our common Supplication, we approach Your Royal Highnels with the greater Degree of Confidence, becaufe we cannot but hope that, when

becaufe an impartial, Distribution of Reward and the Two great Classes of Protestant and Catholic, Favour; that Patriotism, in its purest and molt for mutual Prefervation, shall make common Cause genuine Meaning, would be identified with Power; in pursuit of an Object that we all think indifpenfable, the few but odious remaining Reftrictions upon the Catholic Body, fmitten by the united Rays of the Law, the Conflitution, the Nation, and the Throne, must, like a noxious Exhalation, melt and difappear.

We do, therefore, humbly entreat that Your Royal Highnels may be gracioully pleafed to re-commend to the Imperial Parliament the immediate Confideration of the State of the Irifh Catholics, and the urgent Neceffity of refloring them to the full Participation of all the Advantages and Bleffings of our glorious Conftitution ; Bleffings and Advantages to which we humbly fubmit, that they are now highly and jufily entitled to a fill more ample Extent than what was affured to that Body under the folemn Treaty of Limerick, figued by King William; to the Security of which they have, in much more than a proportionate Degree, contributed by their Treafure and their Lives; to the Enjoyment of which, under Your Royal Highness and every Branch of your illustrious Family, they have eminently entitled themfelves, by an unabated Loyalty toward the Houfe of Brunswick, and by their uniform, ardent, and steady Attachment for Six Hundred and Fifty Years to their natural Alliance with Great Britain; in fupport of which every Battle that hath been fought, and every Victory that has been gained from the earlieft Periods of our Hiltory, under the British Banners by Sea or Land, in every Climate of the Earth, has been highly attributable to Irifh Valour and Irifh Loyalty, bleeding and dying for British Glory, and fealing with the best Blood of Ireland the Bond of British Connexion.

With thefe Views, may it pleafe Your Royal Highnefs, we truft that it will appear but a Claim of common Justice on behalf of this numerous, opulent, and loyal Majority of the Irish People, that they fhould at once be freed from every Species of Restriction and Difability, and be placed on a full and fair Footing of perfect Equality with the most

favoured of His Majefly's molt loyal Subjects. In thus approaching Your Royal Highnefs with our fincere Congratulations, we have attempted to difcharge an honeft Duty, at once to Your Royal Highnels and the People of the Empire, in humbly fuggefting a Measure, by the Recommendation and Accomplishment of which Your Royal Highness will enfure the Gratitude and combine the Strength of this vaft Portion of the Empire, and entail upon your Name and Character the Love, Admiration, and Bleflings of the Time in which you live, and the Reverence of Ages yet to come.

HAVING discovered Four Veisels at Anchor An Act to repeal fo much of an Act, passed in under Pettichi, it being nearly calm, I dispatched the Eighteenth Year of the Reign of King George the Barges of this Ship and the Active, under the

Command of Lieutenant Haye of the latter, to attempt bringing them out, in which he com-pletely fucceeded, although exposed to a heavy Fire of Musketry from the Soldiers quartered at that Place.

Lieutenant Haye speaks in high Terms of the Conduct of the Petty Officers, Seamen, and Royal Marines employed under him for their cool and fleady Conduct on the Occasion.

SIR, February 13, 1811. HAVING completed the Water of His Ma-jefty's Ships under my Command at Liffa, on the oth Inftant, I proceeded to reconnoitre the Coaft of Italy with this Ship and Active, in hopes of intercepting Veffels which were reported to have failed from Ancona for Corfu and taken Shelter in various Harbours along the Coaft, during the Southerly Winds just tet in.

On the Morning of the 12th Inftant we discovered feveral Veffels lying under the Town of Ortano, and as the Wind was light, the Boats of both Ships were difpatched, under the Orders of Lieutenant Dickinfon (First of the Cerberus), to bring them out if practicable. On the near Approach of the Boats to the Veffels a Fire of great Guns and small Arms was inflantly opened from an Armed Trabaccolo (which was not till then observed), and Soldiers posted on the Beach and Hills commanding the Bay; our Boats formed in close Order, gave Three hearty Cheers, and in a few Minutes cleared all before them, the Men from the Veffels and the Troops on fhore running in all Directions.

To prevent any Annoyance whilft the Prizes were bringing out, Lieutenant Dickinfon landed with the

Marines under Lieutenant Mears of that Corps embarked in the Active, and a Division of small Arm Men under Mr. James Rennie, Matter's-Mate of this Ship, taking a strong Position on the Hills, and planting the British Flag at the very Gates of the Town, whill the Launches, under Lieutenants Haye and Campfton, with the Barge of the Active, under Mr. James Gibson, Master's Mate of that Ship, were employed incovering them with the Carronades. This judicious and advantageous Movement was of the greateft. Service to those employed at the Sea Side, as it kept the Soldiers and Inhabitants, who had collected in great Force, in check, and allowed the Work which had been fo ably undertaken to be most fully completed, as in addition to the Convoy confifting of Ten Sail (under the Veffel armed with Six Guns), which was found in the Harbour laden with Grain, Oil, &c. Two large Magazines filled with all Sorts of Naval and Military Stores deftined for the Garrilon of Corfu, (and which it is faid they ftand in much need of,) was most completely de-ftroyed by Fire, and I feel convinced the Enemy will fuffer most feverely by this Capture, as they must have been fome Time in making fo large a Collection. As I believe you are unacquainted with the Situation of Ortano, I must beg Leave to state it, and you will then be able to form your own Opinion of the Difficulties that exifted and to which our Men and Boats were neceffarily exposed.

The Harbour is formed by a large Pier running out into the Sea, and connected with a Range of Hills leading to the Town, which stands on the Top of the higheft, completely commanding the Veffels in the Bay and the Road up to it, fo that the Marines, to gain the ftrong Poft they had, and to prevent being expoled to the fevere Fire of Musketry, were obliged to climb up the Rocks by their Hands, with a Prospect of falling down a Precipice every Step they took.

Having detailed to you, Sir, the Particulars of this Service, I have much Pleafure in adding that our Lofs has been only Four wounded; and when it is confidered that they were exposed to a teazing Fire from the Bushes and Houses from Ten in the Morning until Three in the Afternoon, it will, I truft, be thought trifling in comparison with the Annoyance the Enemy have received by the (apture and Destruction of their Magazines and Veffels.

I cannot fpeak too highly of the gallant Conduct of Lieutenant Dickinfon on this Occafion; the Style in which he boarded the Trabaccolo, armed with Six Guns and full of Men, with the Gig of this Ship, fupported by the Barge under Mr. Rennie, (of whom he fpeaks in the higheft Terms of Praife,) forms only a Imail Part of his Merit; his Arrangements being fo well made and fo promptly executed by those under him, were fuch as to have enfured the moft complete Succefs, could it have been poffible for the Enemy to have collected any additional regular Force, with that already oppofed to them.

No Language I can make use of is strong enough to express the Zeal and Conduct of every Person concerned.

I feel particularly indebted to Captain Gordon of the judicious Manner his Ship was placed, by which Means he prevented any Body of the Enemy from forming in the Rear of our Men, and the Promptitude and zealous Co-operation I have constantly experienced from him fince we have been ferving together.


