  - The humble Address of His Majesty's Catholic Subjects whole Names are hereunto fubfcribed, as well for themfelves as others His Majefty's Subjects profeffing the Catholic Faith in Ireland.

May it pleafe Your Royal Highnefs, W E, the Roman Catholics of Ireland, compelled once more to approach Your Royal Highnefs, by an Administration which has impaired the Vigour and diminished the Lustre of the Crown in the Perfon of Your Royal Highness, beg Leave to express our unlimited Attachment and entire Devotion to Your Perfon and Government, our almost infuperable Reluctance. thus again to entreat your Attention and Interpolition, and our full and confiderate Senfe of the Delicacy and Difficulties of Your Royal

Highnels's Situation. With Alarm and Difmay we have learned that a Bill now pending in Parliament, for the respective Transfer of the Militia Service of the Two Countrics, contains no Provision whatever for the free Exercife of his Religion, on the Part of the Ca-tholic Soldier, who, in the Event of fuch Bill paffing into a Law, may be placed on the English Eftablishment; and we cannot fufficiently express our Fears at an Omiffion fo potentous, and at the Confequences with which it feems to us fo pregnant.

We beg Leave most respectfully to represent to Your Royal Highness, that this deliberate and publicly avowed Omiffion appears to us to aim an infi-dious, but perhaps not lefs mortal, Blow at the Freedom of religious Opinions, and of correspondent Worship, and that the Issue of a General Order as a Substitute can neither be received nor acknowledged as a fair Exchange or Equivalent for the Protection of Law, the Solemnity of an Act of Par-liament, and the best Guards and Assurances of the British Constitution.

Your Royal Highnels requires not to be informed

that the religious Security of the Catholic Soldier in his Native Land stands on the Basis of an Act of Parliament; that the Constitution of his Country is his Charter for the Independence of his Coultry is that this Bill calls upon him to barter away that Charter for a general Order, revocable in its Nature, uncertain in its Duration, precarious in its Effect, and open to much diferentionary Latitude of Interpretation; and that being placed by this Bill under the Controul of an Individual or Individuals, his Religion is exposed to the Whims of Caprice, the Influence of Prejudice, and the Intolerance of Bigotry. We cannot fo far deceive outfelves as to confider this doubtful, this gratuitous Order as a Security; as the Law now flands it is illegal, and the Guarantee it offers is a Violation of the Conflitution:

We most humbly entreat Your Royal Highness to confider, that did this Bill contain a diffinct and fpecific Provision for the Freedom of religious Worship, still without a Clause for the Supply of Catholic Chaplains to the respective Militia Re-giments, its Operation would be illusory and fallacious, and, under Colour of a Reality, prefent nothing but a Phantom.

We beg Leave further to fubmit, that the Interefts of the State and thole of the Service are intimately connected and identified with the Morality of the Soldier, and that to deprive him of his Religion, is to strike at its Existence.

Your Royal Highnefs is most humbly requested to observe, that the Adhesion of the Irish Catholic to the Faith and religious Forms of his Forefathers is, perhaps, the most prominent Feature in his marked and manly Character; that to play with his warmest Feelings, and strike at his dearest Sen-sibilities, is at all Times an Experiment of most illjudged Policy; that when England's Contell is for National Existence, it is an Infatuation incompre-hensible; and that the future Heroes of Talavera, Maida, and Barrofa are richly entitled, if not to British Gratitude, at least to British Confideration.

Under these our Feelings we most respectfully apply to the Wifdom, the Liberality, the Juffice, the confitutional Principles, the Largeneis of Your Royal Highneis's Mind, for the Rights of our Conficiences and the Independence of our Religion; we crave your Interpolition and Protection, and we pray that the

Irith Catholic may fight the Battle of his Country unrestrained and unshackled under the Banners of one common God and one common Christianity.

Copy of a Letter from Rear-Admiral Discon, addreffed to Vice-Admiral Sir James Saumarez, Bart and K. B., and transfnitted by the latter to John Wilfon Croker, J.fq.

His Majefty's Ship Vigo, off Romfoc, June 1, 1811.

SIR, THAVE the Pleasure to inform you that Captain Watts, of the Woodlark, captured, on the Night of the 23d Ultimo, after a fmart Chace over the Natter Reef, a very fine Row-Boat, Thirtyfour Feet long, armed with Two Brals Howitzers and fmall Arms, and commanded by a Lieutenant of the Danish Navy, with Twenty Men; One of the Danes was killed and One wounded; a Galliot whofe Cable fhe had cut was refcued by the Guard Boats of the Dictator.


On the Nights of the 31ft Ultimo and 1ft Inftant Two Privateers, armed with Swivels and fmall Arms, and with Twelve Men in each Boat, were captured by the Guard Boats of the Vigo ; the first was boarded fingly by Lieutenant Streatfield in the Pinnace. and makes the feventh Privateer this brave and active Officer has taken and deftroyed; the other was furprifed under the Shore of Romfoe, and taken by Mr. Hodges, Midshipman; Five of the Crew escaped in the Woods.
