WHEREAS the Time limited by the Order of His Royal Highnels the Prince Regent in Council of the Eighth Day of February laft, prohibiting, in the Name and on the Behalf of His Majefty, the transporting into any Parts out of this Kingdom of any Pig Iron, Bar-Iron, Hemp, Pitch, Tar, Rofin, Turpentine, Anchors, Cables, Cordage, Maîts, Yards, Bowsprits, Oars, Oakum, Sheet-Copper, or other Naval Stores, will expire upon the Eighth Day of August will expire upon the Eighth Lay of August next: And whereas it is judged empedient for His Majefly's Service, and the Safety of this King-dom, that the faid Prohibition fhould be con-tinued for fome Time longer, His Yayal High-nefs in the Name and on the Behaif of His Majefly, and by and with the Advice of His Majefly's Privy Council, doth, therefore, hereby order, require, prohibit, and command, that no Perorder, require, prohibit, and command, that no Perfon or Perfons whofoever do at any Time, for the Space of Six Months from the faid Eighth Day of August next, prefume to transport into any Parts out of this Kingdom any Pig-Iron, Bar-Iron, Hemp, Pitch, Tar, Rofin, Turpentine, Anchors, Ca-bles, Cordage, Masts, Yards, Bowsprits, Oars, Oakum, Sheet-Copper, Sail-Cloth or Canvas, or other Naval Stores, or do fnip or lade any Pig-Iron, Bar-Iron, Hemp, Pitch, Tar, Rofin, Turpeu-tine, Anchors, Cables, Cordage, Masta, Yards, Bowtine, Anchors, Cables, Cordage, Mafts, Yards, Eow-fprits, Oars, Oakum, Sheet-Copper, Sail-Cloth er Canvas, or other Naval Stores, on board any Ship or Veffel, in order to transporting the fame into any Parts beyond the Seas, without Leave or Permiffion first being had and obtained from His Majesty or His Privy Council, upon Pain of incurring the Forfeiures inflicted by an Act paüed in the Thirty-third Y-ar of His Majefty's Reign, intituled "An " Act to enable His Majefty to reftrain the Expor-" tation of Naval Stores, and more effectually to prevent the Exportation of Salt-Petre, Arms, and " Ammunition, when prohibited by Fioclamation " or Order in Council:" But it is neverthelefs His

Royal Highnefs's Pleafure, that nothing herein con-tained fhall extend, or be construed to extend, to any of His Majefty's Ships of War, or any other Ships or Veffels or Boats in the Service of His Majefty, or employed or freighted by His Majefty's Board of Ordnance, or by the Commiffioners of His Majefty's Navy; nor to prevent any Ship or Vellel from triking or having on board fuch Quantities of Naval Stores as may be neceffary for the Ufe of fuch Ship or Velfel during the Courfe of her intended Voyage, or by Licence from the Lord High Admiral of Great Bretain, or the Commiflioners of the Admiralty for the Time being ; nor to the Exportation of the faid feveral Articles to Ireland, or to His Majesty's Yards or Garrifons, or to His Majesty's Colonies a...d Plantations in America or the Welt Indies, or to New-foundland, or to His Majefty's Forts and Settlements on the Coalt of Africa, or to the Island of St. Helena, or to the British Settlements or Factories in the East Indies. Provided that upon the Exin the East indies. Frovided that upon the East portation of any of the faid Articles for the Pur-poles of Trade to Ireland, or to His Majelty's Yards and Garrifons, or to His Majelty's Colonies and Plantations in America or the Weit Indies, or to the Island of Newfoundland, or to His Ma-jefty's Forts and Settlements on the Coalt of Africa, or to the Island of St. Helena, or to the British Settlements or Factories in the East ludies, the Exporters of fuch Articles do first make Oath of the true Deflination of the fame to the Places for which they shall be entered outwards, before the Entry of the fame shall be made, and do give full and fufficient Security, by Bond, except as hereinafter excepted,) to the Satisfaction of the Comafflor is of His Majelty's Cultoms, to carry the faid articles to the Places for which they are fo entered outwards, and for the Purpoles spe-cified, and none other; and such Bond thall not be cancelled or delivered up until Phoof be made to the Satisfaction of the faid Commiffioners, by the Production, within a Time to be fixed by the faid Commissioners, and specified in the Bund, ot a Certificate or Certificates, in fuch Form and Manner as fhall be directed by the faid Commif-tioners, flewing that the haid Articles have been all duly landed at the Places for which they were en-tered outwards: But it is His Royal Highnels's Pleafure, nevertheles, that the following Articles,

viz. Bar-Iron, White and Tarred Rope, Tallow or Mill Greafe, Tarpaulins for Waggon-Covers, Pitch, Tar, and Turpentine, shall be permitted to be exported, upon Payment of the proper Duties, without Bond being entered into by the Merchant Exporter, to any of the British Plantations in the West Indies, or to any of His Majesty's Settlements in South America; provided the Merchant Exporter shall first verify, upon Oath, that the Articles fo exported are intended for the Ufe of a particular Plantation or Settlement, to be named in the Entry Outwards, and not for Sale; and that the faid Plantation or Settlement has not before been furnished with any Supply of the faid Articles during the fame Seafon; and provided also that the Exportation of the faid Articles shall, in no Cafe, exceed the Value of Fifty Pounds Sterling for any given Plantation or Settlement, whether by one or more Shipments within the fame Seafon: And the Right Honourable the Lords Commiffioners of His Majefty's Treafury, the Commiffioners for executing the Office of Lord High Admiral of Great Britain, and the Lord Warden of the Cinque Ports, are to give the neceffary Directions herein as to them may refpec-Chetwynd. tively appertain,

WHEREAS the Time limited by the Order of His Royal Highness the Prince Regent Council of the Eighth Day of February 111 laft, for prohibiting the Exportation out of this Kingdom, or carrying Coaltwife, Gunpowder or Salt-Petre, or any Sort of Arms or Ammunition, will expire on the Eighth Day of August next: And whereas it is judged expedient for His Majesty's Service, and the Safety of this Kingdom, that the faid Prohibition should be continued for fome Time longer, His Royal Highness the Prince Regent, in the Name and on the Behalf of His Majefly, and by and with the Advice of His Majefly's Privy Council, doth therefore hereby order, require, prohibit, and command, that no Perfon or Perfons whatfoever, (except the Mafter General of the Ordnance for His Majesty's Service,) do at any Time, during the Space of Six Months, to commence from the Lighth Day of August next, prefume to trans-port into any Parts out of this Kingdom, or carry Coastwile, any Gunpowder or Salt-Petre, or any Sort of Arms or Aminunition, or thip or lade any Gunpowder or Salt-Petre, or any Sort of Arms or Ammunition, on board any Ship or Veffel, in order to transporting the same into any Parts beyond the Seas, or carrying the same Coastwife, without Leave or Permiffion in that Behalf first obtained from His Majefty or His Privy Council, upon' Pain of incur-ring and fuffering the respective Forfeitures and Penalties inflicted by an Act, paffed in the Twenty-ninth Year of His late Majefty's Reign, intituled "An "Act to empower His Majefty to prohibit the "Exportation of Salt-Petre, and to enforce the "Law for empowering His Majefty to prohibit "the Exportation of Gunpowder, or any Sort of

WHEREAS by an Act, paffed in the Forty-eighth Year of His Majefty's Reign, intituled "An Act for further continuing, until Three Months "after the Ratification of a Definitive Treaty of "Peace, an Act, made in the Forty-fourth Year of "His prefent Majefty, for permitting the Importation " into Great Britain of Hides and other Articles in "Foreign Ships," it is enacted, that an Act, made in the Forty-fourth Year of His prefent Majelty, intituled "An Act for permitting, until the Fifth Day " of May, One thousand eight hundred and five, the " Importation of Hides, Calf-Skins, Horns, Tal-" low, and Wool, (except Cotton Wool,) in Foreign " Ships, on Payment of the like Duties, as if imported " in British or Irish Ships;" which, by an Act made in the Forty-fifth Year of His prefent Majesty, was revived and further continued until the Twenty-fifth Day of March One thousand eight hundred and fix, and extended to Goat-Skins imported in Foreign Ships; and which was further continued by an Act made in the Forty-feventh Year of His prefent Ma-jefty, until the Twenty-fifth Day of March, One thousand eight hundred and eight, should be, and the fame was thereby further continued until Three Months after the Ratification of a Definitive Treaty of Peace: And whereas, by the faid Acts, it is lawful for His Majefty, by His Order in Council, from Time to Time, when and as often as it may be judged expedient, to permit any Hides, Pieces of Hides, dreffed or undreffed, Calf-Skins, or Pieces of Calf-Skins, dreffed or undreffed, Horns, or Pieces of Horns, Tallow, and Wool, (except Cotton Wool,) and alfo Goat-Skins, to be im-ported in any Foreign Ship or Veffel, and to be admitted to Entry in any Port or Place in the United Kingdom, on Payment of fuch and the like Duties of Cultoms and Excife as are due and payable on the like Goods when imported in any British or Irish-built Ship or Veffel, any Thing contained in any Act to the contrary notwithstanding : His Royal Highness the Prince Regent, in the Name and on the Behalf of His Majesty, and by and with the Advice of His Majefty's Privy Council, is thereupon pleafed, in purfuance of the Powers vefted in His Majefty by the faid above recited Acts, to allow, and doth hereby allow, for the Space of Six Months from the Eighth Day of Au-gust next, the Importation of Hides, or Pieces of

Hides, dreffed or undreffed, Calf-Skins, or Pieces of Calf-Skins, dreffed or undreffed, Horns, or Pieces of Horns, Tallow, and Wool, (except Cotton Wool,) and also of Goat-Skins, dreffed or undreffed, in any Foreign Ship or Veffel, from any Port from which the British Flag is excluded; and that on the Arrival at any Port of the United Kingdom of any Foreign Ship or Veffel, from any Port from which the British Flag is excluded, with any of the Article above mentioned, the faid Goods shall be admitted to Entry on Payment of the fame Duties of Cuf-toms and Excife as are due and payable on the like Goods when imported in any British or Irish-built Ship or Vessel.—And the Right Honourable the Lords Commissioners of His Majesty's Treasury are to give the neceffary Directions herein accord-Chetwynd. ingly.



A DISPATCH, of which the following is an Extract, has been this Day received at the Office of the Earl of Liverpool, addreffed to His Lordship by Lieutenant-General Viscount Wellington, dated Quinta de Joao, 18th July 1811.

HE Army of Portugal broke up from their Po-THE Army of Longar of the 14th Inftant, and fition on the Guadiana on the 14th Inftant, and have moved towards Truxillo. I have not yet heard that any Troops had paffed that Town towards Almaraz; or that the Cavalry which had been about Talavera and Lobon, had retired further than Merida.

They are fortifying the Old Caftle of Medellin, as well as that at Truxillo.

General Blake embarked his Corps in the Mouth of the Guadiana on the 6th. As foon as General Blake's Corps embarked, the Body of the Enemy's Troops, which had marched towards the Guadiana, and had turned towards Cartaja, retired from the Frontier towards St. Lucar.

I underfland that the Troops belonging to the 4th Corps, which Marshal Soult had brought into Eftramadura, have marched towards Grenada. There is nothing new on the Side of Valladolid, excepting that Jofeph Bonaparte had returned to Spain, and, it is faid, arrived at Burgos with an Efcort of about Three Thousand Men on the 5th Inftant.


