AT the Court at Carlton-House, the 19th Day of July 1811,

PRESENT,

His Royal Highness the PRINCE REGENT in Council.

WHEREAS the Time limited by the Order of His Royal Highness the Prince Regent in Council of the Eighth Day of February last, prohibiting, in the Name and on the Behalf of His Majesty, the transporting into any Parts out of this Kingdom of any Pig Iron, Bar-Iron, Hemp, Pitch, Tar, Rosin, Turpentine, Anchors, Cables, Cordage, Masts, Yarde, Bowsprits, Oars, Oakum, Sheet-Copper, or other Naval Stores, will expire upon the Eighth Day of August will expire upon the Eighth Lay of August next: And whereas it is judged expedient for His Majesty's Service, and the Safety of this Kingdom, that the said Prohibition fhould be continued for some Time longer, His Yould Highness in the Name and on the Behaif of His Majesty, and by and with the Advice of His Majesty's Privy Council, doth, therefore, hereby order, require, prohibit, and command, that no Perforder, require, prohibit, and command, that no Perforder, requires, prohibit, and command, that no Perforder requires. order, require, prohibit, and command, that no Perfon or Persons whosoever do at any Time, for the Space of Six Months from the said Eighth Day of August next, presume to transport into any Parts out of this Kingdom any Pig-Iron, Bar-Iron, Hemp, Pitch, Tar, Rosin, Turpentine, Anchors, Cables, Cordage, Masts, Yards, Bowsprits, Oarvas, Oakum, Sheet-Copper, Sail-Cloth or Canvas, or other Naval Stores, or do ship or lade any Pig-Iron, Bar-Iron, Hemp, Pitch, Tar, Rosin, Turpentine, Anchors, Cables, Cordage, Masts, Yards, Powers, Cables, Cables tine, Anchors, Cables, Cordage, Masts, Yards, Eow-sprits, Oars, Oakum, Sheet-Copper, Sail-Cloth or Canvas, or other Naval Stores, on board any Ship or Vessel, in order to transporting the same into any Parts beyond the Seas, without Leave or Permission first being had and obtained from His Majesty or His Privy Council, upon Pain of incurring the Forfeitures inflicted by an Act passed in the Thirty-third Year of His Majesty's Reign, intituled "An "Act to enable His Majesty to restrain the Expor-" tation of Naval Stores, and more effectually to prevent the Exportation of Salt-Petre, Arms, and "Ammunition, when prohibited by Floclamation or Order in Council:" But it is nevertheless His

Royal Highnes's Pleasure, that nothing herein contained shall extend, or be construed to extend, to any of His Majesty's Ships of War, or any other Ships or Vessels or Boats in the Service of His Majesty, or employed or freighted by His Majesty's Board of Ordnance, or by the Commissioners of His Majesty's Navy; nor to prevent any Ship or Vessel from taking or having on board such Quantities of Naval Stores as may be necessary for the Use of such Ship or Vessel fel during the Course of her intended Voyage, or by Licence from the Lord High Admiral of Great Bretain, or the Commissioners of the Admiralty for the Time being; nor to the Exportation of the faid several Articles to Ireland, or to His Majesty's Yards or Garrisons, or to His Majesty's Colonies and Plantations in America or the West Indies, or to New-foundland, or to His Majesty's Forts and Settlements on the Coast of Africa, or to the Island of St. Helena, or to the British Settlements or Factories in the East Indies. Provided that upon the Exportation of any of the faid Articles for the Purpoles of Trade to Ireland, or to His Majetty's Yards and Garrifons, or to His Majetty's Colonics at. Plantations in America or the West Indies, or to the Island of Newfoundland, or to His Ma-jesty's Forts and Settlements on the Coast of Africa, or to the Island of St. Helena, or to the British Settlements or Factories in the East ladies, the Exporters of fuch Articles do first make Oath of the true Destination of the same to the Places for which they shall be entered outwards, before the Entry of the same shall be made, and do give full and fufficient Security, by Bond, except as heremafter excepted,) to the Satisfaction of the Comifflowers of His Majelty's Customs, to carry the faid carticles to the Places for which they are fo entered outwards, and for the Purpofes specified, and none other; and such Bond thall not be caucelled or delivered up until Proof be made to the Satisfaction of the faid Commissioners, by the Production, within a Time to be fixed by the faid Commissioners, and specified in the Bond, ot a Certificate or Certificates, in such Form and Manner as shall be directed by the said Commissioners, shewing that the said Articles have been sail duly landed at the Places for which they were entered outwards: But it is His Royal Highness's Pleasure, nevertheles, that the following Articles,
