DISPATCH, of which the following is an Extract, has been this Day received at the Earl of Liverpool's Office, addreffed to His Lord+ ship by Governor Farquhar, dated Port Louis, Isle of France, 2d April 1811.

HAVE the Honour to inform Your Lordship, that His Majesty's Ship of War Eclipse, Captain Lynne, returned to this Port on the 5th Ultimo, after having taken possession of the French Port of Tamelavi, at Madagascar, on the 18th February, and landed the Detachments from His Majesty's 22d Regiment and Bourbon Rifle orps, for the Garrison of that Island. The French Commandant accepted, without Opposition, the Terms upon which the Isle of France capitulated. The Result of this Service has freed these Seas from the last French Flag, and secured to us an unmolested Traffic with the fruitful and abundant Island of Madagascar.
