SUPERIOR CLASS OF SHIPWRIGHT APPRENTICES.

BY His Majesty's Order in Council, dated 20th September 1809, a Plan of Education was established at the Royal Naval College at His Majesty's Dock-Yard at Portsmouth for a superior Class of Apprentices to Shipwrights, and Twelve Persons were admitted as Students on the 1st Day of January last;

And it being determined that Six more Students shall be admitted, the Principal Officers and Commissioners of His Majesty's Navy hereby give Notice, that the Examination of Candidates will take place in His Majesty's Dock-Yard at Portsmouth, on the

6th November next, at Eight o'Clock in the Morning; and that such Persons as may be desirous of becoming Candidates for Admission, are required to send Notice of their Intention to the Navy Board, or the Commissioner of the aforesaid Yard, on or before the 1st Day of that Month.

The Candidates must be at least Fifteen, and not more than Seventeen Years of Age.

The Plan of Education may be obtained on Application at the Navy-Office, or at the Office of the Commissioner of any of His Majesty's Dock-Yards; where also Information may be obtained as to the Nature of the Qualifications required of the Candidates, the Documents they are to produce on the Day of Examination, the Salaries they will be allowed on being admitted Students, and of the Offices to which they will be eligible after they have served the Term of Apprenticeship.
