A PROCLAMATION.

GEORGE P. R.

THEREAS the Parliament stands prorogued to Tuesday the Twelfth Day of this instant November, We, in the Name and on the Behalf of His Majesty, and by and with the Ad, vice of His Majesty's Privy Council, do hereby publish and declare, that the said Parliament shall be further prorogued on the said Twelfth Day of this instant November, to Tuesday the Seventh Day of January next; and We have given Order to the Lord High Chancellor of that Part of the United Kingdom of Great Britain and Ireland called Great Britain, to prepare a Commission for proroguing the same accordingly. And We do further hereby, in the Name and on the Behalf of His Majesty, and by and with the Advice aforesaid, publish and declare, that the said Parliament shall, on the said Seventh Day of January next, be held and sit for the Dispatch of divers urgent and important Affairs; and the Lords Spiritual and Temporal, and the Knights, Citizens, and Burgasses, and the Commissioners for Shires and Burghs of the House of Commons, are hereby required and commanded to give their Attendance accordingly, at Westminster, on the said Seventh Day of January next.

bruary last, for the Payment of the Bountics for the Encouragement of Seamen and Landmen to enter into His Majesty's Royal Navy, and the Rewards for discovering Seamen who may conceal themselves, so that such Scamen should be taken for His Majesty's Service, and also the Rewards to Persons who should procure the voluntary Service of Able and Ordinary Seamen and Landmen fit for His Majesty's Naval Service, and should convey such Seamen and Landmen on board any of His Majesty's Ships and Vessels, or to any of His Majesty's Sea Officers employed in raising Men, will expire on the Thirty-first Day of December next, which Bounties and Rewards are as follows; that is to say, To every Able Seaman, not above the Age of Fifty nor under the Age of Twenty Years, who should enter himself to serve in His Majesty's Royal Navy, a Bounty of Five Pounds; and to every Ordinary Seaman so entering himself, and not above the Age of Fifty nor under the Age of Twenty Years, a Bounty of Two Pounds Ten Shillings; to every Able-bodied Landman, not above the Age of Thirty-five nor under the Age of Eighteen Years, so entering himself, a Bounty of Thirty Shillings; to every Person or Persons who shall discover any Able or Ordinary Seaman or Seamen who may have concealed him or themoslves, so that such Seaman or Seamen shall be taken for His Majesty's Service by any of His Majesty's Officers employed to raise Men, a Reward of Three Pounds for every such Able Seaman, and Fifty Shillings for every such Ordinary Seaman fit to serve on board His Majesty's Ships; to any Person or Persons who shall procure the voluntary Service of Able or Ordinary Scamen or Landmen fit for His Majesty's Service, and shall convey them on board any of His Majesty's Slips and Vessels, or to any of His Majesty's Sea Officers employed in raising Men, a Reward of Three Guineas for every such Able Seaman, Two Guineas for every such Ordinary Seaman, and One Guinea for every such Landman, together with an Allowance, at the Rate of Quer Penny per Mile for cach Able Seaman, Ordinary Scaman, and Landman, for every Mile such Men may respectively WHEREAS the Time limited by the Order travel to the nearest of His Majesty's Ships of War, or nearest Place of The limited of His and Council, bearing Date the Eighth Day of Fe-Majesty's Sea Officers employed in raising Men.
