sioners of His Majesty's Treasury of the Time Entry of such Goods, Wares, and Merchandize, of being, or any Three or more of them, shall deem the Duties of Custons or Excise due on the Imbeing, or any Three or more of them, shall deem It expedient that the Provisions of the said Aot should be extended to any Goods, Wares, and Merchandize not enumerated or described in either of the Tables annexed thereto, and should cause a List of such Goods, Wares, and Merchandize to be published in the London Gazette, then and from theneeforth, all and every the Provisions, Re-gulations, and Restrictions of the said Act shall extend to such Goods, Wares, and Merchandize, in every Respect in as full and ample a Manner as if the same had been inserted and enumerated in the said Tables -respectively at the Time of -passing the said Act :
