To His Royal Highness the Prince of Wales, REGENT of the United Kingdom of Great Britain and Ireland.

The humble Address of the Mayor, Recorder, Sheriffs, and Commonalty of the City of Cork, assembled in Court of Doyer Hundred, the 26th day of May 1812.

WE, His Majesty's most dutiful and loyal subjects, the Mayor, Recorder, Sheriffs, and Commonalty of the City of Cork, assembled in Court of Doyer Hundred, beg leave to approach your Royal Highness with the assurance of our unfeigned respect for your Royal Highness's person and government, and to offer to you our sincere condolence on the melancholy event which has deprived your Royal Highness of a faithful, zealous, and enlightened servant, and the country of a virtuous and upright minister.

In the assassination of the Right Honourable Spencer Perceval, we contemplate with the deepest sorrow and the utmost indignation and horror, a crime to which the unoffending excellence of his public and private life could have given no incitement; but we derive some consolation in reflecting, that it was the atrocious act of a solitary and infatuated assassin, unconnected with party, unassisted by accomplices; and when the page of our history shall be sullied by the record of this deed, it will be told, that the tears of an indignant people had obliterated the disgrace from their country, and that its infamy extended not beyond the desperate individual, who, in an evil hour, deprived society of one of its brightest ornaments.

In the opportunity which this calamity has offered to us of addressing your Royal Highness, we

presume to repeat those assurances of unshaken attachment to our venerable and beloved Sovereign, and to your Royal Highness, which we have so recently given to you; and in the sorrow of our hearts, and the solemnity of the occasion, we implore for our country, in this time of unexampled pressure, the protection of that Being who rules the destiny of nations, and we humbly supplicate that, in His gracious providence, he may shield your royal person, direct your councils, strengthen your government, and overcome your enemies.
