WE, His Majesty's most dutiful and loyal subjects, whose names are underwritten, being the greater part of the Heads of Colleges, of the Doctors, Professors and Masters of Arts, resident Members of the Senate of the University of Cambridge, humbly beg leave to express to your Royal Highness our grief and horror at the late melan-choly and afflicting event which, by the most desperate and atrocious act of assassination, within the walls of the House of Parliament, has deprived your Royal Highness and the country of the services of the late Right Honourable Spencer Perceval.

In this expression of our teelings, we are aware how much they are in unison with those of the empire at large : but to us, as members of an University, to whom the promise of so many public and private virtues was given, and whose expectations therein have been so fully gratified, we trust that a more than ordinary concern may be allowed on this awful and melancholy occasion; and that those virtues which, while he lived, were peculiarly the objects of our exultation, may, now that he is no more, be those also of our more affectionate remembrance.

But, independently of all immediate connection with the subject of our regret, we still humbly hope, that in thus expressing our attachment to the memory of an eminently virtuous man, we shall not be considered by your Royal Highness as acting otherwise than in the best conformity to the duties of our situation, connected as it is with the great and important purposes of education, and founded upon the principles of religion and virtue.

WE, the undersigned Noblemen, Gentlemen, ourselves called upon humbly to offer to your Royal | Clergy, Freeholders, and Inhabitants, of the County of Leicester, beg leave humbly to lay before your Royal Highness, our sincere condolence upon the recent atrocious act of murder committed upon the person of the Right Honourable Spencer Perceval, First Lord of the Treasury, and Chancellor of the Exchequer, within the walls of Parliament, and to assure your Royal Highness of our unfeigned participation in those sentiments of grief so feelingly expressed by your Royal Highness, in the public communications to Parliament upon that lamentable occasion.

In reflecting upon this horrid and detestable transaction, we are convinced that it must be viewed by all ranks of His Majesty's subjects with those sentiments of disgust and execration, which it so justly merits, and that our name as a nation will be rescued from the foul stain of any participation in the odious and disgraceful crime of assassination, so foreign to the open and generous feelings of Britons; and we have the melancholy consolation of belief, that this base deed was the act of a desperate but single individual, under the furious and unfounded impulse of resentment for supposed private wrongs. Against such a charge, even were the facts less public, it would be sufficient to record the amiable and unoffending character, the many private virtues, and the unquestioned public integrity, of your Royal Highness's late faithful servant ; but moreover we know that the assassin himself lamented the direction of his wicked and misguided vengeance, which has thus snatched from his family a man endowed with every moral virtue, and from his country a statesman, who by a truly disinterested exercise of eminent talents, and a most conciliatory spirit, has not left to himself one personal enemy, even amongst his political opponents, and whose loss has produced the rare but genuine tribute of unanimous and universal grief.

We beg leave at the same time to assure your Royal Highness, that we most deeply deplore the excesses of late committed in violation of the public peace, in various districts; but trust that the established authorities of the realin, aided by the good sense of the people, will cause these disgraceful scenes to cease from amongst us, and humbly implore the blessings of Providence on your Royal Highness's endeavours to promote 'the public welfare, and further bcg permission to express our humble but firm determination 'to use our most strenuous exertions, whenever necessary, in support of the due execution of the laws, and in the maintenance of public tranquillity.—June 5, 1812.

For this mark of your Royal Highness's gracious and humane sympathy in the feelings of an afflicted

family, we, who have been solong and so infimately connected with Mr. Perceval, and whose loss we now so sincerelydeplore, particularly entreat permission most strongly to express our lively sense of gratitude.

It is satisfactory to us to find, that the guilt of this foul crime was confined solely to the perpetrator of it, and that he was speedily doomed to suffer an ignominious fate, the only atonement to the justice of his insulted country. With these our sentiments, we beg to add the assurance of our zealous and ardent attachment to your Royal Highness's person, to our constitution in church and state, and our sincere participation in your Royal Highness's regret for the loss of an individual, distinguished alike by his integrity, by the firmness of his mind, by his commanding eloquence, and by the bright display of every private virtue.

The Prince Regent and the Knights Companions being seated, Garter acquainted His Royal Highness that Sir Thomas Tyrwhitt attended at the door, and humbly prayed admittance to take the oath of office as Gentleman Usher of the Black Rod of this most noble Order ; who, being in his mantle, was conducted to His Royal Highness by Garter carrying the ensigns of Black Rod's office ; and, kneeling down, the oath was administered to him by the Register. Garter, then, presenting the chain with the badge to His Royal Highness, and afterwards the rod, His Royal Highness was pleased to put the chain about Black Rod's neck, and to deliver to him the rod ; and, having kissed His Royal Highness's hand, he withdrew to his place.

The Chancellor signified to the Chapter His Royal Highness's pleasure, in the name and on the behalf of the Sovereign, that one of the stalls vacant in the Royal Chapel of St. George at Windsor, be filled: and as, by the statutes, none but a Knight can be elected, Francis Earl of Moira was introduced and knighted by His Royal Highness with the sword of state.

The Knights Companions then proceeded to the election; and the suffrages being collected by the Chancellor and presented to the Prince Regent, Francis Earl of Moira was, by the command of His Royal Highness, in the name and on the behalf of the Sovereign, declared duly elected.

His Lordship was thereupon received at the door of the Chapter Room by the two Junior Knights Companions, and conducted between them to the Prince Regent, preceded by Garter (bearing the ensigns of the Order on a crimson velvet cushion) and Black Rod.

Garter presenting the garter to the Prince Regent, His Royal Highness, assisted by the two Senior Knights Companions, buckled it on his Lordship's left leg; the Chancellor pronouncing the admonition.

Garter then presented the ribband with the George to the Prince Regent; and the Earl of Moira kneeling, His Royal Highness, with the assistance of the said two Senior Knights Companions, put the same over his Lordship's shoulder; the Chancellor, in the mean time, pronouncing the admonition: and his Lordship having kissed His Royal Highness's hand, and seluted severally the Knights present, withdrew.

The Chapter ended, Garter called over the Knights; and a procession was made back to His Royal Highness's apartment, in the order as before.

His Royal Highness the Prince Regent, in the name and on the behalf of His Majesty, Sovereign of the Most Noble Order of the Garter, has been pleased, by letters patent under the sign manual of His Royal Highness and the great seal of the Order, to dispense with all the statutes and regulations usually observed in regard to Installation; and to give and grant unto Francis Earl of Moira, Knight Elect of the said Most Noble Order, full power and authority to exercise all rights and privileges belonging to a Knight Companion of the Most Noble Order of the Garter, as if he had been formally installed; any decree, rule, or usage to the contrary notwithstanding.
