they were within musket-shot, the ship was carried, after a desperate struggle, in which the whole of the crew, excepting twenty-three taken, were either killed or compelled to jump overboard; the com-mander of the vessel (a Lieutenant de Vaisseau) was amongst the latter, severely wounded. The Medusa had none killed, and only five wounded.

At daylight the ship was got under weigh, but after proceeding about a league down the harbour, she grounded; and the tide then running out with great violence, she was set fire to, after the wounded had been taken out, and some time after blew up. The Dorade had been watching an opportunity

to escape from Arcasson since the month of April 1811.

Captain Bouverie highly commends the conduct of Lieutenant Thompson and the other officers and men employed on this occasion.
